SGD Fixed Rate First-to-Default Credit-Linked Notes due 2013 (ISIN: SG7M06934347) (the "Tranche B Notes") issued by Pinnacle Performance Limited pursuant to its U.S.\$5,000,000,000 Structured Note Programme (the "Programme")

We refer to our notice to holders of the Pinnacle Series 6 Notes dated 9 July 2010 regarding the Early Redemption Date and the Early Redemption Amount to be payable to holders of the Pinnacle Series 6 Notes as a result of the Mandatory Redemption Event.

As stated in that notice, an amount equal to USD1,113,146.87, which will be converted into SGD at the exchange rate prevailing on or about the Early Redemption Date (as determined by the Determination Agent, acting for and on behalf of the Issuer in its sole and absolute discretion acting in good faith) will be payable to the holders of the Tranche B Notes on a pro rata basis. The Determination Agent determined the USD/SGD exchange rate prevailing on or about the Early Redemption Date to be SGD1.3735 per USD1. Accordingly, an amount equal to SGD1,528,907.23 will be payable to the holders of the Tranche B Notes on a *pro rata* basis, so that the holder of each Tranche B Note will receive approximately SGD137.24 per Tranche B Note. These amounts will be paid to CDP on the Early Redemption Date, which, as stated in our notice to holders of the Pinnacle Series 6 Notes dated 9 July 2010, will occur on 19 July 2010. Holders of Tranche B Notes must look solely to CDP for his share of such payment, subject to and in accordance with the rules and procedures of CDP.

Capitalised terms used but not otherwise defined in this notice or otherwise specified shall have the meanings ascribed thereto in the Pricing Statement relating to the Pinnacle Series 6 Notes dated 16 May 2007 (the "**Pricing Statement**").
