

**SUPPLEMENTAL NOTICE CONCERNING AUCTION RATE SECURITIES**

The District of Columbia has previously issued its \$50,000,000 aggregate principal amount Multimodal Revenue Bonds (American University Issue), Series 2006, Subseries 2006A dated August 16, 2006 (the "Bonds"), and loaned the proceeds of the Bonds to American University (the "University").

Of even date herewith, the University filed a Report of Material Development as a preliminary statement of the University's intent to bid on the Bonds. The purpose of this Supplemental Notice is to supplement that Report of Material Development.

- (a) Attached hereto as Schedule A is certain information with respect to the auction for the Bonds that occurred on April 7, 2008 (the "Previous Auction").
