PRODUCT OVERVIEW

We seek to add value to clients' portfolios by capitalizing on the mis-valuations that arise within and across the world's equity markets. We do this by investing in securities that are undervalued, as identified by our in-house valuation tools and by our research analysts. Our process is dominated by bottom-up stock selection. Our process focuses on identifying the most attractive names in each industry group, seeking to add value by bottom-up stock selection in each sector. Sector deviations are controlled, regional and country deviations reflect bottom-up stock selection decisions.

MANAGER'S INVESTMENT PROCESS

- Fundamental research - is carried out by the 72 career analysts that comprise our global sector teams. Analysts are organized by into global sector teams and operate out of four regional centers: New York, London, Tokyo and Singapore. These teams cover approximately 2,000 companies worldwide, including all those within the MSCI EAFE Value Index, as of March 31, 2016. Each analyst conducts extensive fundamental research into the companies they cover, visiting with management, analyzing financial statements, for example. Based on this research, earnings estimates for each company are generated with an emphasis on forecasting each company's normalized (mid-cycle or sustainable) level of earnings and the rate at which those earnings are expected to grow over the intermediate term. This focus on "normalized" earnings and intermediate growth helps us to (a) help ensure that we value companies based on their sustainable level of earnings rather than on peak or trough earnings, and (b) identify attractively-valued companies sooner than most other firms that focus on just short-term estimates one to two years out.
- Stock Selection - The proprietary estimates generated by our in-house analysts serve as inputs into the Dividend Discount Model ("DDM"), which in turn uses them to synthesize a projected dividend stream for each company. The model then equates the present value of that dividend stream to the current share price in order to calculate each stock's Dividend Discount Rate ("DDR") – a measure of each stock's internal rate of return. The DDR serves as the primary valuation metric for the strategy. The higher a company's DDR, the more attractively-valued the stock.

- Portfolio construction - is the responsibility of the portfolio management team, led by Gerd Woort-Menker. Focusing on the most attractively-valued stocks within each sector (as measured by the DDR rankings), the portfolio managers work closely with the analysts to seek to identify those names which generate strong cash flows, are run by return-focused, shareholder-friendly managements, and possess specific, timely catalysts that will allow the stock to realize its inherent value.





AVERAGE ANNUAL TOTAL RETURN (%) - PERIODS ENDING 12/31/17



This composite consists of all equity portfolios invested in the EAFE region, according to the following rules. The portfolios are managed by the Global Portfolio Group; they are open-ended pooled or segregated funds; they follow a dynamic strategy and are managed against the MSCI EAFE Value (previously EPAC) benchmark. The composite is constructed from discretionary portfolios only. It does not contain any returns that have been carved out of other multi asset class portfolios. The minimum account size is USD 50 million for inclusion in the composite. Performance presented for any period prior to 1st January 1996 is not GIPS® compliant for the following reason - portfolios managed for a short period of time and closed before 1996 may not be included in composites. However, composite returns presented prior to 1996 have been calculated on a consistent basis with those calculated after this date. Currently there are no separately managed accounts in the International Value Managed Account composite. The performance shown is that of the International Value Institutional Composite. The International Value Institutional Composite performance illustrates the management team's record in international value investing. INDEX DESCRIPTIONS

90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of discount is the interest earned. T-bills are issued in denominations of \$10,000 auction and \$1,000 increments thereafter.

MSCI EAFE Net

The MSCI EAFE Index -Europe, Australasia, Far East - is a free float-adjusted market capitalization index that is designed to measure the equity market performance of developed markets, excluding the US and Canada. The MSCI EAFE Index consists of the following 21 developed market country indexes: Australia, Austria, Belgium, Denmark, Finland, France, Germany, Hong Kong, Ireland, Israel, Italy, Japan, the Netherlands, New Zealand, Norway, Portugal, Singapore, Spain, Sweden, Switzerland, and the United Kingdom (as of June 2014). Net total return indices reinvest dividends after the deduction of withholding taxes, using (for international indices) a tax rate applicable to non-resident institutional investors who do not benefit from double taxation treaties.

S&P 500

The S&P 500 Total Return has been widely regarded as the best single gauge of the large cap U.S. equities market since the index was first published in 1957. GLOSSARY OF TERMS

Alpha is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

American Depository Receipts (ADRs) are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

Average Portfolio Beta is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

Beta is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

Bottom-Up Stock Selection Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

Capitalization is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

Dividend a portion of a company's profit paid to common and preferred shareholders.

Downside Risk is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

Duration is a measure of price sensitivity expressed in years.

High Grade Corporate Bonds corporate bonds from issuers with credit ratings of AA or AAA.

Information Ratio is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

Investment Grade Bonds are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

Price/Book Ratio (P/B) weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

Price/Cash Flow Ratio a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company' operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

Price/Earnings Ratio (P/E Ratio) shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

Price/Sales Ratio determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

R2 (R-Squared)/Portfolio Diversification indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

Sharpe Ratio measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

Standard Deviation is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

Top-Down/Economic Analysis Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

Tracking Error represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

U.S. Treasury Bonds a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

Volatility a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
