## PRODUCT OVERVIEW

McDonnell Investment Management, LLC's (McDonnell) intermediate term government fixed income strategy aims to outperform the market benchmark, as measured by the Lehman Brothers Government Bond Index, in a consistent manner where capital preservation is a key objective. To achieve this objective McDonnell limits dependence on forecasting interest rates. Instead, it seeks to control the risk/return profile of the portfolio relative to the benchmark by maintaining a relatively duration neutral posture. The strategy typically invests primarily in U.S. Treasury, U.S. Agency and securities that are guaranteed under the Federal Deposit Insurance Corporation's Temporary Liquidity Guarantee Program and backed by the full faith and credit of the United States. The minimum permissible credit quality rating of individual portfolio holdings is "A" by at least two of the following three rating agencies: Fitch, Moody's and S&P. The average credit quality of a portfolio is typically AA or above. McDonnell may purchase investment securities outside of the benchmark universe provided the securities meet the minimum permissible rating. Maturities of securities may range across the yield curve. McDonnell strives to maintain an average portfolio duration range of 4 to 6 years and targets an average portfolio maturity range of 6 to 10 years.

The portfolio characteristics, portfolio statistics, portfolio weightings, allocation history and top five holdings are based on a representative account managed by the investment manager in the same or a substantially similar investment discipline and/or on information that the manager has provided to Morgan Stanley Smith Barney. The performance data and related analyses are based on the performance of the investment manager's composite described on page 3.

- Sector Emphasis: Allocate the portfolio among the appropriate market sectors based on market research and quantitative relative value analysis
- Security Selection: Identify under- and over-valued securities based on credit research and quantitative relative value analysis
- Maturity Structure: Construct the portfolio to maximize returns based on the current and projected changes in the shape of the yield curve

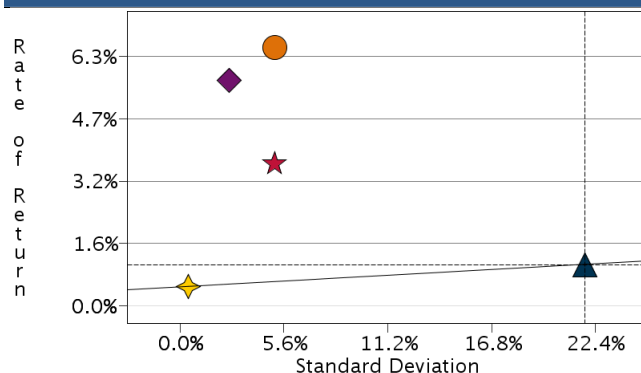

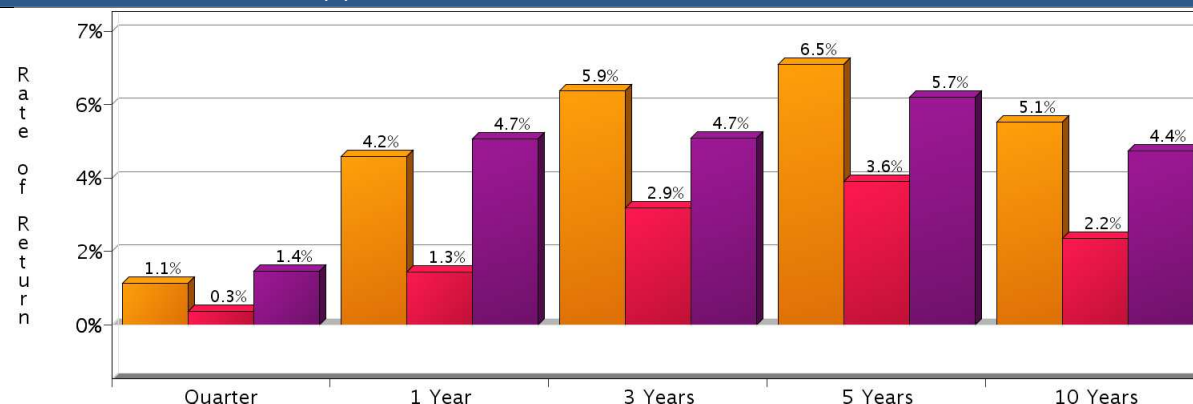

## RISK/RETURN ANALYSIS – 5 YEARS ENDING 09/30/12



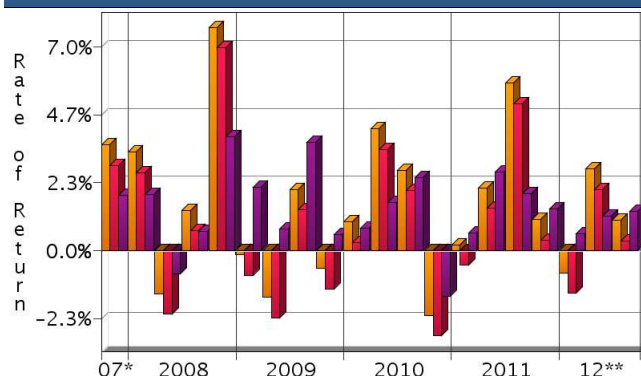

**Sources of Performance Results and Other Data:** The performance data and certain other information for this strategy (including the data on page 1 of this profile) reflect the investment manager's results in managing Morgan Stanley program accounts, or the investment manager's results in managing accounts and investment products, in the same or a substantially similar investment discipline. (For periods through June 2012, the Fiduciary Services program operated through two channels - Morgan Stanley channel and the Smith Barney channel - and any performance and other data relating to Fiduciary Services accounts shown here for these periods is calculated using accounts in only one of these channels.) This information for the investment manager is presented solely to provide information about accounts that were managed according to investment objectives and strategies the same or substantially similar to the corresponding investment discipline in the Select UMA program. #### Related Performance:

McDonnell Investment Management, LLC's ("McDonnell") intermediate term fixed income performance prior to 1/1/2005 represents a composite of all fully discretionary, fee-paying institutional accounts greater than \$5 million managed in an all government fixed-income style. The composite is size-weighted and consisted of 5 accounts with a market value of \$69.0 million as of 12/31/2004. From 1/1/2005 to 6/30/2007, the performance represents a composite of all fully discretionary, fee-paying institutional and retail accounts greater than \$5 million managed in an all government fixed-income style. The composite is size-weighted and consists of 4 accounts totaling \$81.0 million as of 6/30/2007.

#### Select UMA Performance:

In this profile, the performance from 7/1/2007 through June 2012 consists of accounts in either the Morgan Stanley or the Smith Barney form of the Fiduciary Services program. From July 2012, performance consists of all Fiduciary Services accounts managed by the investment manager in the strategy, subject to any other limitations stated in this profile. Performance composites calculated by Morgan Stanley include all fee-paying portfolios with no investment restrictions. New accounts are included upon the first full quarter of performance. Terminated accounts are removed in the quarter in which they terminate. Performance is calculated on a total return basis and by asset weighting the individual portfolio returns using the beginning of period values.

**Gross Performance:** McDonnell's gross results do not reflect a deduction of any investment advisory fees or program fees, charged by McDonnell or Morgan Stanley, but are net of commissions charged on securities transactions.

**Net Performance for all Periods:** Net performance results reflect a deduction of 0.705% quarterly. This consists of three components: 0.625% maximum quarterly MS Advisory Fee and 0.03% maximum quarterly Program Overlay Fee (which, together cover the services provided by Morgan Stanley), plus 0.05% quarterly SMA Manager Fees (being the fee currently charged by McDonnell to new clients for managing their assets in the Select UMA program). The SMA Manager Fees may differ from manager to manager, and managers may change their fee to new clients from time to

## INDEX DESCRIPTIONS

**90-Day T-Bills**

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of 'discount' is the interest earned. T-bills are issued in denominations of \$10,000 (auction) and \$1,000 increments thereafter.

**BC Muni 5 Yr**

The Barclays Capital 5 Year Municipal Bond Index is composed of securities from the Barclays Municipal Bond Index with maturities between four and six years.

**S&P 500**

The S&P 500 has been widely regarded as the best single gauge of the large cap U.S. equities market since the index was first published in 1957. The index has over US\$ 5.58 trillion benchmarked, with index assets comprising approximately US\$ 1.31 trillion of this total. The index includes 500 leading companies in leading industries of the U.S. economy, capturing 75% coverage of U.S. equities. This index includes dividend reinvestment.

## GLOSSARY OF TERMS

**Alpha** is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

**American Depositary Receipts (ADRs)** are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

**Average Portfolio Beta** is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Capitalization** is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

**Downside Risk** is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

**Duration** is a measure of price sensitivity expressed in years.

**Information Ratio** is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

**Investment Grade Bonds** are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

**Price/Earnings Ratio (P/E Ratio)** shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

**R<sup>2</sup> (R-Squared)/Portfolio Diversification** indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

**Sharpe Ratio** measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

**Standard Deviation** is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

**Tracking Error** represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.
