PRODUCT OVERVIEW

The objective of HOLT Global Sustainable Dividend is to offer current income and income growth, as well as capital appreciation with less risk than the broader equity market. The strategy focuses on high quality, blue chip companies with deep defensive moats, sustainable cash flows and attractive valuations. The strategy is designed for asymmetric upside/downside capture and historically has realized 70% of down market returns and 90% of upmarket returns. By focusing on sustainable dividends as opposed to high dividends, the strategy seeks to be an appropriate investment solution regardless of whether dividend investing is in or out of favor. The Capital Discipline investment team combines systematic and fundamental elements in their investment process for a disciplined and differentiated approach to dividend investing. The team leverages the HOLT framework as the backbone of its research process; the HOLT model is a value based, return on capital framework proprietary to Credit Suisse used for comparing and valuing companies. HOLT converts reported income statement and balance sheet information into a cash based measure of performance more closely approximating the underlying economics of the business. The model also adjusts for accounting rules, inflation rates and company risk profiles to provide a Standardized platform for company analysis.

MANAGER'S INVESTMENT PROCESS

- The Strategy's initial universe consists of the 20,000 companies in the HOLT database, screened to include those in the MSCI All Country World Index. The investment process evaluates the investible universe and measures each company on quality, competitive advantage, cash flow sustainability, dividend yield / growth and valuation.
- The covering analysts are then responsible for reviewing the companies from a fundamental perspective. Due diligence is performed leveraging sources such as company financial filings, street research, HOLT sector specialist commentary, company investor presentations, and quarterly conference call transcripts. The goal of the fundamental review is to confirm that the criteria match with the fundamentals of the company.
- All of the companies in the portfolio and investable universe are scored monthly. For any stocks in the portfolio which no longer meet the inclusion requirements, due diligence is conducted to either confirm that the systematic signal is correct or if it is missing a turnaround.
- The Team uses a portfolio optimization process to maximize dividend yield and minimize risk. Absolute thresholds are utilized for sector, country, and position limits.
- After the portfolio optimization is complete, the Team does a final review to approve trades and weights.



AVERAGE ANNUAL TOTAL RETURN (%) - PERIODS ENDING 09/30/16



The HOLT Global Sustainable Dividend Composite includes all fully discretionary portfolios that are managed to the HOLT Global Sustainable Dividend Strategy. The objective of the strategy is to seek current income, income growth, and capital appreciation by investing in U.S. and foreign stocks. Historically, exposure to foreign securities was primarily obtained through liquid American Depository Receipts (ADRs). Beginning January 2015, accounts in the composite may gain exposure to non-U.S. markets through either ADRs or through direct investment in foreign stocks. The strategy focuses on high quality, blue chip companies with deep defensive moats, sustainable cash flows, and attractive valuations, without geographic constraints. These cash flow rich companies have excess capital to return

to shareholders and are largely focused on wealth distribution. The Global Sustainable Dividend Strategy leverages the Sustainable Dividend methodology powered by HOLT, an innovative stock selection method that offers a consistent, structured, and repeatable investment process. Portfolios must be materially invested to the model and hold a minimal amount of cash and other non-model assets prior to

initial inclusion in the composite. Portfolios included in the composite are not necessarily 100% invested to the model for all time periods. The composite creation date is December 2014.

INDEX DESCRIPTIONS

90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of discount is the interest earned. T-bills are issued in denominations of \$10,000 auction and \$1,000 increments thereafter.

MSCI AC Wld Nt

The MSCI ACWI Index is a free float-adjusted market capitalization weighted index that is designed to measure the equity market performance of developed and emerging markets. The MSCI ACWI consists of 46 country indexes comprising 23 developed and 23 emerging market country indexes. The developed market country indexes included are: Australia, Austria, Belgium, Canada, Denmark, Finland, France, Germany, Hong Kong, Ireland, Israel, Italy, Japan, Netherlands, New Zealand, Norway, Portugal, Singapore, Spain, Sweden, Switzerland, the United Kingdom and the United States. GLOSSARY OF TERMS

Alpha is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

American Depository Receipts (ADRs) are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

Average Portfolio Beta is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

Beta is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

Bottom-Up Stock Selection Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

Capitalization is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

Dividend a portion of a company's profit paid to common and preferred shareholders.

Downside Risk is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

Duration is a measure of price sensitivity expressed in years.

High Grade Corporate Bonds corporate bonds from issuers with credit ratings of AA or AAA.

Information Ratio is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

Investment Grade Bonds are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

Price/Book Ratio (P/B) weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

Price/Cash Flow Ratio a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company's operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

Price/Earnings Ratio (P/E Ratio) shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

Price/Sales Ratio determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

R2 (R-Squared)/Portfolio Diversification indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

Sharpe Ratio measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

Standard Deviation is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

Top-Down/Economic Analysis Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

Tracking Error represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

U.S. Treasury Bonds a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

Volatility a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
