PRODUCT OVERVIEW

Ashfield Capital Partners, LLC's Balanced Large Cap Growth portfolio seek a combination of growth and income by investing in what Ashfield believes are both high quality stocks and bonds or bond ETFs (Exchange Traded Funds). Over time, the asset allocation is expected to average 70% equities and 30% bonds. Risk is managed through the initial asset allocation and by careful selection of the underlying securities, not by market timing. Bonds or bond ETFs (Exchange Traded Funds) are designed to provide stable cash flow while controlling overall volatility. Stocks will provide for long-term capital growth potential. While Ashfield's investment process seeks to maintain sector weightings similar to the S&P 500 Index, portfolios will, at times, be slightly over/underweighted in particular sectors/industries versus the index. The fixed income portfolio consists of U.S. and foreign securities, which may include ETFs and Closed-End Funds.



FIXED INCOME SECTOR DISTRIBUTION(%) ⁺



RISK/RETURN ANALYSIS – 5 YEARS ENDING 03/31/13




AVERAGE ANNUAL TOTAL RETURN (%) – PERIODS ENDING 03/31/13
