PRODUCT OVERVIEW

Eagle Global Advisors, LLC ("Eagle Global")/ Eaton Vance Management international core equity investment strategy offers an international equity portfolio consisting of foreign investment in the form of American Depositary Receipts (ADRs), exchange-traded funds (ETFs) and closed-end country funds traded in U.S. markets. Eagle Global's investment philosophy is to invest in international large-cap companies that it believes are high quality, industry leading, growth-oriented companies with the potential to provide investors with attractive long term, risk-adjusted returns. Eagle Global follows the tenet that a disciplined, consistent and repeatable approach is the key to successful investing. Eagle Global applies a disciplined top-down analysis to create a geographic portfolio allocation, followed by a strong bottom-up stock selection process. Eagle Global's process seeks to invest in international large-cap growth companies that have generated consistent earnings, cash flows and returns on equity as well as companies with strong management teams that seek to reward patient investors with above average market returns while limiting risk over the long term. Eagle Global's investment process may, at times, result in portfolios that will be over/underweighted in particular countries/sectors/industries versus the MSCI EAFE Index. Eagle Global offers this strategy in conjunction with Eaton Vance Management, which provides administrative services in respect of the strategy.

MANAGER'S INVESTMENT PROCESS

- Eagle Global utilizes quantitative models for its geographic allocation and its economic sector allocation
- Eagle Global utilizes a proprietary multi-factor security ranking model with valuation, growth, earnings momentum and relative price strength factors
- Eagle Global's multi-factor model seeks to identify companies that they believe are attractively valued with positive trends
- Eagle Global completes a detailed fundamental review to assess a company's competitive strength, management strategy, quality of earnings and cash flow
- Eagle Global will sell a security if there is deterioration of a company's qualitative or quantitative fundamentals, when top-down analysis leads to a reduction in country or sector exposure, or if a stock with greater upside potential is identified

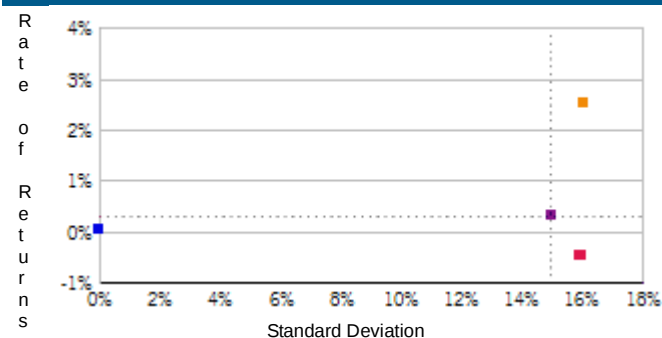

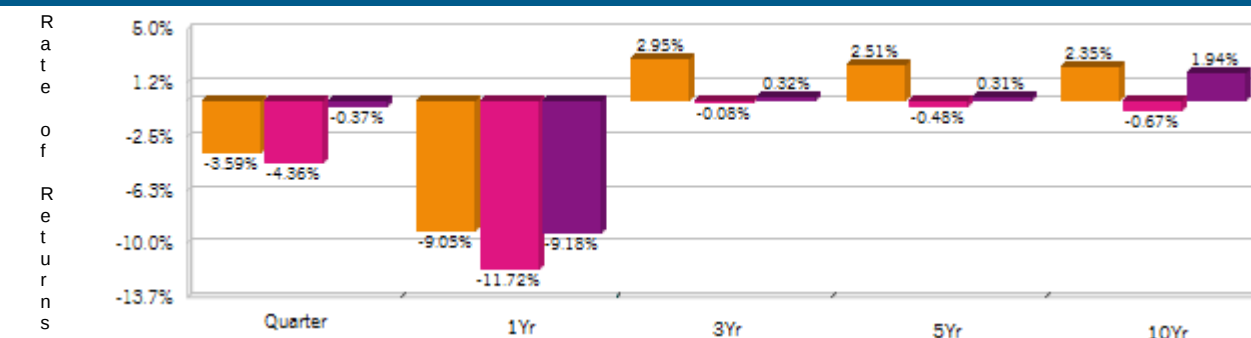

RISK/RETURN ANALYSIS - 5 YEARS ENDING 03/31/16



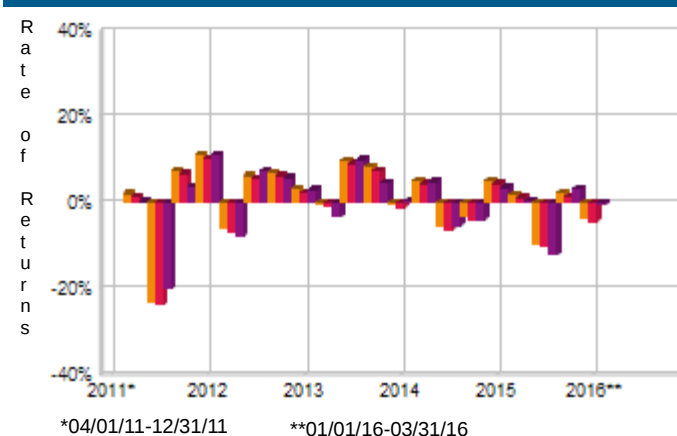

Eagle Global Advisors, LLC's international core equity performance prior to 1/1/1997 was achieved when the investment staff of Eagle Global was employed by another firm, Eagle Management & Trust. The composite only includes accounts that were transferred and does not include accounts where there was a break in service that lasted more than one month. The composite was size-weighted and consisted of 2 accounts with a market value of \$1.86 million as of 12/31/1996. From 12/31/1996 to 12/31/2006, the performance represents a composite of all fully discretionary, fee-paying single asset class international ADR large capitalization growth equity portfolios and includes the international ADR equity portion of balanced accounts. The composite was size-weighted and included approximately 285 accounts totaling \$470.4 million as of 12/31/2006.

Fiduciary Services Performance:

In this profile, the performance from 1/1/2011 through June 2012 consists of accounts in either the Morgan Stanley or the Smith Barney form of the Fiduciary Services program. From July 2012, performance consists of all Fiduciary Services accounts managed by the investment manager in the strategy, subject to any other limitations stated in this profile. INDEX DESCRIPTIONS

90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of discount is the interest earned. T-bills are issued in denominations of \$10,000 auction and \$1,000 increments thereafter.

MSCI AC Wld xUS Nt

The MSCI ACWI Index is a free float-adjusted market capitalization weighted index that is designed to measure the equity market performance of developed and emerging markets. The MSCI ACWI consists of 46 country indexes comprising 23 developed and 23 emerging market country indexes. The developed market country indexes included are: Australia, Austria, Belgium, Canada, Denmark, Finland, France, Germany, Hong Kong, Ireland, Israel, Italy, Japan, Netherlands, New Zealand, Norway, Portugal, Singapore, Spain, Sweden, Switzerland, the United Kingdom and the United States. The emerging market country indexes included are: Brazil, Chile, China, Colombia, Czech Republic, Egypt, Greece, Hungary, India, Indonesia, Korea, Malaysia, Mexico, Peru, Philippines, Poland, Qatar, Russia, South Africa, Taiwan, Thailand, Turkey, and United Arab Emirates (as of June 2014). GLOSSARY OF TERMS

Alpha is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

American Depositary Receipts (ADRs) are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

Average Portfolio Beta is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

Beta is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

Bottom-Up Stock Selection Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

Capitalization is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

Dividend a portion of a company's profit paid to common and preferred shareholders.

Downside Risk is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

Duration is a measure of price sensitivity expressed in years.

High Grade Corporate Bonds corporate bonds from issuers with credit ratings of AA or AAA.

Information Ratio is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

Investment Grade Bonds are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

Price/Book Ratio (P/B) weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

Price/Cash Flow Ratio a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company's operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

Price/Earnings Ratio (P/E Ratio) shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

Price/Sales Ratio determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

R² (R-Squared)/Portfolio Diversification indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

Sharpe Ratio measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

Standard Deviation is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

Top-Down/Economic Analysis Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

Tracking Error represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

U.S. Treasury Bonds a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

Volatility a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
