PRODUCT OVERVIEW

Fox Asset Management's (Fox) multi cap value equity (NGC Dividend Yield) strategy employs a value-oriented philosophy. William E. Dodge founded and operated Nine Gates Capital (NGC) from 2003 to 2005 and during his tenure, Mr. Dodge created the dividend yield strategy. Fox attempts through rigorous fundamental equity analysis and other bottom-up methodologies to identify what Fox believe to be the best companies which trade at a 20% discount or more to the overall market in their respective industries. The investment objective of the strategy is to produce above core market S&P 500 results and to hold high dividend yielding large capitalization equities in a concentrated portfolio of 25-35 stocks. Fox's process may, at times, result in portfolios that will be over/underweighted in particular sectors/industries versus the S&P 500 Index.

RISK CONSIDERATIONS

MANAGER'S INVESTMENT PROCESS

- Fox screens the 1,000 largest capitalization stocks in various categories: yield, P/E, P/CF, P/B, profit margins, debt/capital, etc. The main focus is yield with particular attention to the 2nd quintile of stocks which based on Fox's research, has historically provided the highest excess returns
- Fundamental research process begins reviewing quantitative characteristics of the companies that meet the screening criteria. Favorable qualitative characteristics are taken into consideration such as leading/dominant products, growing markets, strong financials, and focused managements
- The Portfolio Construction Team incorporates the outputs of quantitative and fundamental research and constructs a portfolio of 25-35 names
- Stocks are sold if the dividend is in jeopardy, based on valuation, fundamental deterioration, rebalancing or a more attractive alternative
- Discussions with management are an important part of the investment process






AVERAGE ANNUAL TOTAL RETURN (%) – PERIODS ENDING 09/30/11

Fox Asset Management's (Fox) multi cap value equity (NGC dividend yield) performance prior to 3/1/2005 was achieved by William E. Dodge at Nine Gates Capital (NGC). Mr. Dodge was primarily responsible for the performance results achieved at the predecessor firm shown herein. The performance represents a composite of all fully discretionary fee-paying institutional multi cap value equity accounts managed by Fox at inception on 2/1/2006. The minimum account size for this strategy is \$2 million.

Fiduciary Services Performance:

Equity Account (Gross): Fox's gross results do not reflect a deduction of the investment advisory fees charged by Fox, or program fees, if any, but are net of commissions charged on securities transactions.

Net Performance for all Periods: To demonstrate the effect of Morgan Stanley Smith Barney's fees that would have applied if you had invested in the investment manager strategy's through the Fiduciary Services program, the net results for all periods are calculated by deducting a quarterly fee of 0.75% (equivalent to an annual fee of 3%).

Morgan Stanley Smith Barney program fees are usually deducted quarterly, and have a compounding effect on performance. Focus List, Approved List, and Watch Status:

Consulting Group Investment Advisor Research ("CG IAR") uses two methods to evaluate investment products in applicable advisory programs. INDEX DESCRIPTIONS

90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of 'discount' is the interest earned. T-bills are issued in denominations of \$10,000 (auction) and \$1,000 increments thereafter.

Russell 1000 Value Index

The Russell 1000 Value Index is representative of the U.S. market for large capitalization stocks containing those companies in the Russell 1000 Index with lower price-to-book ratios and lower forecasted growth.

S&P 500 Index

Widely regarded as the best single gauge of the U.S. equities market, this world-renowned index includes a representative sample of 500 leading companies in leading industries of the U.S. economy. Although the S&P 500 focuses on the large-cap segment of the market, with over 80% coverage of U.S. equities, it is also an ideal proxy for the total market.

GLOSSARY OF TERMS

Alpha is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

American Depository Receipts (ADRs) are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

Average Portfolio Beta is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

Capitalization is defined as the following: Mega (\$50.0 billion and Above), Large (\$11.0 - \$50.0 billion), Medium (\$2 - \$11.0 billion), Small (\$500m - \$2 billion) and Micro (below \$500 million).

Downside Risk is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

Duration is a measure of price sensitivity expressed in years.

Information Ratio is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

Investment Grade Bonds are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

Price/Earnings Ratio (P/E Ratio) shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

R² (R-Squared)/Portfolio Diversification indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

Sharpe Ratio measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

Standard Deviation is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

Tracking Error represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.
