## PRODUCT OVERVIEW

The Lazard Emerging Markets Core Equity Select ADR strategy seeks to achieve attractive risk-adjusted relative returns through a full market cycle by investing in companies whose valuations are being mis-priced by the market, based on the team's assessment of fair value. The strategy typically invests in 35-55 non-Rule 144A ADR securities, of sufficient liquidity and generally with a market capitalization of approximately \$300 million or greater, that are located, or that do significant business, in emerging-market countries. Companies that derive more than 50% of their net assets or sales from Emerging Markets are also included in the initial universe.

## MANAGER'S INVESTMENT PROCESS

- Screening/Idea Generation - The investment universe consists of approximately 2,500 securities of companies. The team utilizes proprietary screens to help narrow the Emerging Markets Equity universe based on valuation, quality, revisions, market validation and the trajectory of fundamental metrics. This step yields a target universe of about 300 to 400 stocks that qualify for further fundamental analysis.
- Core Company Model - A proprietary model which generates the following: 1) Returns Analysis, which leads to the identification of the appropriate forward-looking valuation metric for each stock in our target universe. 2) Identification of Appropriate Valuation Technique to determine the key drivers of returns (e.g. ROE, RoIC) and earnings/cash flows based on historical and prospective fundamental and valuation data.
- Fundamental analysis: 1) Modeling & Accounting Validation; 2) Valuation & Recommendation. Detailed financial modeling is performed with emphasis on the specific metric(s) which will ultimately determine fair value. The final step is to assign both base case and bear case price targets for all portfolio holdings.
- Portfolio Construction/Buy/Sell Disciplines - Securities are added or removed from the portfolio based on expected upside to target prices, the security's asymmetry score, and portfolio management. Buy criteria: 1) Absolute upside to Target Price; 2) Attractive Asymmetric Risk Score; 3) Improving Company Fundamentals; 4) Quality of management ; 5) Competitive Advantage; 6) Difference from consensus. Sell criteria: 1) Target Price achieved; 2) Unattractive Asymmetric Risk Score; 3) Investment thesis invalidated; 4) Negative change in corporate strategy or governance.
- Risk Management - Idiosyncratic and systematic risk is monitored at all stages of the portfolio construction process as well as by the independent risk management utilizing proprietary risk models to deconstruct risk at the portfolio level and at the region, country and sector level.

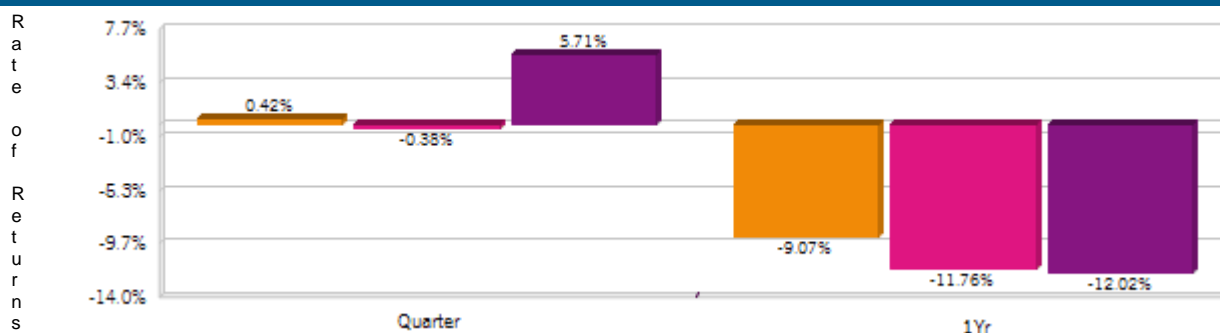

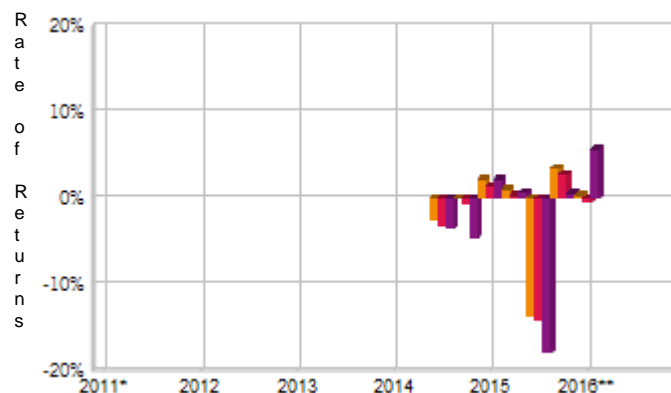

The strategy typically invests in non-Rule 144A ADR securities of companies domiciled in countries included in the MSCI Emerging Markets Index which are of sufficient liquidity and companies not domiciled in the emerging markets but that derive more than 50% of their net assets and/or sales from emerging-market countries.

**INDEX DESCRIPTIONS****90-Day T-Bills**

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of discount is the interest earned. T-bills are issued in denominations of \$10,000 auction and \$1,000 increments thereafter.

**MSCI EM Net**

The MSCI Emerging Markets Index is a free float-adjusted market capitalization index that is designed to measure equity market performance of emerging markets. The MSCI Emerging Markets Index consists of the following 23 emerging market country indexes: Brazil, Chile, China, Colombia, Czech Republic, Egypt, Greece, Hungary, India, Indonesia, Korea, Malaysia, Mexico, Peru, Philippines, Poland, Qatar, Russia, South Africa, Taiwan, Thailand, Turkey, and United Arab Emirates (as of June 2014). **GLOSSARY OF TERMS**

**Alpha** is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.



**American Depositary Receipts (ADRs)** are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

**Average Portfolio Beta** is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Beta** is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Bottom-Up Stock Selection** Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

**Capitalization** is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

**Dividend** a portion of a company's profit paid to common and preferred shareholders.

**Downside Risk** is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

**Duration** is a measure of price sensitivity expressed in years.

**High Grade Corporate Bonds** corporate bonds from issuers with credit ratings of AA or AAA.

**Information Ratio** is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

**Investment Grade Bonds** are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

**Price/Book Ratio (P/B)** weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

**Price/Cash Flow Ratio** a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company's operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

**Price/Earnings Ratio (P/E Ratio)** shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

**Price/Sales Ratio** determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

**R2 (R-Squared)/Portfolio Diversification** indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

**Sharpe Ratio** measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

**Standard Deviation** is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

**Top-Down/Economic Analysis** Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

**Tracking Error** represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

**U.S. Treasury Bonds** a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

**Volatility** a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
