PRODUCT OVERVIEW

MDT employs a quantitative investment process that is expected to allocate assets across the small capitalization spectrum and stylistically between growth and value. Called the Optimum Q process, the model construction is based on the creation of a decision tree algorithm, CART (Classification and Regression Tree). The universe is grouped into 24 clusters in which it uses six stock selection variables: earnings estimate momentum, share buyback/issuance activity, long-term growth rate, earnings to price, tangible book to price and earnings risk. In the portfolio construction process, MDT wants to build a portfolio of the highest ranked securities possible while adhering to its risk control guidelines. These guidelines dictate the maximum exposure to an individual security, business, industry, or economic sector.

MANAGER'S INVESTMENT PROCESS

- Models are quantitatively based using advanced algorithms and proprietary software
- The investment process consists of three primary elements: portfolio selection, trading and model construction
- Portfolio selection and trading occur on a daily basis, while model construction occurs less frequently, approximately once every twenty-four to thirty-six months
- MDT seeks to control risk by utilizing diversification constraints
- Trading costs are built into the model to account for potential round-trip cost





RISK/RETURN ANALYSIS – 5 YEARS ENDING 03/31/13





The performance composite calculated by Federated MDT Advisers, one of the Federated Advisory Companies (MDT), includes all actual, fully discretionary, fee-paying institutional Small Cap Core accounts managed by MDT in accordance with its Small Cap Core strategy. The performance results presented herein for the Small Cap Core composite were calculated in U.S. dollars on a time-weighted and asset-weighted, total-return basis, including the reinvestment of all dividends, interest and other income. Securities transactions are accounted for on the trade date. MDT's gross composite performance is presented before the deduction of investment advisory fees and after the deduction of transaction costs.

Fiduciary Services Performance:

In this profile, the performance from 10/1/2006 through June 2012 consists of accounts in either the Morgan Stanley or the Smith Barney form of the Fiduciary Services program. From July 2012, performance consists of all Fiduciary Services accounts managed by the investment manager in the strategy, subject to any other limitations stated in this profile. Performance composites calculated by Morgan Stanley include all fee-paying portfolios with no investment restrictions. New accounts are included upon the first full quarter of performance. Terminated accounts are removed in the quarter in which they terminate. INDEX DESCRIPTIONS

90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of 'discount' is the interest earned. T-bills are issued in denominations of \$10,000 (auction) and \$1,000 increments thereafter.

Russell 2000

The Russell 2000 Index consists of the 2,000 smallest companies in the Russell 3000 Index, which generally has represented approximately 10% of the total market capitalization of the Russell 3000 Index.

S&P 500

The S&P 500 has been widely regarded as the best single gauge of the large cap U.S. equities market since the index was first published in 1957. The index has over US\$ 5.58 trillion benchmarked, with index assets comprising approximately US\$ 1.31 trillion of this total. The index includes 500 leading companies in leading industries of the U.S. economy, capturing 75% coverage of U.S. equities. This index includes dividend reinvestment.

GLOSSARY OF TERMS

Alpha is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

American Depository Receipts (ADRs) are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

Average Portfolio Beta is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

Capitalization is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

Downside Risk is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

Duration is a measure of price sensitivity expressed in years.

Information Ratio is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.
