PRODUCT OVERVIEW

The Newton Capital Management (Newton) global core equity strategy offers a global equity portfolio consisting of assets in the form of U.S. stocks, American Depository Receipts (ADRs) and foreign stocks. The investment strategy combines a bottom-up stock selection process with a global thematic framework, beginning with the development of key investment themes. MBSC Securities Corporation's Dreyfus Investment Division ("Dreyfus") manages accounts invested in the strategy using a model portfolio developed by the subadvisor Newton as a result of Newton's investment research process. (Both Dreyfus and Newton are subsidiaries of Bank of New York Mellon Corporation). With Newton's entire investment team sitting in one open-plan office in London, the investment process is designed to capture all the best ideas within the house and deliver them effectively and consistently into the model portfolio. Once Newton gives its investment recommendations to Dreyfus in the form of the model portfolio, Dreyfus makes the investment decisions with respect to securities for each account (although it anticipates that, in the normal course, it will follow Newton's recommendations). Investments in emerging markets may range from 0 to 20% of the portfolio. The investment process may, at times, result in portfolios that will be actively over or underweighted in particular sectors, countries or regions versus the MSCI World Net Index.





RISK/RETURN ANALYSIS - 5 YEARS ENDING 06/30/16




AVERAGE ANNUAL TOTAL RETURN (%) - PERIODS ENDING 06/30/16

Newton Capital Management's ("Newton") global core equity performance prior to 1/1/2011 represents a composite of all fully discretionary, fee-paying institutional equity accounts that invest in global equities including emerging markets, which may include stocks that do not form part of the benchmark and for comparison purposes is measured against the MSCI World Net Index. These accounts are managed either by Newton or by an affiliate in the Newton group of companies (which, in addition to Newton, includes Newton Investment Management Limited, Newton International Investment Management Limited and Newton Fund Managers (CI) Limited). Returns include the effect of foreign currency exchange rates. The U.S. Dollar is the currency used to express performance. The composite was size-weighted and consists of approximately 5 accounts totaling \$677.9 million as of 9/30/2007. The Newton Group Strategy Assets Under Management on page one of this profile are those of the Newton group.

In the Fiduciary Services program, Newton holds different types of securities, and a different number of securities, from its institutional strategy. In Fiduciary Services, Newton holds ADRs and F-shares. F-shares are ordinary shares traded in local markets but priced in U.S. dollars and customarily are listed on the U.S. OTC market with the "F" as the final letter in a five-letter ticker symbol. The U.S. dollar quoted F-shares provide access to some of the foreign companies that do not currently have ADRs available to individual investors. Newton's institutional strategy consists of ADRs and ordinary shares, with no F-shares.

Fiduciary Services Performance:

In this profile, the performance from 1/1/2011 through June 2012 consists of accounts in either the Morgan Stanley or the Smith Barney form of the Fiduciary Services program. From July 2012, performance consists of all Fiduciary Services accounts managed by the investment manager in the strategy, subject to any other limitations stated in this profile. Performance composites calculated by Morgan Stanley include all fee-paying portfolios with no investment restrictions. New accounts are included upon the first full quarter of performance. Terminated accounts are removed in the quarter in which they terminate. INDEX DESCRIPTIONS

90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of discount is the interest earned. T-bills are issued in denominations of \$10,000 auction and \$1,000 increments thereafter.

MSCI AC WI d Nt

The MSCI ACWI Index is a free float-adjusted market capitalization weighted index that is designed to measure the equity market performance of developed and emerging markets. The MSCI ACWI consists of 46 country indexes comprising 23 developed and 23 emerging market country indexes. The developed market country indexes included are: Australia, Austria, Belgium, Canada, Denmark, Finland, France, Germany, Hong Kong, Ireland, Israel, Italy, Japan, Netherlands, New Zealand, Norway, Portugal, Singapore, Spain, Sweden, Switzerland, the United Kingdom and the United States. GLOSSARY OF TERMS

Alpha is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

American Depository Receipts (ADRs) are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

Average Portfolio Beta is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

Beta is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

Bottom-Up Stock Selection Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

Capitalization is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

Dividend a portion of a company's profit paid to common and preferred shareholders.

Downside Risk is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

Duration is a measure of price sensitivity expressed in years.

High Grade Corporate Bonds corporate bonds from issuers with credit ratings of AA or AAA.

Information Ratio is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

Investment Grade Bonds are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

Price/Book Ratio (P/B) weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

Price/Cash Flow Ratio a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company's operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

Price/Earnings Ratio (P/E Ratio) shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

Price/Sales Ratio determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

R2 (R-Squared)/Portfolio Diversification indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

Sharpe Ratio measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

Standard Deviation is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

Top-Down/Economic Analysis Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

Tracking Error represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

U.S. Treasury Bonds a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

Volatility a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
