## PRODUCT OVERVIEW

Allianz Global Investors U.S. LLC/NFJ Investment Group L.P. ("Allianz/NFJ") is a disciplined, value-oriented equity manager specializing in a diversified, low price-to-earnings approach with an emphasis on dividends. Allianz/NFJ selects stocks on a bottom-up basis by employing a process that begins with screening the largest 1,000 stocks by market capitalizations for positive fundamental characteristics. Based on forward twelve months earnings, stocks are then ranked by P/E and dividend yield within their industry peer group. Those exhibiting attractive relative valuations within each industry are then evaluated based on P/E, P/B, dividend yield and price momentum. The resulting portfolio typically hold between 40 and 60 dividend-paying stocks across 40 to 50 industries and consistently has an overall P/E significantly lower than the market. Allianz Global Investors U.S. LLC ("Allianz") manages the NFJ Large Cap Value accounts using a model portfolio developed by the sub-advisor NFJ Investment Group L.P. ("NFJ") as a guide. While Allianz generally intends to follow NFJ's recommendations, as the account manager it has the discretion to accept or reject any investment recommendation and to deviate from the model portfolio. Allianz/NFJ's bottom-up investment process may, at times, result in portfolios that will be over/underweighted in particular sectors/industries versus the S&P 500 Index.

- Apply a screen for positive fundamental characteristics to a universe of approximately 1,000 stocks
- Research each of the remaining possible investments, looking for companies with low price-to-earnings multiples, low price-to-book multiples, a high dividend yield, and good price momentum
- Avoid overexposure to any one sector by restricting the number of stocks held in a single industry
- Select approximately of the most attractive securities identified, diversified across industries. Each holding must pay a dividend






## AVERAGE ANNUAL TOTAL RETURN (%) – PERIODS ENDING 03/31/13

#### Related Performance:

Allianz Global Investors U.S. LLC/NFJ Investment Group L.P.'s (Allianz/NFJ) large cap value equity performance prior to 1/1/2007 represents a composite of all discretionary large cap value style institutional accounts managed by NFJ Investment Group at the institutional account minimum of \$20 million, although there may be accounts below the minimum included in the institutional composite. The composite was asset-weighted and consisted of 6 accounts with a market value of \$844.4 million as of 12/31/2006.

#### Fiduciary Services Performance:

In this profile, the performance from 1/1/2007 through June 2012 consists of accounts in either the Morgan Stanley or the Smith Barney form of the Fiduciary Services program. From July 2012, performance consists of all Fiduciary Services accounts managed by the investment manager in the strategy, subject to any other limitations stated in this profile. Performance composites calculated by Morgan Stanley include all fee-paying portfolios with no investment restrictions. New accounts are included upon the first full quarter of performance. ## INDEX DESCRIPTIONS

### 90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of 'discount' is the interest earned. T-bills are issued in denominations of \$10,000 (auction) and \$1,000 increments thereafter.

### Russell 1000 VI

The Russell 1000 Value Index is representative of the U.S. market for large capitalization stocks containing those companies in the Russell 1000 Index with lower price-to-book ratios and lower forecasted growth.

### S&P 500

The S&P 500 has been widely regarded as the best single gauge of the large cap U.S. equities market since the index was first published in 1957. The index has over US\$ 5.58 trillion benchmarked, with index assets comprising approximately US\$ 1.31 trillion of this total. The index includes 500 leading companies in leading industries of the U.S. economy, capturing 75% coverage of U.S. equities. This index includes dividend reinvestment.

## GLOSSARY OF TERMS

**Alpha** is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

**American Depositary Receipts (ADRs)** are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

**Average Portfolio Beta** is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Capitalization** is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

**Downside Risk** is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

**Duration** is a measure of price sensitivity expressed in years.

**Information Ratio** is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

**Investment Grade Bonds** are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

**Price/Earnings Ratio (P/E Ratio)** shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are

determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

**R<sup>2</sup> (R-Squared)/Portfolio Diversification** indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

**Sharpe Ratio** measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

**Standard Deviation** is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

**Tracking Error** represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.
