### PRODUCT OVERVIEW

Pacific Income Advisers, Inc.'s (PIA) intermediate term fixed income investment strategy applies an active core discipline utilizing duration and yield curve management with sector oriented decisions and security selection. The investment process was designed to exploit what they believe are the inefficiencies in the yield curve by capitalizing on the periodic opportunities to achieve above average yields adjusted for risk and the potential for capital gains, as the yield curve reverts to its normal shape. An important aspect of PIA's investment process is its application of Treasury yield curve analysis to other bond market sectors (e.g. industrial, financial, agency, mortgages). While the concept of a "yield curve" is generally associated with Treasury securities, PIA's methodology analyzes the yield curves for all major bond market sectors. PIA maintains a proprietary historical yield-spread database which analyzes over 75 bond market sectors, providing portfolio managers with insight into the probabilistic nature of shifts in these various yield curves, assisting them in identifying relative value among these credit sectors. PIA's yield curve analysis consists of analyzing sector data to determine each sector's relative valuation based on risk-adjusted spreads. Sectors are ranked relative to each other, from most attractive to least attractive in terms of valuation. PIA tends to overweight those sectors that they believe offer higher risk-adjusted yields and the potential for capital gains as the yield curve reverts to its normal shape. As a general rule, duration can be +/-20% of each respective index's duration.

## MANAGER'S INVESTMENT PROCESS

- PIA maintains and utilizes a database to perform quantitative analysis to identify relative value among 75 credit/duration-based bond market sectors
- PIA seeks to add value through sector selection, duration decision and yield curve positioning
- PIA's Bond Strategy Group reviews the credit quality of portfolio holdings and evaluates sector valuations to identify what they believe are the highest "risk-adjusted" yields among securities under consideration for purchase
- Utilizing all major fixed income sectors of the market, PIA constructs investment grade portfolios with securities that they rank as undervalued on a risk-adjusted basis
- PIA will sell a security upon what it determines to be fair value, if there is deterioration in business fundamentals or to take advantage of what they believe is a better opportunity

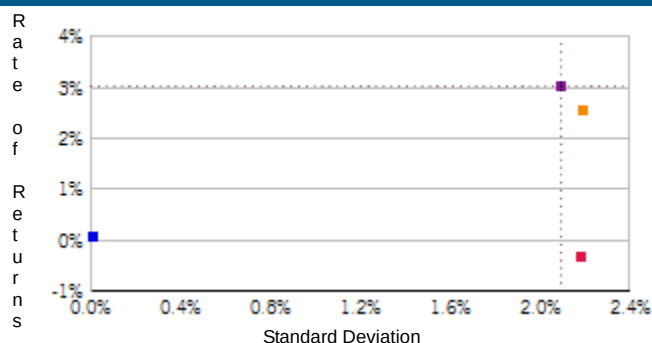

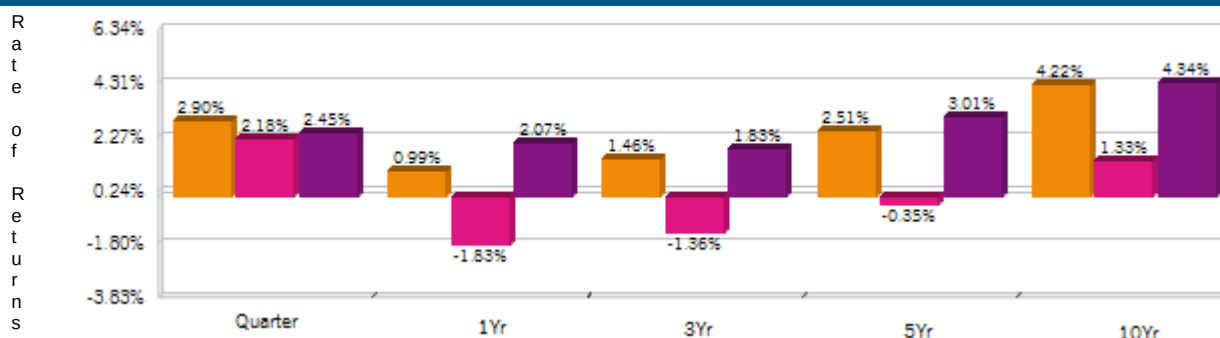

## RISK/RETURN ANALYSIS - 5 YEARS ENDING 03/31/16



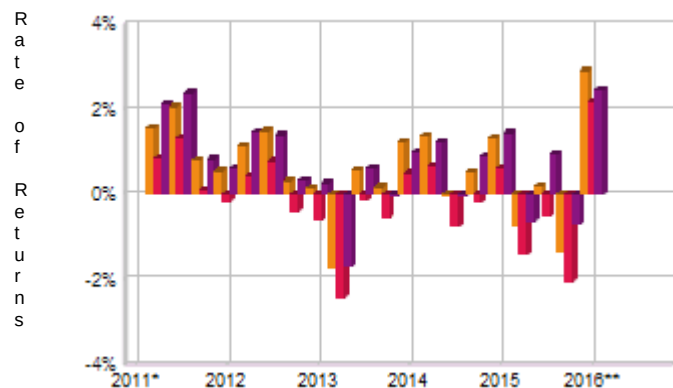

Pacific Income Advisers, Inc.'s (PIA) intermediate term (Limited Duration) fixed income performance prior to 6/30/2001 represents a composite of all fully discretionary institutional accounts over \$3 million managed for a full quarter according to PIA's limited duration fixed income strategy. The number of holdings in these accounts ranged from 15 to 30. The composite was size-weighted and consisted of 6 accounts with a market value of \$375.0 million as of 6/30/2001. From 7/1/2001 to 3/31/2003, the performance represents a composite of fully discretionary, wrap-fee and non-wrap-fee separately managed accounts over \$1 million that were managed for a full quarter according to the Limited Duration SMA strategy.

**Fiduciary Services Performance:**

In this profile, the performance from 10/1/2002 through June 2012 consists of accounts in either the Morgan Stanley or the Smith Barney form of the Fiduciary Services program. ## INDEX DESCRIPTIONS

### 90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of discount is the interest earned. T-bills are issued in denominations of \$10,000 auction and \$1,000 increments thereafter.

### BC Gov/Cr Intm

The Barclays Government/Credit Bond Index contains bonds that are investment grade and that have at least one year to maturity. The Barclays Intermediate Government/Credit Bond Index is composed primarily of bonds covered by the Barclays Government/Credit Bond Index with maturities between one and 9.99 years.

### S&P 500

## GLOSSARY OF TERMS

**Alpha** is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

**American Depositary Receipts (ADRs)** are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.



**Average Portfolio Beta** is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Beta** is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Bottom-Up Stock Selection** Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

**Capitalization** is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

**Dividend** a portion of a company's profit paid to common and preferred shareholders.

**Downside Risk** is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

**Duration** is a measure of price sensitivity expressed in years.

**High Grade Corporate Bonds** corporate bonds from issuers with credit ratings of AA or AAA.

**Information Ratio** is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

**Investment Grade Bonds** are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

**Price/Book Ratio (P/B)** weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

**Price/Cash Flow Ratio** a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company's operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

**Price/Earnings Ratio (P/E Ratio)** shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

**Price/Sales Ratio** determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

**R2 (R-Squared)/Portfolio Diversification** indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

**Sharpe Ratio** measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

**Standard Deviation** is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

**Top-Down/Economic Analysis** Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

**Tracking Error** represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

**U.S. Treasury Bonds** a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

**Volatility** a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
