PRODUCT OVERVIEW

Renaissance Investment Management's (Renaissance) large cap growth equity strategy seeks capital appreciation by investing in large capitalization U.S. companies. Renaissance invests in 50-60 mid and large-cap companies that Renaissance believes exhibit good growth characteristics, business and earnings momentum, and reasonable valuation. This investment philosophy has been in place since the strategy's inception in 1991. The investment style is best described as growth at a reasonable price with an investment process of three distinct stages: 1) Profitability & Financial Strength Analysis - Begin with the universe of the 1,000 largest U.S. companies, screening for those with above-average historical rates of profitability and strong financial characteristics. This highlights only companies with successful business records and strong operating results. 2) Score and Rank Opportunities - Typically after stage one, 400-500 companies are subjected to a rigorous quantitative scoring process, analyzed and ranked on the basis of historical growth, future earnings expectations and valuation, resulting in a composite ranking. Only the top 20% of companies in this composite ranking are eligible for further review. 3) Qualitative Analysis - Examine each company ranked in the top 20% considering fundamentals, business momentum, management strategy, etc. Use outside research sources as well as internal analysis. The most attractive companies from this further qualitative review are finally selected. The scoring process serves as an effective sell discipline as any issue falling below the top 40% in the composite ranking becomes an automatic sale candidate. This sell discipline results in companies being sold in favor of more attractively ranked companies. Renaissance's process may, at times, result in portfolios that will be over/underweighted in particular sectors/industries versus the S&P 500 Index.

The portfolio characteristics, portfolio statistics, portfolio weightings, allocation history and top five holdings are based on a representative account managed by the investment manager in the same or a substantially similar investment discipline and/or on information that the manager has provided to Morgan Stanley Smith Barney. The performance data and related analyses are based on the performance of the investment manager's composite described on page 3.

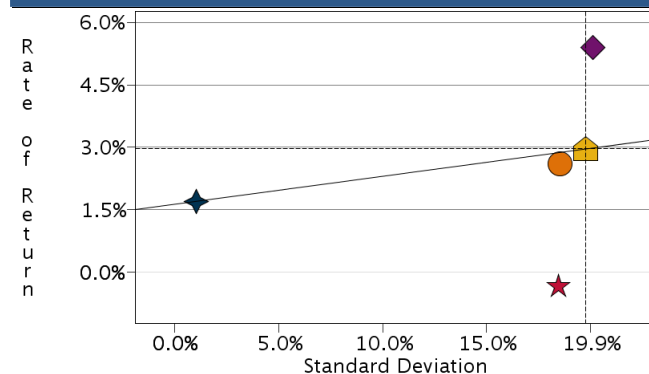

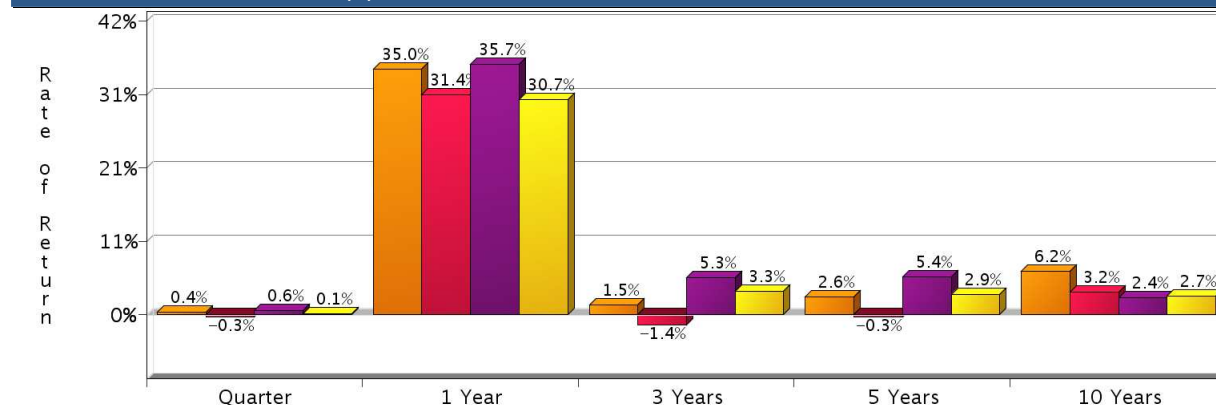

RISK/RETURN ANALYSIS – 5 YEARS ENDING 06/30/11



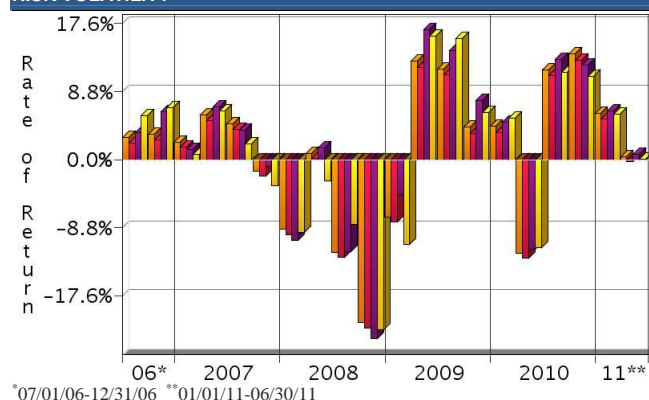

Sources of Performance Results and Other Data: The performance data and certain other information for this strategy (including the data on page 1 of this profile) reflect the investment manager's results in managing Morgan Stanley Smith Barney Fiduciary Services program accounts in the Morgan Stanley channel or the Smith Barney channel, or the investment manager's results in managing accounts and investment products, in the same or a substantially similar investment discipline. This information for the investment manager is presented solely to provide information about accounts that were managed according to investment objectives and strategies the same or substantially similar to the corresponding investment discipline in the Select UMA program. Although the Fiduciary Services and Select UMA programs are both Morgan Stanley managed account programs, the performance results and other features of similar investment disciplines in the two programs may differ due to investment and operational differences. Related Performance:

Renaissance Investment Management's large cap growth equity performance prior to 4/1/2007 represents a composite of all fee paying, fully discretionary, large cap growth wrap accounts (not in the Morgan Stanley Fiduciary Services program) managed by Renaissance. The composite was asset-weighted and included approximately 10,949 accounts with a market value of \$2.5 billion as of 3/31/2007.

Select UMA Performance:

In this profile, the performance from 4/1/2007 consists of accounts in either the Morgan Stanley or the Smith Barney form of the Fiduciary Services program. Performance composites calculated by Morgan Stanley Smith Barney include all fee-paying portfolios with no investment restrictions. New accounts are included upon the first full quarter of performance. Terminated accounts are removed in the quarter in which they terminate. Performance is calculated on a total return basis and by asset weighting the individual portfolio returns using the beginning of period values.

Gross Performance: Renaissance's gross results do not reflect a deduction of any investment advisory fees or program fees, charged by Renaissance or Morgan Stanley Smith Barney, but are net of commissions charged on securities transactions.

Net Performance for all Periods: Net performance results reflect a deduction of .7175% quarterly. This consists of three components: 0.625% maximum quarterly MSSB Advisory Fee and 0.03% maximum quarterly Program Overlay Fee (which, together cover the services provided by Morgan Stanley Smith Barney), plus .0625% quarterly SMA Manager Fees (being the fee currently charged by Renaissance to new clients for managing their assets in the Select UMA program). INDEX DESCRIPTIONS

90-Day Treasury Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of 'discount' is the interest earned. T-bills are issued in denominations of \$10,000 (auction) and \$1,000 increments thereafter.

Russell 3000 Growth Index

The Russell 3000 Growth Index is representative of those Russell 3000 Index companies with higher price-to-book ratios and higher forecasted growth values. The stocks in this index are also members of either the Russell 1000 Growth Index or the Russell 2000 Growth Index.

S&P 500 Index

Widely regarded as the best single gauge of the U.S. equities market, this world-renowned index includes a representative sample of 500 leading companies in leading industries of the U.S. economy. Although the S&P 500 focuses on the large-cap segment of the market, with over 80% coverage of U.S. equities, it is also an ideal proxy for the total market.

GLOSSARY OF TERMS

Alpha is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

American Depositary Receipts (ADRs) are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

Average Portfolio Beta is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

Capitalization is defined as the following: Mega (\$50.0 billion and Above), Large (\$11.0 - \$50.0 billion), Medium (\$2 - \$11.0 billion), Small (\$500m - \$2 billion) and Micro (below \$500 million).

Downside Risk is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

Duration is a measure of price sensitivity expressed in years.

Information Ratio is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

Investment Grade Bonds are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

Price/Earnings Ratio (P/E Ratio) shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

R² (R-Squared)/Portfolio Diversification indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

Sharpe Ratio measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

Standard Deviation is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

Tracking Error represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.
