PRODUCT OVERVIEW

Sage Advisory Services, Ltd. Co. ("Sage") Market Duration Municipal Fixed Income investment strategy's objective is to minimize downside risk in any environment and maintain consistent quarterly after-tax total returns over an intermediate to long-term investment horizon. Sage seeks to satisfy future operating or liability funding requirements in the most efficient present value terms within the client's investment risk constraints. Sage employs a value-oriented comprehensive portfolio management approach which blends together the investment techniques of active duration management, market sector rotation and undervalued security selection. Portfolio security selection is primarily focused on investment grade municipal obligations, such as, tax-exempt municipal general and revenue debt obligations, taxable municipal general and revenue debt obligations, auction rate securities and variable rate demand notes, as well as U. S. Treasury debt obligations. Sage's investment approach is based upon fundamental analysis of international capital markets and macro economic cycles, utilizes quantitative analysis techniques for portfolio construction and security valuation, focuses on meeting individual client liability funding objectives and long-term investment needs, and is directed towards achieving competitive and consistent risk adjusted after-tax total returns. Sage's investment process assesses client liability funding requirements and the existing investment portfolio, identifies optimal portfolio duration positioning via horizon return analysis and cash flow modeling, establishes market sector allocations relative to market environment and client cash flow requirements, and selects individual securities based upon potential performance contribution and develops an optimal portfolio.



PORTFOLIO'S CREDIT QUALITY STRUCTURE(%) ^{†, *}



RISK/RETURN ANALYSIS – 5 YEARS ENDING 06/30/11




AVERAGE ANNUAL TOTAL RETURN (%) – PERIODS ENDING 06/30/11

Related Performance:

Sage Advisory Services, Ltd. Co.'s ("Sage") Market Duration Municipal Fixed Income performance was calculated by the investment manager and represents a composite of all actual, fee-paying fully discretionary accounts managed by Sage for at least three months. Sage minimum account size is \$1,000,000 as of 6/30/2010. The composite is asset-weighted and consisted of 5 accounts with a market value of \$25.0 million as of 6/30/2011.

Municipal Fixed Income Account (Gross): Sage's gross results do not reflect a deduction of the investment advisory fees charged by the manager, or program fees, if any, but are net of commissions charged on transactions.

Fiduciary Services Performance:

Net Performance for all Periods: To demonstrate the effect of Morgan Stanley Smith Barney's fees that would have applied if you had invested in the investment manager strategy's through the Fiduciary Services program, the net results for all periods are calculated by deducting a quarterly fee of 0.705% (equivalent to an annual fee of 2.82%).

Morgan Stanley Smith Barney program fees are usually deducted quarterly, and have a compounding effect on performance. Focus List, Approved List, and Watch Status:

Consulting Group Investment Advisor Research ("CG IAR") uses two methods to evaluate investment products in applicable advisory programs. In general, strategies that have passed a more thorough evaluation may be placed on the "Focus List", while strategies that have passed a less comprehensive evaluation process may be placed on the "Approved List". INDEX DESCRIPTIONS

90-Day Treasury Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of 'discount' is the interest earned. T-bills are issued in denominations of \$10,000 (auction) and \$1,000 increments thereafter.

BC Municipal Bond Index

The Barclays Municipal Bond Index contains approximately 1,100 municipal bonds composed of approximately 60% revenue bonds and 40% state government obligations.

S&P 500 Index

Widely regarded as the best single gauge of the U.S. equities market, this world-renowned index includes a representative sample of 500 leading companies in leading industries of the U.S. economy. Although the S&P 500 focuses on the large-cap segment of the market, with over 80% coverage of U.S. equities, it is also an ideal proxy for the total market.

GLOSSARY OF TERMS

Alpha is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

American Depository Receipts (ADRs) are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

Average Portfolio Beta is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

Capitalization is defined as the following: Mega (\$50.0 billion and Above), Large (\$11.0 - \$50.0 billion), Medium (\$2 - \$11.0 billion), Small (\$500m - \$2 billion) and Micro (below \$500 million).

Downside Risk is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

Duration is a measure of price sensitivity expressed in years.

Information Ratio is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

Investment Grade Bonds are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

Price/Earnings Ratio (P/E Ratio) shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

R² (R-Squared)/Portfolio Diversification indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

Sharpe Ratio measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

Standard Deviation is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

Tracking Error represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.
