### PRODUCT OVERVIEW

Templeton Separately Managed Accounts (TSMA), invests in a portfolio of global equity and fixed income securities. The global equity portion of the portfolio is managed using the Templeton philosophy consisting of U.S. equities and foreign securities in the form of American Depository Receipts (ADRS) and foreign stocks traded in U.S. markets. The fixed income portfolio is managed by Franklin Separately Managed Accounts (FSMA). Both TSMA and FSMA are part of Franklin Templeton Investments. FSMA implements its fixed income investment philosophy utilizing primarily U.S. Treasury and Agency bonds, corporate bonds and ETFs traded in U.S. markets. FSMA focuses on investments in high-quality bonds, seeking to take advantage of relative valuation differences between asset classes, issuers and individual bond issues, with the objective of producing a high level of current income and generating total return opportunities. TSMA has a bottom-up, value-oriented investment approach rooted in original fundamental research with an unconstrained search for long-term value across all sectors and regions. TSMA seeks companies trading at large discounts to their business value, based on future earnings, cash flow or asset value potential. TSMA leverages the research team of the broader Templeton organization. TSMA's investment process may result in portfolios that will be significantly over/underweighted in particular sectors/countries/regions versus the MSCI World Index. Investments in emerging markets may range from 5 to 15% of the equity portfolio. The target allocation for this portfolio is 65% equity and 35% fixed income. The ranges for equity and fixed income are expected to generally fluctuate from approximately 60-70%, and 30-40%, respectively and will be determined by TSMA.

## MANAGER'S INVESTMENT PROCESS

- Fundamental analysis with emphasis on a company's price relative to its five-year EPS, cash-flow or asset value potential
- Investment thesis presented to research team for debate and Director of Research approval
- Portfolio reflects where research is finding value; reviewed by entire research team in weekly peer review
- Stocks sold if price meets/exceeds estimation of full value, greater value exists in another security, or fundamental change in investment thesis occurs
- Using proprietary, relative value analysis, fixed income PMs make top-down allocation decisions among U.S. Treasury securities, U.S. agency securities and corporate bonds. Managers and analysts then perform bottom-up, fundamental research that emphasizes credit quality and liquidity





## RISK/RETURN ANALYSIS - 5 YEARS ENDING 06/30/16



### 90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. ## GLOSSARY OF TERMS

**Alpha** is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

**American Depository Receipts (ADRs)** are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

**Average Portfolio Beta** is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Beta** is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Bottom-Up Stock Selection** Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

**Capitalization** is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

**Dividend** a portion of a company's profit paid to common and preferred shareholders.

**Downside Risk** is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

**Duration** is a measure of price sensitivity expressed in years.

**High Grade Corporate Bonds** corporate bonds from issuers with credit ratings of AA or AAA.

**Information Ratio** is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

**Investment Grade Bonds** are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

**Price/Book Ratio (P/B)** weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

**Price/Cash Flow Ratio** a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company's operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

**Price/Earnings Ratio (P/E Ratio)** shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

**Price/Sales Ratio** determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

**R2 (R-Squared)/Portfolio Diversification** indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

**Sharpe Ratio** measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

**Standard Deviation** is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

**Top-Down/Economic Analysis** Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

**Tracking Error** represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

**U.S. Treasury Bonds** a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

**Volatility** a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
