- **Top-down macroeconomics analysis**—includes an assessment of factors such as interest rates, inflation, monetary policy and demographic trends.
- **Bottom-up company and stock analysis**—stocks are evaluated and selected on the basis of attributes such as market share position, excellent management teams, improving profit margins, solid balance sheets and free cash flow generation.

Thornburg Investment Management, Inc.

Location: Santa Fe, NM

Year Registered: 1982

- **Bottom-up investors**—Thornburg seeks to own promising companies at a discount to their estimates of their intrinsic value. The firm knows what they own and why they own it. Stocks are placed in a portfolio on merit, not to accommodate weights relative to a benchmark.
- **Long Term view on investing**—Thornburg believes firms that focus on the next quarter tend to get caught up in price momentum and the herd mentality that can envelop a stock.
