PRODUCT OVERVIEW

AB Concentrated International Growth is a portfolio of approximately 25 to 30 stocks that seeks to generate outperformance through superior stock selection driven by the firm's proprietary fundamental research. Our bottom-up research identifies the most attractive investment candidates—great businesses that appear to offer the best long-term growth potential and are trading at attractive valuations. We have been using this approach in our Concentrated International Growth portfolios since 2006, and it has allowed us to deliver strong performance to our clients over time. Because this strategy expects to hold a concentrated portfolio of a limited number of securities, a decline in the value of these investments would cause the portfolio's overall value to decline to a greater degree than that of a less concentrated portfolio.

<ul style="list-style-type: none"> • The Team applies a disciplined investment process focused on the goal of delivering superior, sustainable returns by investing in concentrated portfolios of high-quality, steadily growing businesses. The process is rooted in fundamental analysis and features four distinct steps: • Discovery – Screening the Broad Universe- The investment process begins with a broad universe of approximately 1,500 stocks, which we screen based on market capitalization and growth parameters. • Identifying Quality – Focusing on the Opportunity Set- We then narrow down the universe to an opportunity set of approximately 150 high-quality growth companies, which are typically superior businesses that have consistent positive earnings, a high degree of predictability, and are industry leaders. Additionally, we integrate Environmental, Social and Corporate Governance factors in our equity research and investment process to help us focus on the highest quality growth opportunities. • Model and Discuss - Evaluating the Best Candidates- We then narrow down the opportunity set to an investment universe of approximately 60 companies. The identification of the investment universe is a team-based process that involves all members and reflects their research. We assign each investment prospect an appropriate market-relative multiple, taking into account the relative growth over a five-year period. The relative valuation usually ranges between 80 (for a company growing slower than the market) and 220 (for stocks growing much faster). We then discount this valuation back to today using different discount rates. • Portfolio Construction – Investing in Compelling Stocks- Once we determine a target price for each stock in the universe based, we rank the stocks by relative price attractiveness and begin to build a diversified portfolio. The Team considers valuation attractiveness at a given time, the level of conviction in the company, and the liquidity of the underlying security. Generally, we concentrate holdings in those with the greatest appreciation potential and sell off those that appear to be fully valued. 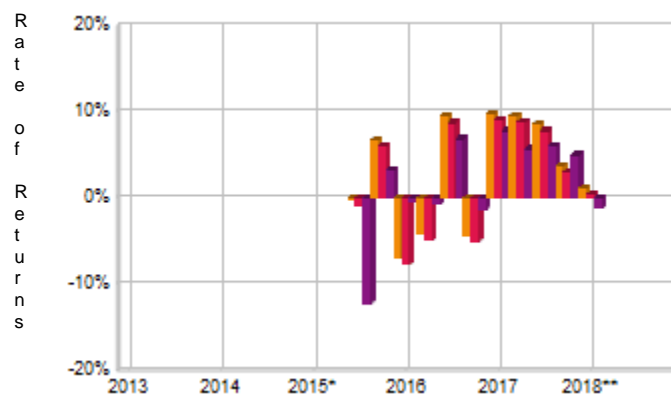

INDEX DESCRIPTIONS

90-Day T-Bills

GLOSSARY OF TERMS

Alpha is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

American Depositary Receipts (ADRs) are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

Average Portfolio Beta is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

Beta is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

Bottom-Up Stock Selection Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

Capitalization is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

Dividend a portion of a company's profit paid to common and preferred shareholders.

Downside Risk is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

Duration is a measure of price sensitivity expressed in years.

High Grade Corporate Bonds corporate bonds from issuers with credit ratings of AA or AAA.

Information Ratio is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

Investment Grade Bonds are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

Price/Book Ratio (P/B) weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

Price/Cash Flow Ratio a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company's operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

Price/Earnings Ratio (P/E Ratio) shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

Price/Sales Ratio determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

R2 (R-Squared)/Portfolio Diversification indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

Sharpe Ratio measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

Standard Deviation is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

Top-Down/Economic Analysis Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

Tracking Error represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

U.S. Treasury Bonds a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

Volatility a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
