<p>Fundamental credit research is the foundation of the fixed income investment process at Eaton Vance and they believe it is critical to generating attractive returns in a laddered corporate bond portfolio. The credit process is primarily focused on assessing the risks of owning corporate credits to assess whether they are fully compensated for taking that risk. After Eaton Vance has performed the credit analysis, they look at the structure of the bond. While credit analysis focuses on evaluating the probability of repayment by a given issuer, structural analysis concentrates on the timing of a given bond's cash flows. In the laddered corporate bond portfolios, Eaton Vance seeks to produce consistent and competitive income streams, so they generally avoid bonds with any imbedded options. As part of the risk-return assessment, their traders provide input on liquidity. Their team then determines if the expected return is attractive given the risk assessment. When constructing client portfolios, their first step is to review client mandated constraints. Before executing any trades, Eaton Vance models the proposed portfolio in their analytics system to ensure that the strategy is executable from the beginning. The objective of their collaborative investment process is to utilize fundamental and quantitative credit analysis to construct a diversified portfolio from the bottom-up that meets their clients' unique objectives, while strictly adhering to their individual maturity and quality constraints. After Eaton Vance has identified possible corporate issuers, they perform rigorous bottom-up credit and structural analysis on each security before it can be considered for portfolio inclusion. They look for companies with: 1. Proven management teams; 2. Positive industry fundamentals; 3. Improving operating results; 4. Attractive security terms 5. - Eaton Vance believes that stable long-term returns are achieved through bottom-up, credit research and issuer diversification.
- Their philosophical approach to managing laddered corporate bond portfolios is predicated on the following key tenets:
- Seeking to protect principal is their first priority
- Fundamental credit analysis is an ongoing process
- Diversification contributes to consistent returns over a credit market cycle
- Dedicated investment grade corporate bond expertise is essential to long term success
- Eaton Vance's investment strategy in managing laddered corporate bond portfolios is based on professional management and institutional buying power which offers important potential benefits to bond investors
- Their dedicated team of experienced credit analysts select and monitor investments
- They seek to manage risk through diversification

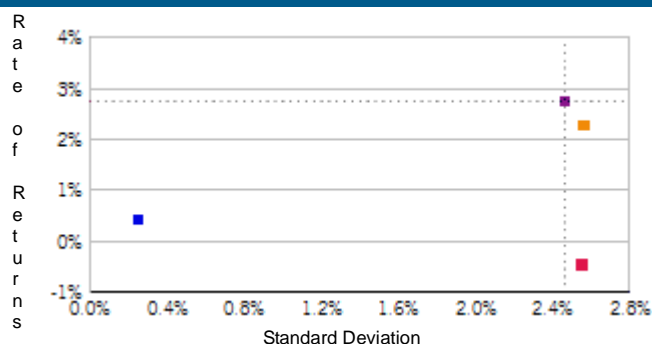

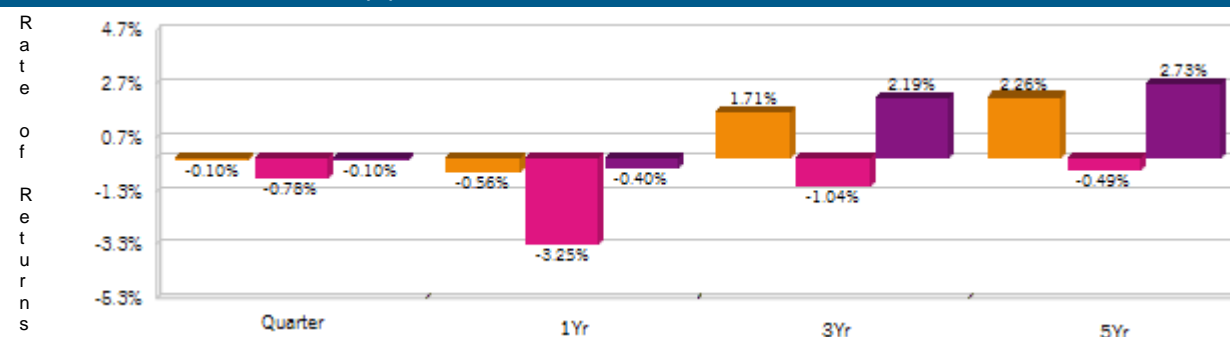

AVERAGE ANNUAL TOTAL RETURN (%) - PERIODS ENDING 06/30/18

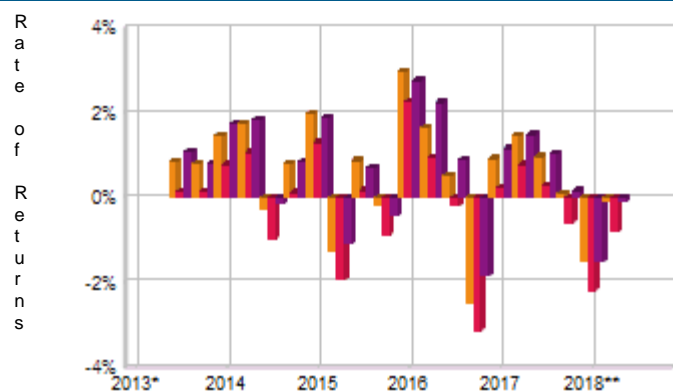

The investment objective of this style is to provide stable income. Accounts seek to achieve this objective by investing in investment-grade U.S. corporate and Yankee bonds that carry an average maturity of one to ten years and a credit rating of BBB-or better. An account is included in the Composite at the beginning of the third full month under management. Closed accounts are included through the last full month under management. No selective periods of performance have been used. Composite gross returns are presented as supplemental information and do not include any fees, expenses or transaction costs. All fees for accounts in this composite are available from the managed account sponsor's form ADV Part II. The creation date of this composite is February 2012, and the inception date is October 2012. The composite consists of 373 account(s) with a market value of **\$112.5 million** as of **06/30/2018**. In this profile, from January 1, 2016, performance consists of the performance of all FS accounts (as described in the previous sentence) as well as the performance of all single style Select UMA accounts managed by the investment manager in this strategy, subject to any other limitations stated in this profile. Performance composites calculated by Morgan Stanley include all fee-paying portfolios with no investment restrictions. INDEX DESCRIPTIONS

90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of discount is the interest earned. T-bills are issued in denominations of \$10,000 auction and \$1,000 increments thereafter.

BC Corp Intm

Publicly issued U.S. corporate and specified foreign debentures and secured notes that meet the specified maturity, liquidity, and quality requirements. To qualify, bonds must be SEC-registered. This index is the Intermediate component of the U.S. Corporate Investment Grade index.

S&P 500

The S&P 500 Total Return has been widely regarded as the best single gauge of the large cap U.S. equities market since the index was first published in 1957. The index has over \$5.58 trillion benchmarked, with index assets comprising approximately \$1.31 trillion of this total. The index includes 500 leading companies in leading industries of the U.S. economy, capturing 75% coverage of U.S. equities. This index includes dividend reinvestment.

GLOSSARY OF TERMS

Alpha is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

American Depositary Receipts (ADRs) are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

Average Portfolio Beta is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

Beta is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

Bottom-Up Stock Selection Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

Capitalization is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

Dividend a portion of a company's profit paid to common and preferred shareholders.

Downside Risk is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

Duration is a measure of price sensitivity expressed in years.

High Grade Corporate Bonds corporate bonds from issuers with credit ratings of AA or AAA.

Information Ratio is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

Investment Grade Bonds are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

Price/Book Ratio (P/B) weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

Price/Cash Flow Ratio a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company's operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

Price/Earnings Ratio (P/E Ratio) shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

Price/Sales Ratio determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

R2 (R-Squared)/Portfolio Diversification indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

Sharpe Ratio measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

Standard Deviation is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

Top-Down/Economic Analysis Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

Tracking Error represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

U.S. Treasury Bonds a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

Volatility a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
