## PRODUCT OVERVIEW

The Large Cap Value Portfolio Management Team, together with the research analysts, identifies potential catalysts for investment by monitoring changes in company developments, industry dynamics, and the economic environment. Selected companies are further researched by analyzing the potential impacts of industry trends and product cycles, the potential for margin expansion and the possible impact of legislative actions and regulatory changes on future business prospects. Quantitative valuation models are used to determine risk/reward characteristics for stocks under consideration for purchase, to test the conclusions reached by fundamental analysis and to determine appropriate security valuations based on normalized earnings. Through this process, the team constructs a diversified portfolio of 70-90 equity securities, with portfolio weights based on the strength of the team's convictions and perception of market sentiment, balanced by an awareness of the benchmark and sensitivity to risk exposure. Within the fixed income portion of the balanced strategy, the process begins with an evaluation of global economic, financial and regulatory conditions they believe are likely to influence the fixed income markets. This analysis occurs in parallel with fundamental credit and quantitative research. Quantitative econometric modeling is used to assess relative value at the security and sector level and to measure and manage portfolio risk. The teams of sector specialists and quantitative analysts combine in an effort to determine optimal portfolio construction which includes security, sector and term structure decisions. As a matter of policy, portfolios are managed duration neutral to the appropriate index. The fixed income portion typically has 10-20 holdings.





## RISK/RETURN ANALYSIS - 5 YEARS ENDING 03/31/18





The GIPS® Compliant performance results shown below represent the investment performance record for Lord, Abnett & Co. LLC's Managed Accounts Value Balanced Taxable – Aggregate (without mortgages) Composite (the "VB" Composite), which includes all fully invested portfolios managed in a separately managed account program investing primarily in a combination of large-capitalization equity securities that Lord Abnett deems to be undervalued on a relative basis and U.S. government securities, including its agencies and instrumentalities (but without mortgage-backed securities). New accounts are included in the Composites as of the first full month they are under management. Closed accounts are removed from the Composites after the last full month in which they were managed in accordance with the applicable objectives, guidelines and restrictions. Performance results are expressed in U.S. dollars and reflect reinvestment of any dividends and distributions. Cash flows are adjusted for on a time-weighted basis and an account is revalued in the event a cash flow equals or exceeds 10%. The VB Composite was created in 2002. A complete list of Lord Abnett composites and a description of the investment strategies are available on request. The performance of the Composite is shown net and gross of the maximum separately managed account program fee. The net performance results illustrate the effect of the deduction of the maximum separately managed account program fee (2.8%) on investment returns. All gross performance shown is presented on a supplemental basis and reflects the deduction of transaction costs. The program fee is paid to the program sponsor and includes the advisory fee Lord Abnett receives and trade execution expenses. The effect of fees and expenses on performance will vary with the relative size of the fee and account performance. For example, if \$100,000 were invested and experienced a 10% compounded annual return for 10 years, its ending dollar value, without giving effect to the deduction of the program fee, would be \$259,374. If a program fee of 2.8% of average net assets per year for the 10-year period were deducted, the annual total return would be 6.99% and the ending dollar value would be \$200,423. The composite consists of **275** account(s) with a market value of **\$102.4 million** as of **03/31/2018**. In this profile, the performance from April 1, 2002 through June 30, 2012 consists of accounts managed by the investment manager in this strategy in either the Morgan Stanley or the Smith Barney form of the Fiduciary Services program. From July 1, 2012 through December 31, 2015, performance consists of all Fiduciary Services (FS) accounts managed by the investment manager in this strategy, subject to any other limitations stated in this profile. **90-Day T-Bills**

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are issued in denominations of \$10,000 auction and \$1,000 increments thereafter.

**S&P 500**

The S&P 500 Total Return has been widely regarded as the best single gauge of the large cap U.S. equities market since the index was first published in 1957. The index has over \$5.58 trillion benchmarked, with index assets comprising approximately \$1.31 trillion of this total. The index includes 500 leading companies in leading industries of the U.S. economy, capturing 75% coverage of U.S. equities. This index includes dividend reinvestment.

**GLOSSARY OF TERMS**

**Alpha** is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

**American Depositary Receipts (ADRs)** are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

**Average Portfolio Beta** is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Beta** is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Bottom-Up Stock Selection** Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

**Capitalization** is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

**Dividend** a portion of a company's profit paid to common and preferred shareholders.

**Downside Risk** is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

**Duration** is a measure of price sensitivity expressed in years.

**High Grade Corporate Bonds** corporate bonds from issuers with credit ratings of AA or AAA.

**Information Ratio** is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

**Investment Grade Bonds** are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

**Price/Book Ratio (P/B)** weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

**Price/Cash Flow Ratio** a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company's operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

**Price/Earnings Ratio (P/E Ratio)** shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

**Price/Sales Ratio** determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

**R2 (R-Squared)/Portfolio Diversification** indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

**Sharpe Ratio** measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

**Standard Deviation** is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

**Top-Down/Economic Analysis** Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

**Tracking Error** represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

**U.S. Treasury Bonds** a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

**Volatility** a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
