PRODUCT OVERVIEW

Allianz Global Investors U.S. LLC adheres to a strict value philosophy, seeking undervalued, fundamentally sound companies. What sets the firm apart from other value-oriented managers is its emphasis on risk control. To temper the risks associated with equity investing, Allianz Global Investors U.S. LLC maintains broad industry diversification and expects each stock in its International Value portfolio to pay a dividend-a characteristic they believe is an important sign of financial stability. Allianz Global Investors U.S. LLC's investment process enables it to identify international stocks within a universe of approximately 600 ADR's within a market cap universe of \$1 billion and above, offering attractive valuations and long-term growth potential. At the same time, the process seeks to control total portfolio risk. Allianz Global Investors Managed Accounts manages the Allianz Global Investors U.S. LLC International Value accounts using a model portfolio developed by the sub-advisor NFJ as a guide. While Allianz Global Investors Managed Accounts generally intends to follow Allianz Global Investors U.S. LLC's recommendations, as the account manager it has the discretion to accept or reject any investment recommendation and to deviate from the model portfolio.

MANAGER'S INVESTMENT PROCESS

- Their investment process enables them to identify stocks offering what they believe are attractive valuations and growth potential.
- Primary Screening - Apply a screen for positive characteristics to a universe of the largest 1,000 U.S. stocks by market capitalization. Stocks are ranked by price-to-earnings ratio and dividend yield within their industry peer group. Stocks that exhibit attractive relative valuations in an industry and pay dividends are identified as prospective purchase candidates.
- Secondary Screens - Stocks that exhibit poor price momentum are excluded from consideration. Companies are also screened to identify earnings revisions and significant insider trades that could affect price movements.
- Research and Analysis - Portfolio candidates must exhibit high quality based on assessment of company fundamentals, including balance sheet analysis, cash flow analysis and earnings and dividend history.
- Portfolio Construction - Identify approximately 40-60 of the most attractive securities, diversified among 40-50 industries. Position sizes of 2% or 4% at market value are established based on assessment of valuation, dividend yield and low price-to-earnings ratio.





AVERAGE ANNUAL TOTAL RETURN (%) - PERIODS ENDING 09/30/17



Related Performance:

The NFJ International Value performance data from 1/1/2006 to the present reflects a composite of all fully discretionary managed account portfolios with comparable investment objectives and risk managed by Allianz Global Investors Managed Accounts using NFJ's International Value model. From 3/1/2003 through 12/31/2005, the performance presented represents the International Value Institutional Composite which includes all discretionary, institutional fee-paying accounts, regardless of size, invested in NFJ's International Value strategy. This strategy, with an emphasis in low P/E, is almost exclusively limited to ADR's and foreign stocks listed on the NYSE. Accounts meeting the above criteria are included in the Institutional Composite beginning with the first full month under management after they have been fully invested (as determined by NFJ) and terminated accounts are removed at the end of the last full month under management. From inception until 4/1/2005, the Composite was composed of one non-fee paying seed account.

In this profile, the performance from July 1, 2010 through June 30, 2012 consists of accounts managed by the investment manager in this strategy in either the Morgan Stanley or the Smith Barney form of the Fiduciary Services program. INDEX DESCRIPTIONS

90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of discount is the interest earned. T-bills are issued in denominations of \$10,000 auction and \$1,000 increments thereafter.

MSCI AC Wld xUS Nt

The MSCI ACWI Index is a free float-adjusted market capitalization weighted index that is designed to measure the equity market performance of developed and emerging markets. The MSCI ACWI consists of 46 country indexes comprising 23 developed and 23 emerging market country indexes. The developed market country indexes included are: Australia, Austria, Belgium, Canada, Denmark, Finland, France, Germany, Hong Kong, Ireland, Israel, Italy, Japan, Netherlands, New Zealand, Norway, Portugal, Singapore, Spain, Sweden, Switzerland, the United Kingdom and the United States. The emerging market country indexes included are: Brazil, Chile, China, Colombia, Czech Republic, Egypt, Greece, Hungary, India, Indonesia, Korea, Malaysia, Mexico, Peru, Philippines, Poland, Qatar, Russia, South Africa, Taiwan, Thailand, Turkey, and United Arab Emirates (as of June 2014). GLOSSARY OF TERMS

Alpha is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

American Depository Receipts (ADRs) are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

Average Portfolio Beta is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

Beta is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

Bottom-Up Stock Selection Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

Capitalization is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

Dividend a portion of a company's profit paid to common and preferred shareholders.

Downside Risk is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

Duration is a measure of price sensitivity expressed in years.

High Grade Corporate Bonds corporate bonds from issuers with credit ratings of AA or AAA.

Information Ratio is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

Investment Grade Bonds are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

Price/Book Ratio (P/B) weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

Price/Cash Flow Ratio a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company' operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

Price/Earnings Ratio (P/E Ratio) shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

Price/Sales Ratio determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

R2 (R-Squared)/Portfolio Diversification indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

Sharpe Ratio measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

Standard Deviation is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

Top-Down/Economic Analysis Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

Tracking Error represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

U.S. Treasury Bonds a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

Volatility a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
