## PRODUCT OVERVIEW

Originally founded in 1971, Pacific Investment Management Company ("PIMCO") is a global investments solutions provider. PIMCO's primary goals in managing municipal bond portfolios are generating attractive tax-efficient income, principal preservation and enhancing after-tax total returns. They seek to diversify portfolios across state, sector and issuer when appropriate. PIMCO seeks to proactively protect clients from downside risk and will take a defensive position in a challenging market. The PIMCO Municipal Bond for Managed Accounts strategy will consist of a discreet bond portfolio with individual line items (minimum 70% of product offering) and a PIMCO proprietary sector oriented pooled fund (maximum 30% of product offering). Average duration will be maintained within  $\pm$  3 years of the benchmark.

## MANAGER'S INVESTMENT PROCESS

- PIMCO's investment process consists of both top-down and bottom-up decision making. They seek to add value through our top-down approach that leverages our long-term outlook, developed annually through their Secular Forum and augmented quarterly with short-term forecasts. Their focus on longer-term trends recognizes that secular considerations, such as demographics, political factors, fiscal policies and structural economic changes, exert powerful, sustained influences on interest rates and sector relative returns.
- The municipal team leverages the top-down outlook provided by the forums and leverages investment targets from the PIMCO Investment Committee while viewing each output through the lens of a tax-exempt investor. The municipal team also considers fundamental and technical factors within the municipal market when making investment decisions. Individual security selection is a key component in building a municipal portfolio. In selecting individual issues, they analyze credit, call and sinking fund, liquidity and market discount tax risks. They seek to maintain liquidity, capital preservation and high quality while improving market access and pricing in a risk-adjusted framework.
- The portfolio will invest at least 70% in individual high quality intermediate municipal securities with the remaining assets in a PIMCO proprietary sector oriented pooled fund.



## RISK/RETURN ANALYSIS - 5 YEARS ENDING 06/30/18



## AVERAGE ANNUAL TOTAL RETURN (%) - PERIODS ENDING 06/30/18





The PIMCO National Municipal Bond Managed Accounts with Commingled Vehicle Exposure Composite includes all discretionary accounts that are managed through a wrap-fee program in the style and are benchmarked against the Barclays 10-Year Municipal Bond Index. Portfolios consist of municipal bonds exempt from Federal taxes. The portfolio targets a duration range of +/- 3 years from the stated benchmark. Prior to April 2013, the composite was referred to as the PIMCO National Long Term Municipal Bond Managed Accounts Composite. Valuations are computed and performance is reported in U.S. dollars. Returns are presented gross and net of investment management fees and include the reinvestment of earnings. All accounts in the composite are charged a wrap-fee which is all-inclusive of advisory, trading, custodial and administrative fees. Gross of fees performance results are "pure" gross, do not reflect the deduction of advisory and sponsor fees (including trading and custodial fees) and are provided as supplemental information. The composite consists of 135 account(s) with a market value of **\$122.3 million** as of **06/30/2018**. In this profile, the performance from November 1, 2012 through December 31, 2015, performance consists of all Fiduciary Services (FS) accounts managed by the investment manager in this strategy, subject to any other limitations stated in this profile. From January 1, 2016, performance consists of the performance of all FS accounts (as described in the previous sentence) as well as the performance of all single style Select UMA accounts managed by the investment manager in this strategy, subject to any other limitations stated in this profile. #### **INDEX DESCRIPTIONS**

##### **90-Day T-Bills**

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of discount is the interest earned. T-bills are issued in denominations of \$10,000 auction and \$1,000 increments thereafter.

##### **BC Muni 10 Yr**

The Barclays Municipal Bond Index is a rules-based, market-value-weighted index engineered for the long-term tax-exempt bond market. This index is the 10 Year (8-12) component of the Municipal Bond index.

##### **S&P 500**

The S&P 500 Total Return has been widely regarded as the best single gauge of the large cap U.S. equities market since the index was first published in 1957. The index has over \$5.58 trillion benchmarked, with index assets comprising approximately \$1.31 trillion of this total. The index includes 500 leading companies in leading industries of the U.S. economy, capturing 75% coverage of U.S. equities. This index includes dividend reinvestment.

## GLOSSARY OF TERMS

**Alpha** is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

**American Depository Receipts (ADRs)** are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

**Average Portfolio Beta** is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Beta** is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Bottom-Up Stock Selection** Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

**Capitalization** is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

**Dividend** a portion of a company's profit paid to common and preferred shareholders.

**Downside Risk** is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

**Duration** is a measure of price sensitivity expressed in years.

**High Grade Corporate Bonds** corporate bonds from issuers with credit ratings of AA or AAA.

**Information Ratio** is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

**Investment Grade Bonds** are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

**Price/Book Ratio (P/B)** weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

**Price/Cash Flow Ratio** a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company's operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

**Price/Earnings Ratio (P/E Ratio)** shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

**Price/Sales Ratio** determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

**R2 (R-Squared)/Portfolio Diversification** indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

**Sharpe Ratio** measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

**Standard Deviation** is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

**Top-Down/Economic Analysis** Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

**Tracking Error** represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

**U.S. Treasury Bonds** a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

**Volatility** a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
