PRODUCT OVERVIEW
The Winslow Capital Management, LLC. ("Winslow") Large Cap Growth team believes that investing in quality companies with above-average earnings growth provides the best opportunity for achieving superior portfolio returns over the long term. While above-average growth is a necessity, valuation relative to their estimated earnings or cash flow growth rate is also important in selecting a stock. The strategy invests in companies expected to deliver strong future growth with a high or rising return on invested capital. Historically and based on proprietary modeling, Winslow Capital compiles a portfolio with a weighted three-year forward annual earnings growth rate typically around 18%. Winslow Capital applies a bottom-up approach to stock selection. The portfolio typically owns 55-65 stocks that are broadly diversified by type of growth (consistent growth, quality cyclical growth and newer faster growth), sector and industry, as well as other factors such as earnings per share growth rate, valuation and market capitalization.

## MANAGER'S INVESTMENT PROCESS

- We seek high-quality growth companies which: address growing markets; lead/gain in market share; have identifiable/sustainable competitive advantages; have solid management; have high/rising ROIC; deploy excess cash flow; and demonstrate sound corporate governance.
- Our investment process screens about 1,200 stocks; comprised of the companies in the Russell 1000® Index, companies outside of the index with similar characteristics including ADRs and with market capitalizations typically \$4B+. We quantitatively screen for factors such as revenue, cash flow and earnings growth, earnings consistency, ROIC, earnings revisions, low financial leverage and high FCF rates relative to net income. The output is about 300 companies which possess highly desirable quantitative characteristics.
- Our qualitative assessment within each company's sector/industry leads to models developed on each. This leverages the expertise and depth of our investment team and emphasizes our "No Preferred Habitat" philosophy. The flexibility to invest in companies with a range of growth attributes: Consistent, Quality Cyclical and Newer/Faster Growth, can lead to early recognition of a change in fundamentals.
- This narrows the universe to about 100 companies; those in which we have a positive, differentiated view on fundamentals vs. consensus are considered. We then quantify the magnitude of difference: higher revenues; margin expansion; non-operating expenses; earnings per share conversion to FCF; and capital allocation/share count.
- Decisions involve our CIO and a Sector PM/Analyst discussing the fundamental analysis of a company's business and a valuation judgment of the stock price. We firmly believe this two-party challenge dialogue and process is optimal. The CIO makes the final decision.

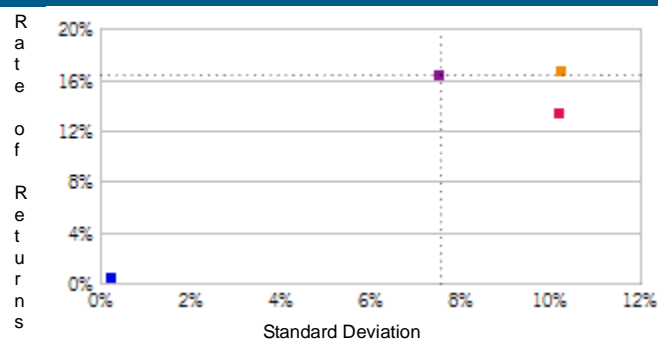

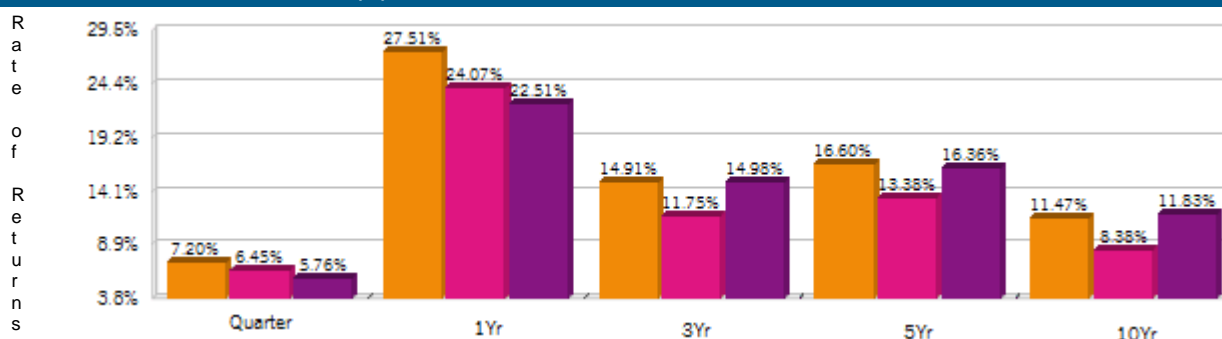

## RISK/RETURN ANALYSIS - 5 YEARS ENDING 06/30/18



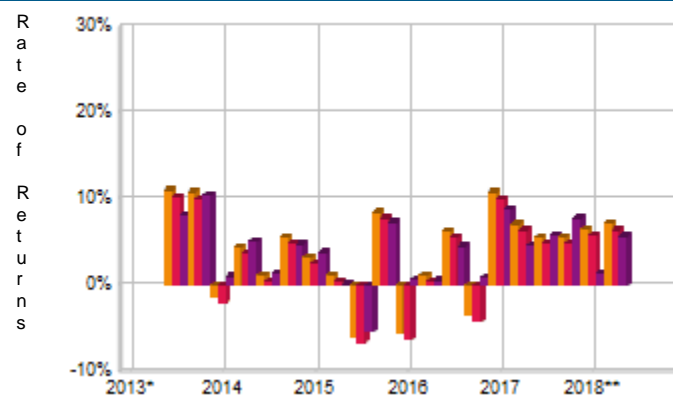

Winslow Capital Management (Winslow) large cap growth equity performance prior to 10/1/2006 represents a composite of all fully discretionary fee-paying institutional large cap growth accounts managed by Winslow. The composite was asset-weighted and consisted of 8 accounts with a market value of \$525.0 million as of 9/30/2006. Performance subsequent to 10/1/2006 represents a composite of all fully discretionary, fee-paying large cap growth equity wrap accounts (not in Morgan Stanley Fiduciary Services program) managed by NYLIM for which Winslow acts as a sub-advisor. The composite was asset-weighted and consisted of 29 with a market value of \$4.2 billion as of 06/30/18.

The composite consists of **340** account(s) with a market value of **\$226.6 million** as of **06/30/2018**. In this profile, the performance from January 1, 2011 through June 30, 2012 consists of accounts managed by the investment manager in this strategy in either the Morgan Stanley or the Smith Barney form of the Fiduciary Services program. ## INDEX DESCRIPTIONS

### 90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of discount is the interest earned. T-bills are issued in denominations of \$10,000 auction and \$1,000 increments thereafter.

### Russell 1000 Gr

The Russell 1000 Growth Index is representative of the U.S. market for large capitalization stocks containing those companies in the Russell 1000 Index with higher price-to-book ratios and higher forecasted growth.

### S&P 500

The S&P 500 Total Return has been widely regarded as the best single gauge of the large cap U.S. equities market since the index was first published in 1957. The index has over \$5.58 trillion benchmarked, with index assets comprising approximately \$1.31 trillion of this total. The index includes 500 leading companies in leading industries of the U.S. economy, capturing 75% coverage of U.S. equities. This index includes dividend reinvestment.

## GLOSSARY OF TERMS

**Alpha** is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

**American Depositary Receipts (ADRs)** are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

**Average Portfolio Beta** is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.



**Beta** is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Bottom-Up Stock Selection** Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

**Capitalization** is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

**Dividend** a portion of a company's profit paid to common and preferred shareholders.

**Downside Risk** is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

**Duration** is a measure of price sensitivity expressed in years.

**High Grade Corporate Bonds** corporate bonds from issuers with credit ratings of AA or AAA.

**Information Ratio** is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

**Investment Grade Bonds** are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

**Price/Book Ratio (P/B)** weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

**Price/Cash Flow Ratio** a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company's operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

**Price/Earnings Ratio (P/E Ratio)** shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

**Price/Sales Ratio** determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

**R2 (R-Squared)/Portfolio Diversification** indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

**Sharpe Ratio** measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

**Standard Deviation** is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

**Top-Down/Economic Analysis** Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

**Tracking Error** represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

**U.S. Treasury Bonds** a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

**Volatility** a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
