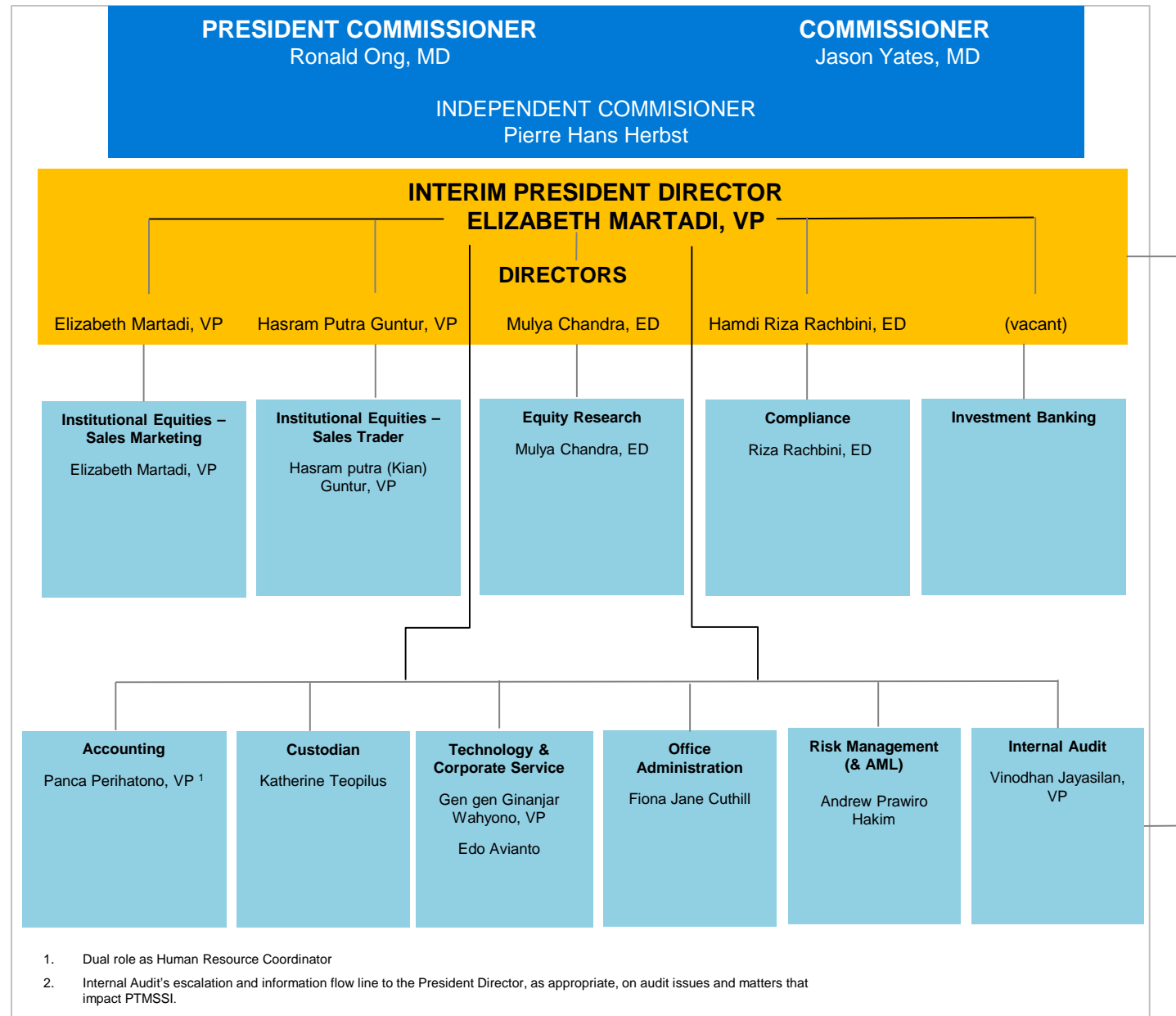


Organizational Structure
