Seeks to track the performance of the Calvert US Large-Cap Core Responsible Index.

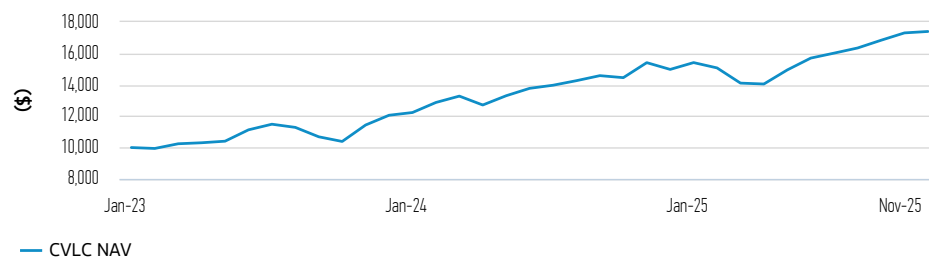

The following companies do not meet the Calvert Principles due to material business risks associated with:

- Meta Platforms Inc:** Large-scale data privacy and security concerns without fundamental reform after incidents
- Berkshire Hathaway:** Lacks a coordinated approach to manage financially material risks associated with energy transition and human capital
- Exxon Mobil Corporation:** Asset impairment and stranding risk through energy transition
- Boeing Company:** Significant concerns related to airplane safety
- United Airlines Holdings:** Multiple controversies involving discrimination, aircraft safety, and business ethics

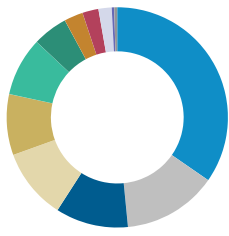

Environmental, social, and governance (ESG) criteria are a set of factors used by investors to evaluate potential investments. DEFINITIONS

Price/book compares a stock's market value to the book value per share of total assets less total liabilities. This number is used to judge whether a stock is undervalued or overvalued. **Price/earnings (LTM)** is the price of a stock divided by its earnings per share for the past 12 months. Sometimes called the multiple, P/E gives investors an idea of how much they are paying for a company's earning power. **SEC yield** is a measure of the income generated by the portfolio's underlying asset over the trailing 30 days, relative to the asset base of the portfolio itself. The **SEC 30-day yield subsidized** reflects current fee waivers in effect. Absent such fee waivers, the yield would have been lower. The **SEC 30-day yield unsubsidized** does not reflect the fee waivers currently in effect. **Weighted average market capitalization** is an average of the market capitalization of stocks held by a portfolio or comprising an index, adjusted by each stock's corresponding weight in the portfolio or index.

RepRisk provides a proprietary, systematic framework to identify and assess corporate ESG risk that includes a score that ranks company controversies (most controversial to least controversial).
