

# Calvert US Large-Cap Core Responsible Index ETF (CVLC)

#### SUSTAINABILITY REPORT 3

The Calvert U.S. Large-Cap Core Responsible Index ETF seeks to track the performance of the Calvert US Large-Cap Core Responsible Index, which is composed of common stocks of large companies selected from the 1,000 largest publicly traded U.S. companies based on market capitalization. The fund offers broad exposure to companies that meet The Calvert Principles for Responsible Investment (Calvert Principles). The Fund uses the Russell 1000 Index as a benchmark.

The Investment Adviser applies the Calvert Principles as primary criteria for including companies in the index. The Calvert Principles serve as a framework for considering environmental, social and governance ("ESG") factors. Under this framework, Calvert seeks to identify companies and other issuers that provide positive leadership in the areas of their operations and overall activities that are material to improving long-term shareholder value and societal outcomes, including ESG areas such as: environmental sustainability and resource efficiency; equitable societies and respect for human rights; and accountable governance and transparency.



#### **ENVIRONMENTAL SUSTAINABILITY**

#### Weighted Average Carbon Intensity (WACI) Scope 1 & 2

Measures a portfolio's exposure to carbon intensity, measured in tonnes of CO2e per million USD in revenue. <sup>1</sup>



#### 27% lower than benchmark

Fund holdings have **30% lower financed carbon emissions intensity**<sup>2</sup> than the benchmark which is equivalent to the carbon emissions of 21,141 miles driven by an average passenger vehicle in the U.S. (equivalent to 4 round trips from NYC to LA).





# **Calvert's Approach to Engagement**


Calvert believes long-term ownership entails a responsibility to participate in improving the governance and socioenvironmental practices of the firms that we hold in our portfol ios. Through our research, we identify engagement targets, seeking to help address financially material issues that matter to clients, the companies we own and society.

The statistics below represent engagements in all products for which Calvert has been granted voting authority.

Engagements are primarily with issuers held in funds or accounts managed by Calvert but may include issuers not currently held in Calvert funds.

# **Calvert's Approach to Proxy Voting**

Calvert's proprietary proxy voting guidelines seek to drive positive change and long-term value creation across the companies held in our investment portfolios. We have generally supported well-crafted shareholder proposals advocating for better management practices and voted against management as necessary to oppose problematic or outdated practices more often than the top 10 asset managers by AUM globally.

#### **Proxy Voting Metrics**

Proxy Voting (Source: Insightia): Derived from quarterly U.S. Securities and Exchange Commission (SEC) NPX filings (SEC-recorded proxy votes), July 2023 - June 2024. Data reflects the percentage of votes that are in favor of a proposed resolution on the subject as categorized by Insightia.

Top 10 Asset Managers by AUM identified based on Morningstar global fund family data as of June 2024. Not all Asset Managers included are necessarily ESG oriented.

Number of Votes Cast and Votes Against Management are pulled directly from Insightia using the SEC's N-PX filings for each investor. Adjustments are made to number of votable proposals including to remove immaterial, non-votable proposals, and to split votes and adjust voting instructions to binary 'for' or 'against' outcomes.

ESG Proposals are exclusively composed of shareholder-filed resolutions and proposal categories provided by Insightia, which include: Energy, Environmental, Sustainability, Animal Welfare, Charitable Donations, Corporate Social Responsibility, Human Rights, Political Activities, Social, and Social and Ethics Committee.

Voting topic breakdowns are more granular groupings of Insightia ESG categories noted above, disaggregated by U.S. vs. non-U.S. meetings (based on company domicile).

Percentage of votes in favor and percentage of votes against are an average of the voting records from Top 10 asset managers and may differ from individual manager voting records.

#### **Engagement Metrics**

#### Coverage

To provide transparency on ESG data availability for a fund's portfolio and its reference benchmark index, a coverage percentage is provided, where applicable. Coverage refers to the percentage of the fund's portfolio or benchmark index for which data is available for a given ESG metric. For example, coverage of 98% means that data for the ESG metric in question is available for approximately 98% of the portfolio or index's corporate holdings.

## **Sustainability Metrics**

The metrics referenced in this report are core to the Calvert Principles for Responsible Investment, a framework utilized by the research analyst to consider financially material sustainable factors in the investment research process.

Sustainability metrics measure each portfolio's exposure to key financially material factors in comparison to a reference benchmark. These metrics are based significantly on data self-reported by companies or derived and/or estimated by data vendors based on their proprietary methodologies. Due to limitations in uniform reporting standards, inconsistent disclosures by companies and variations in data vendors' coverage universes, data coverage will vary, in some cases significantly. All calculations are applied to holdings information as of most recent quarter-end unless otherwise indicated.

Weighted Average Carbon Intensity - Revenue (Source: MSCI): Measures a portfolio's exposure to carbon-intensive industries as expressed by metric tons of carbon emissions (scope 1 and 2) equivalent per million USD in revenue while considering all issuers. It is a Task Force on Climate-Related Financial Disclosures (TCFD)-recommended measure. For each company in the portfolio, carbon emissions are calculated using the company's most recently reported or estimated total scope 1 and scope 2 emissions within the last five years.

**Financed Carbon Emissions Intensity** (Sources: MSCI, Calvert, U.S. EPA, Google Maps) - The financed carbon emissions differential between Calvert strategies and their respective reference benchmarks is metaphorically expressed as the equivalent of carbon emissions from an average passenger vehicle driven in the United States (USA) over a given distance in miles. A portfolio's carbon emissions footprint is the total volume of greenhouse gas emissions associated with the portfolio's holdings, expressed in metric tons. For each company in the portfolio, carbon emissions are calculated using the company's most recently reported or estimated total scope 1 and scope 2 emissions from the last three years. Scope 1 emissions are those from sources controlled or owned by the company. Scope 2 emissions are those caused by the generation of electricity purchased by the company.

Green House Gas Reduction Targets (Source: ISS ESG): This factor differentiates an issuer's targets as "No Target", "Non-Ambitious Target", "Ambitious Target", "Committed Target", or "Approved Target" based on the existence and quality of greenhouse gas emissions reduction targets. The factor considers both science-based targets and other targets set by the issuer. Datapoints "Committed Target" and "Approved Target" come directly from the Science Based Target initiative. Datapoints "Non-Ambitious Target" and "Ambitious", mean the companies are not covered by the Science Based Target initiative and a conclusion is made by ISS. "No Target" means no target has been announced by the company. Approved Target: Denotes issuers that have published specific science-based 1.5°C emissions reduction targets. All issuers with approved targets are disclosed on the SBTi website (www.sciencebasedtargets.org). Committed Target: Denotes issuers that have communicated science-based emissions reductions targets but have not published specific targets yet. Commitments demonstrate an issuer's intention to develop and submit targets for validation within 2 years. Ambitious Target: Denotes issuers with clearly defined emissions reduction targets that are not listed on the SBTi website. It is unclear whether stated targets are aligned with the emission reductions required to limit the global temperature increase to well below 2°C compared to pre-industrial levels. Non-Ambitious Target: Denotes issuers with clearly defined emissions reduction targets that are not listed on the SBTi website. The targets do not seem to be aligned with the emission reductions required to limit the global temperature increase his to well below 2°C compared to pre-industrial levels.

Average Percentage of Female Board Members (Source: FactSet): Expresses the percentage of female corporate board members.

**United Nations Global Compact** (Source: MSCI): This factor indicates whether the company is in compliance with the United Nations Global Compact principles. The possible values are Fail, Watch List, or Pass.

**Overall Controversy Flag** (Source: MSCI): The overall controversy assessment signals whether a company has a notable controversy related to a company's operations and/or products, and the severity of the social or environmental impact of the controversy.
