TAX INFORMATION

U.S. Government income percentages

The portion of dividends paid by your fund that is derived from U.S. Government obligations is generally exempt from state and local income taxes. In many states, income derived from other government agencies is also free from state income taxes. The percentage of 2024 dividends paid by your fund attributable to government and agency obligations is listed on the table. Primary obligations represent direct investments in Treasury securities, while secondary obligations are direct investments in generally qualifying U.S. agency obligations.

Only those funds that have earned income from U.S. Government obligations in 2024 are listed below. If applicable, the percentages below should be applied to the amount shown in Box 1a on your Form 1099-DIV. For specific information regarding your state's exemption provisions, please consult your tax advisor or local taxing authority.
