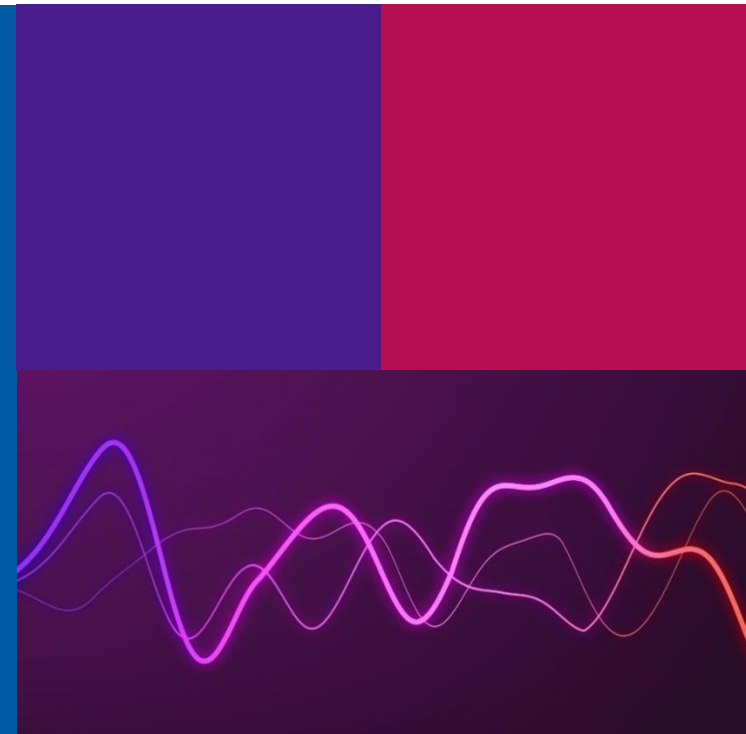

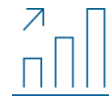
TOP VIEWS: THE BOTTOM LINE

Irrational exuberance? We say no. That's because fundamentals support equity market strength and bond spreads alike. Supporting drivers are resilient macro data (sturdy albeit softer growth, sticky albeit low inflation), fiscal and monetary policy tailwinds, and structural durability of AI productivity gains. We remain cautiously optimistic.



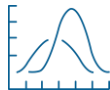
Headwinds (Tariffs) Turning Into Tailwinds (Taxes)

After the passage of the One Big Beautiful Bill Act, taxes paid by corporations on the September 15th tax date fell by \$104Bn, compared to tariff expenses rising \$94Bn, a net positive for issuers that's feeding into earnings.



Rising Productivity

Productivity has risen steadily, and we expect the trend to continue into 2026. Investment in AI tools, equipment, software and automation should accelerate productivity gains in the coming years. This supports higher valuations.



Positive Policy Impulses

The Fed believes it can run the economy hot with low risk of inflation. Combined with government stimulus the markets will be supported on both sides of the monetary/fiscal policy picture.



Widening Profit Margins

Markets are pricing rising growth in earnings with stable costs, which equals wider profit margins, something that may justify higher valuations. A resilient consumer and a Fed focused on supporting the labor market add to a solid backstop.

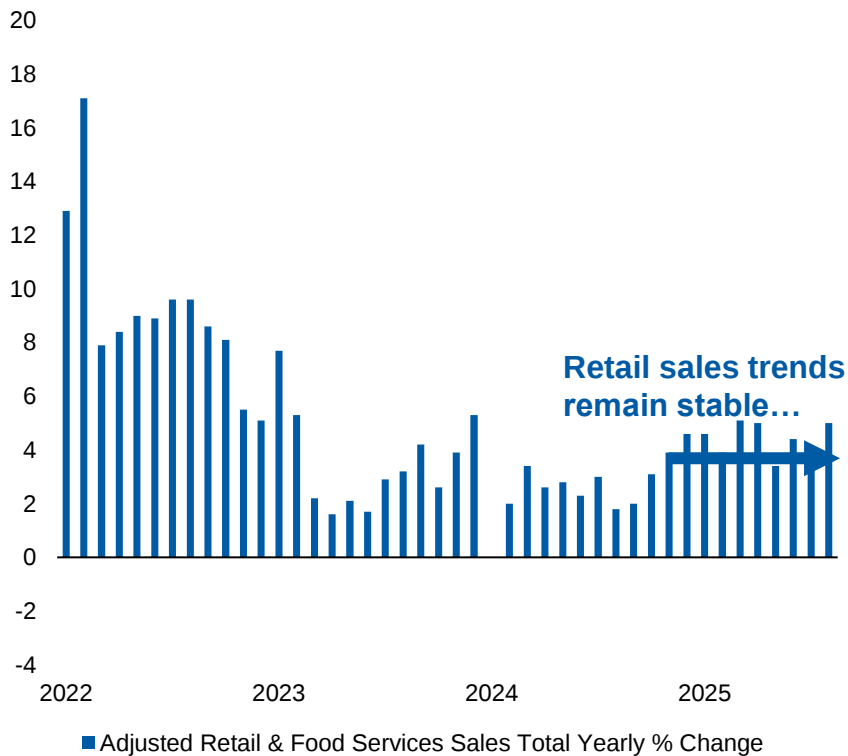

Stable retail sales signal a healthy consumer, reinforcing upward revisions to 2025–2026 GDP forecasts.

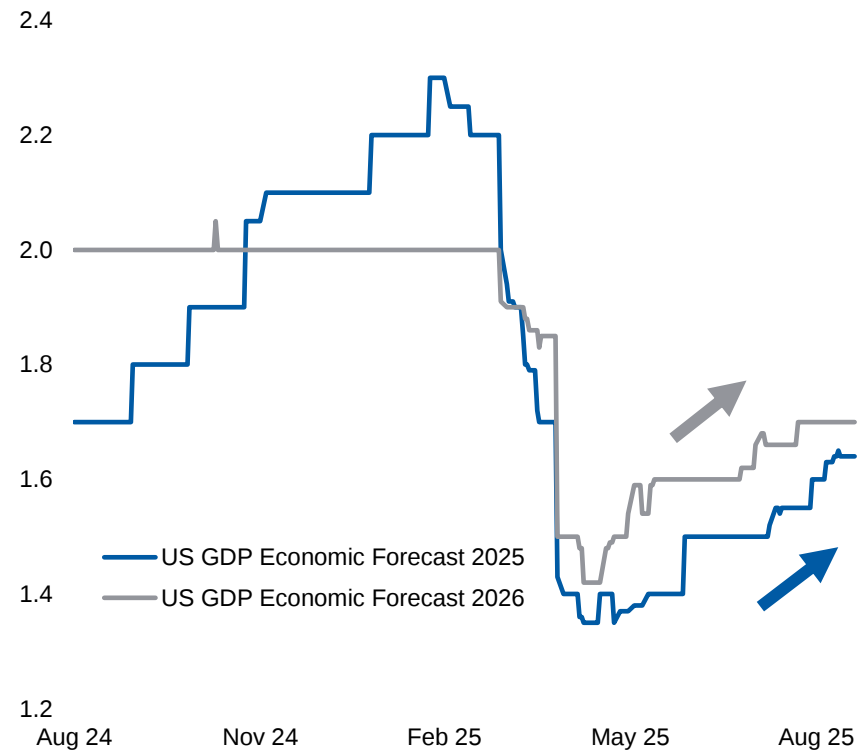
Consumer Spending Remains Resilient ...

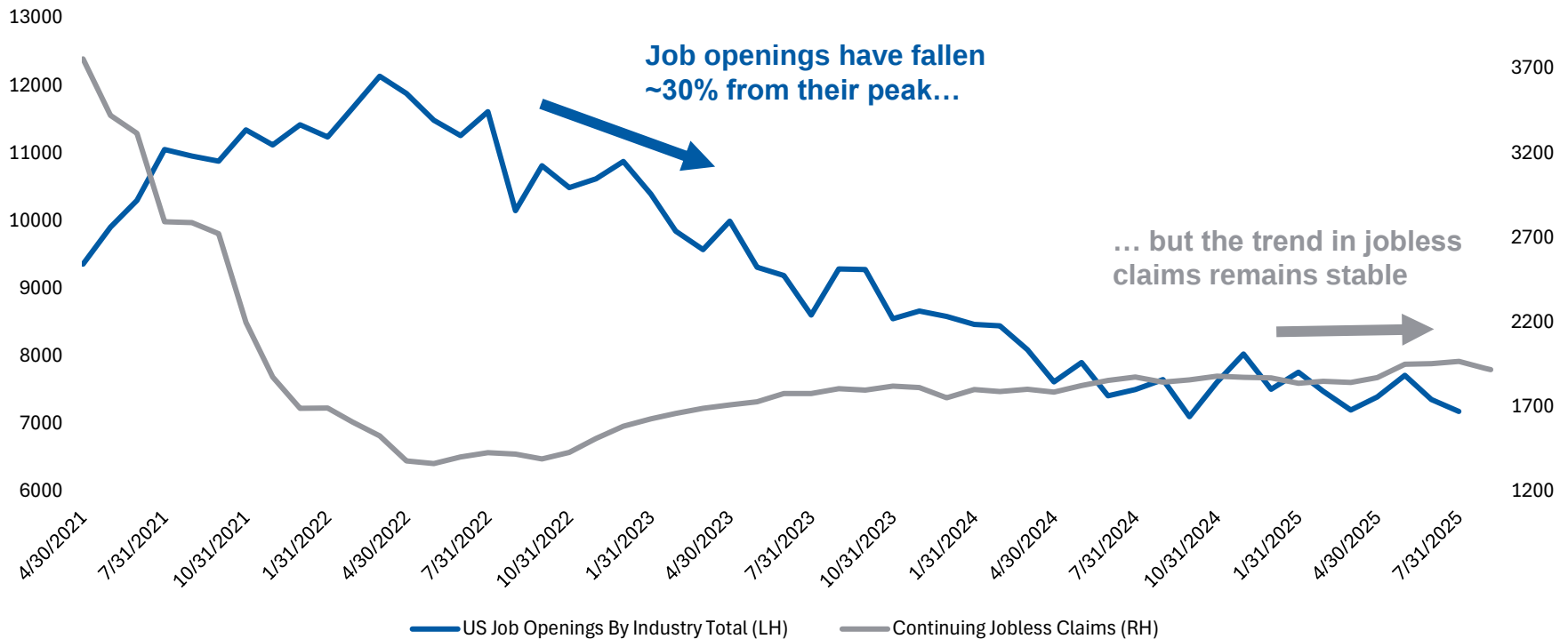

Labor Market Rebalancing: Hiring Slowing, but Layoffs Remain Contained

Job openings have declined from highs, but layoffs have yet to increase meaningfully. This points to a gradual rebalancing in the labor market rather than a sharp downturn.

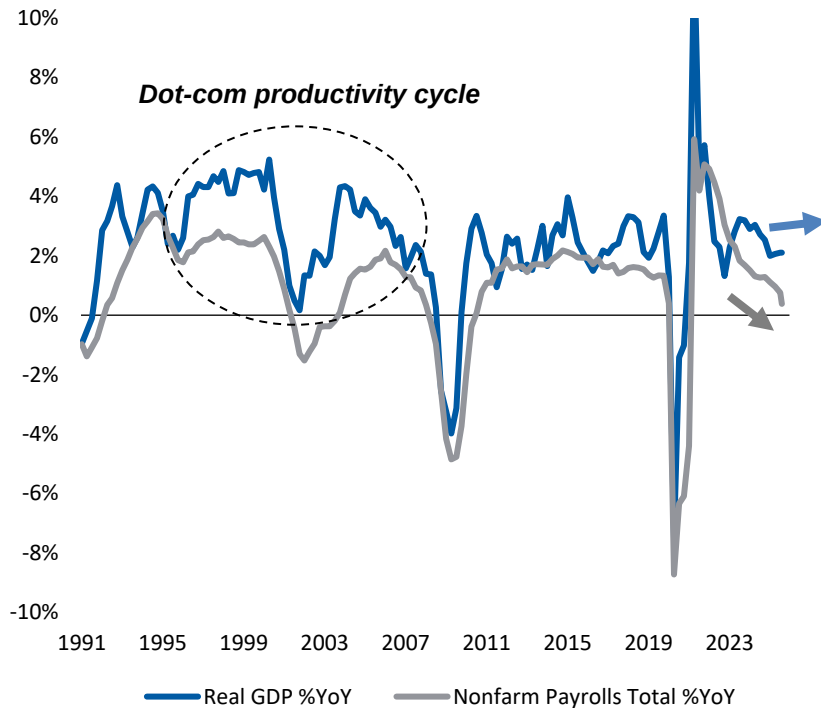

Labor Productivity Remains a Key Growth Driver in the U.S.

Broad economic growth has been outpacing measures of employment growth, signalling a continued growth in labor productivity. Higher productivity increases potential growth, which can support higher profit margins and valuation multiples.

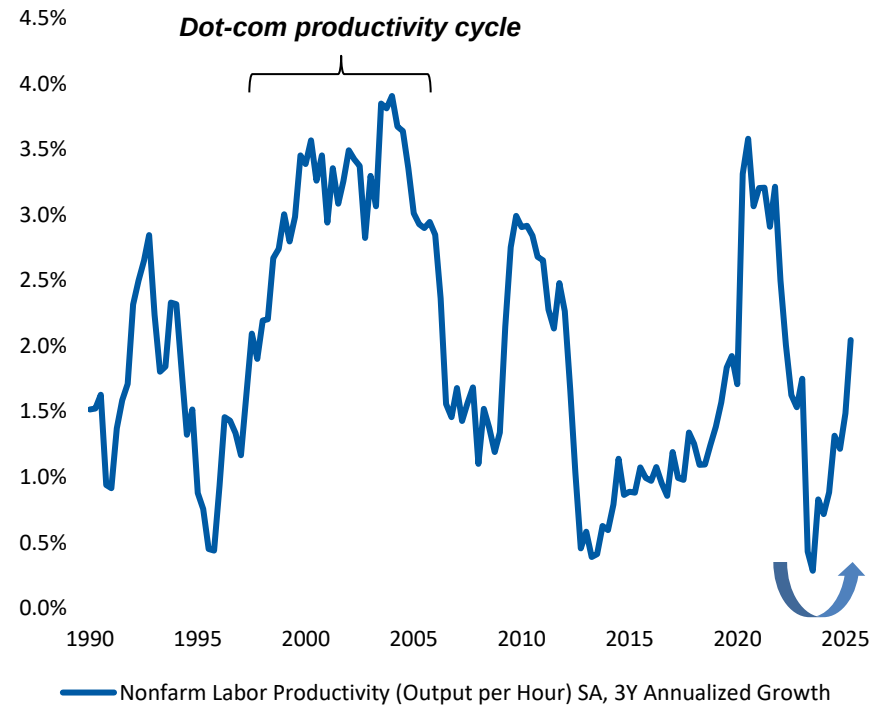
Economic Growth Is Outpacing Employment Growth ...

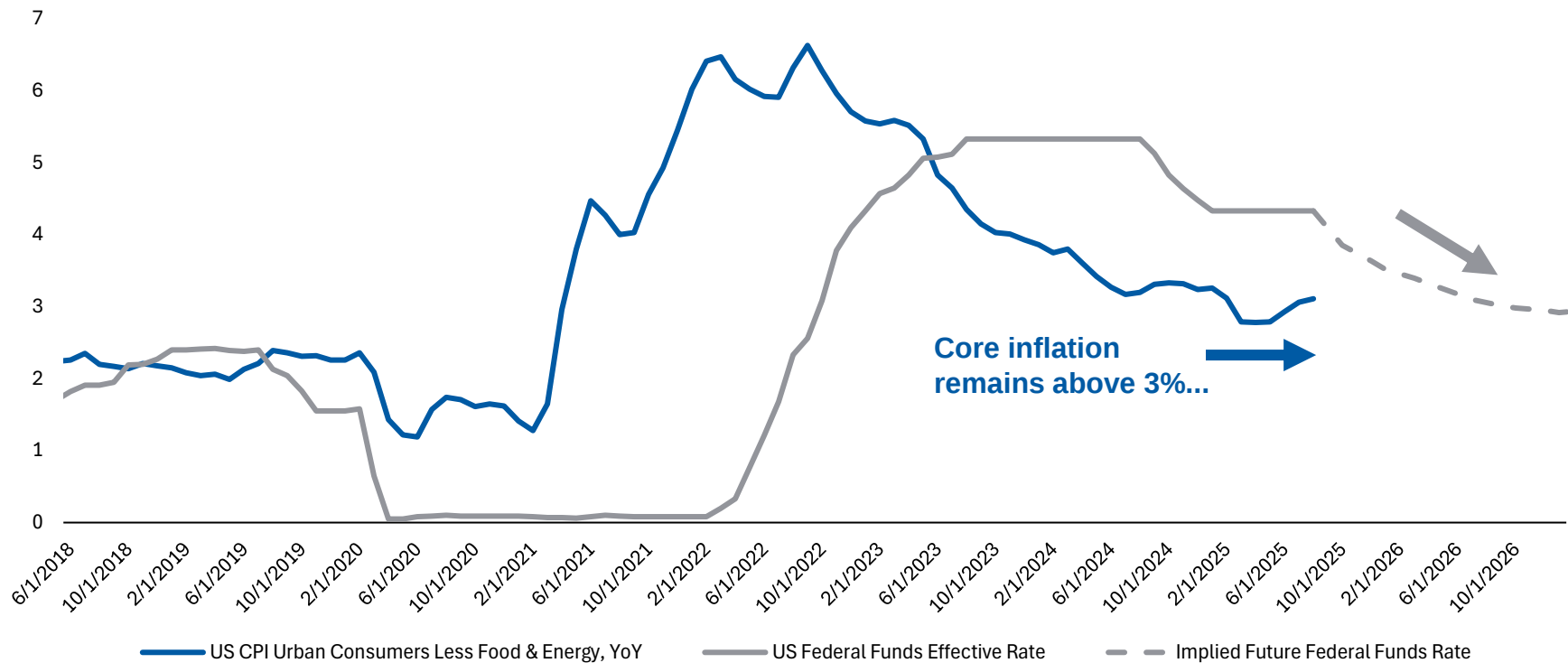

Markets Expect Several Rate Cuts, While Inflation/Growth Suggest Fewer

Consensus expects the Fed funds rate to finish 2026 at ~3% (4-5 additional cuts), but sticky inflation and stronger growth trends suggest expectations may be too aggressive.

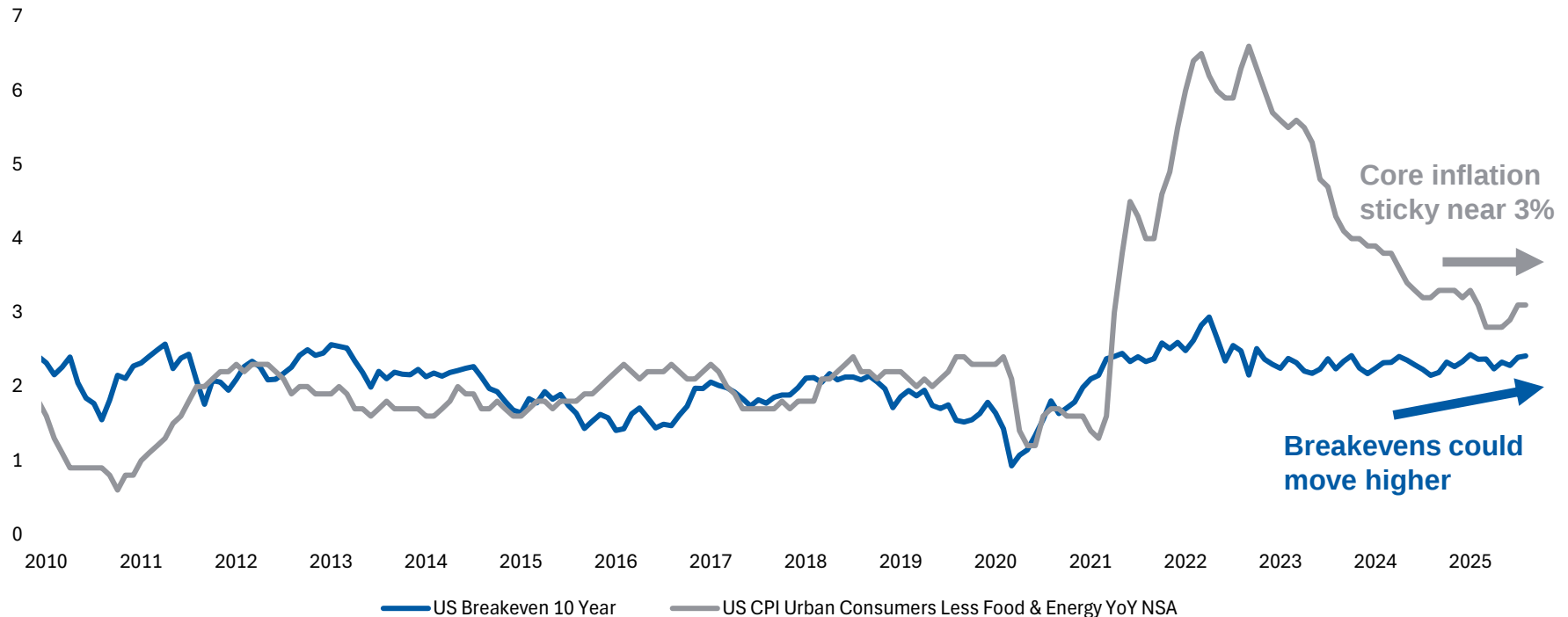

Overweight TIPS: Markets May Be Underappreciating Inflation Risks

10-year breakevens imply core inflation is returning closer to 2%, while current levels remain closer to 3%. With growth potentially reaccelerating in 2026, upside inflation risks may be underappreciated.

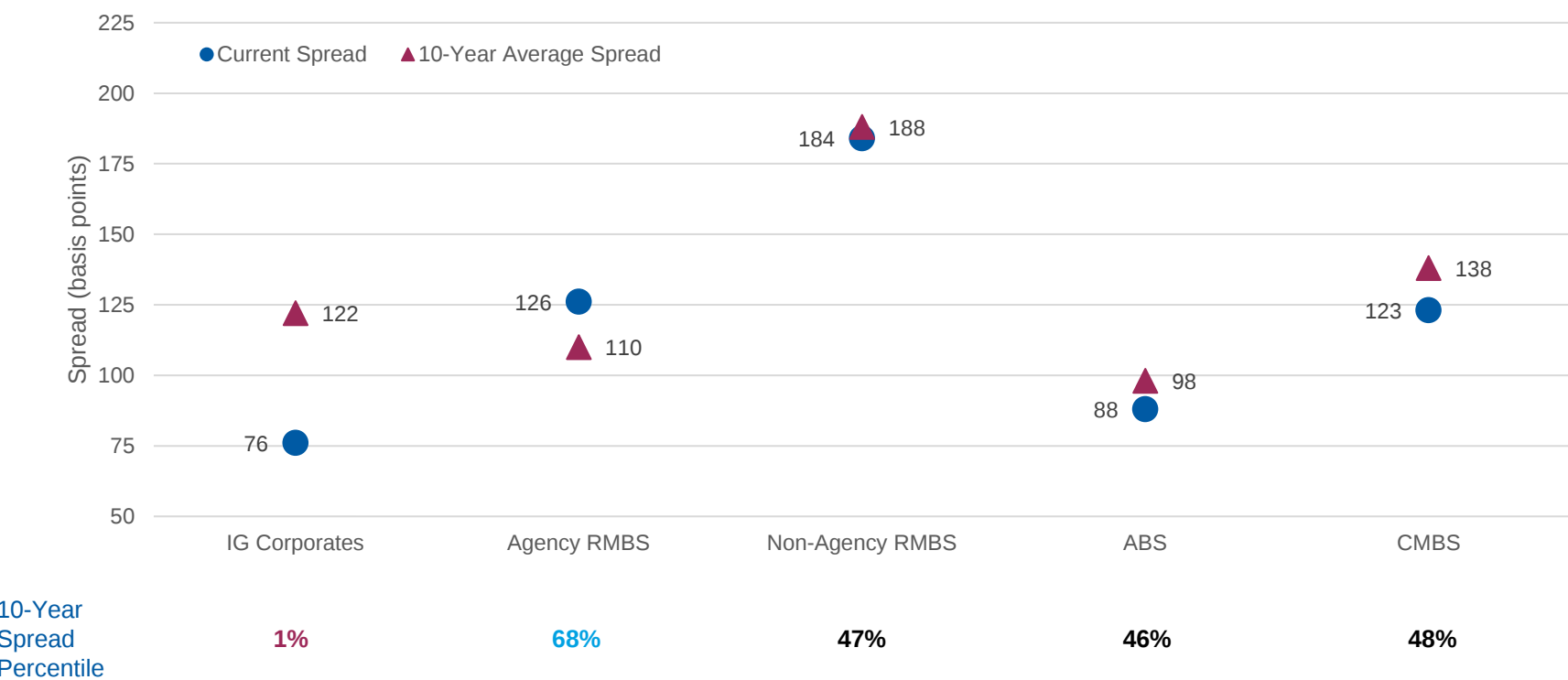

As of September 30, 2025



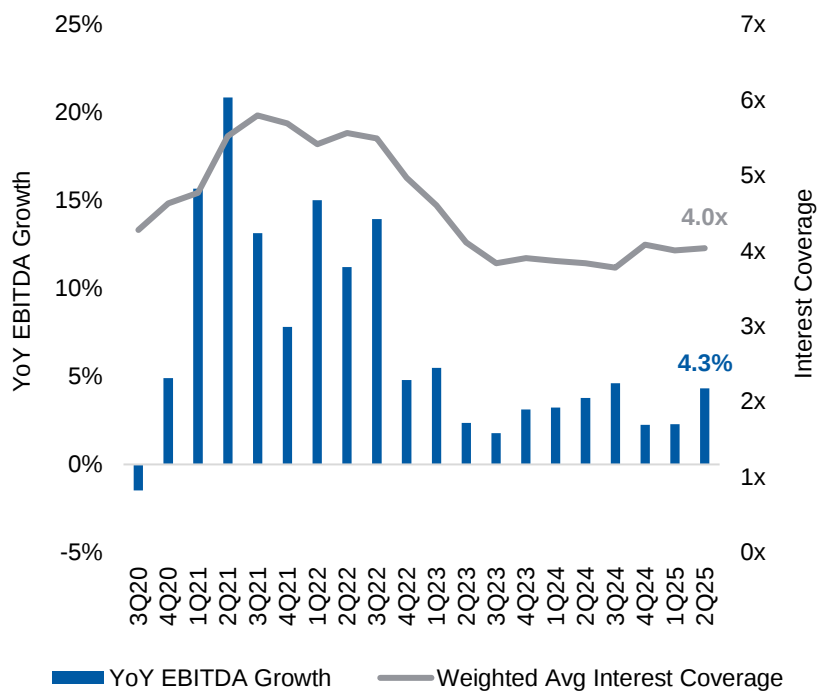

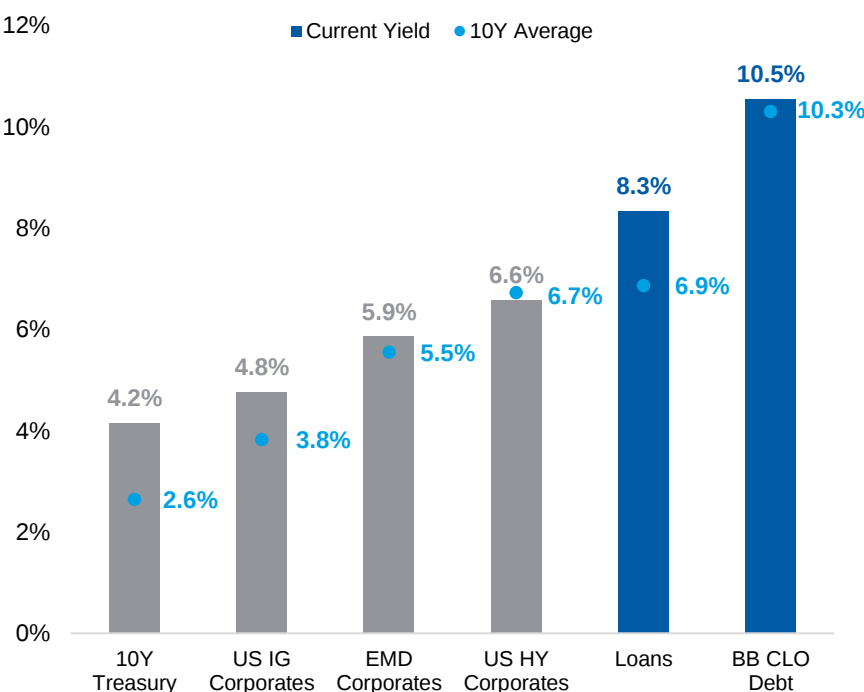
Floating-Rate Loans Continue to Show Resilience

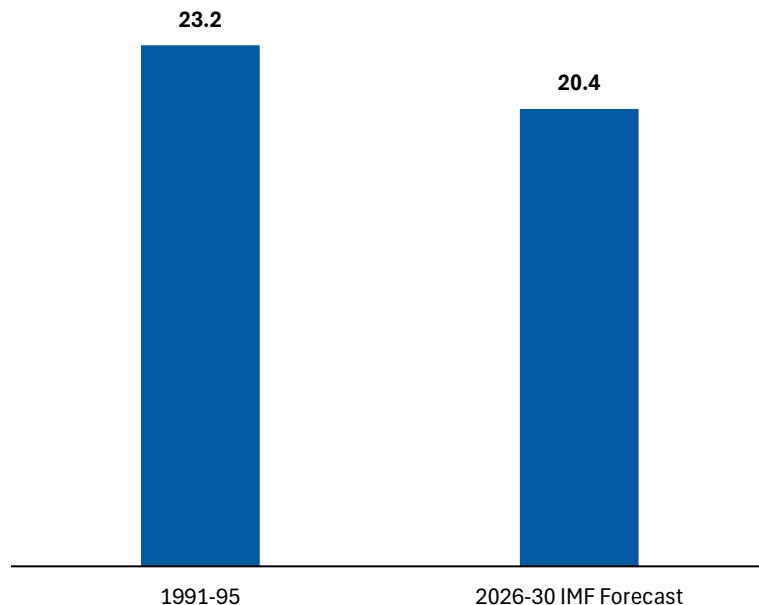

Despite inflation falling towards target, we think long-end yields in the Eurozone could continue to rise, as Germany's fiscal spending exerts steepening pressure on yield curves.

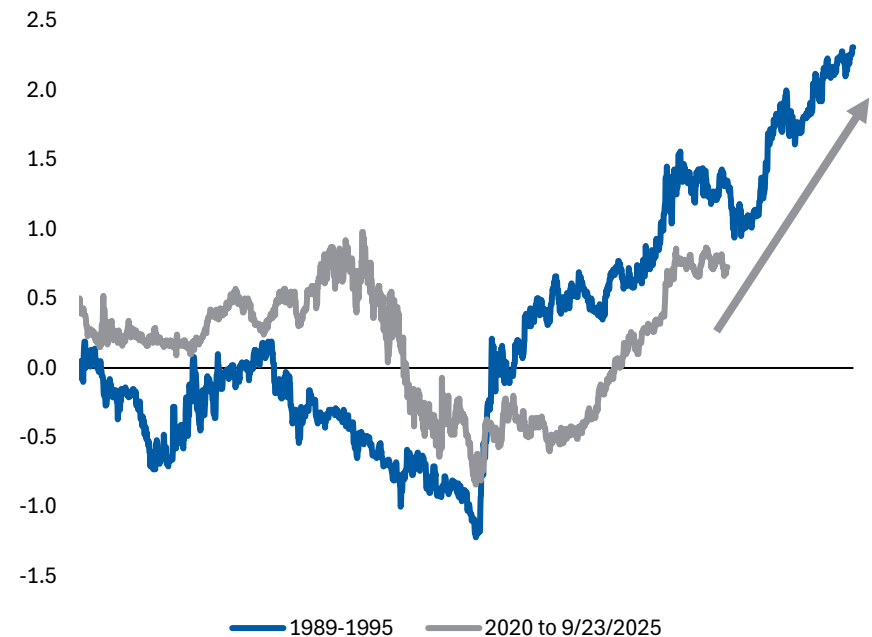
Germany's Fiscal Expansion Mirrors the Post-Reunification Spending Boom

German bund 2-10 year curve slope



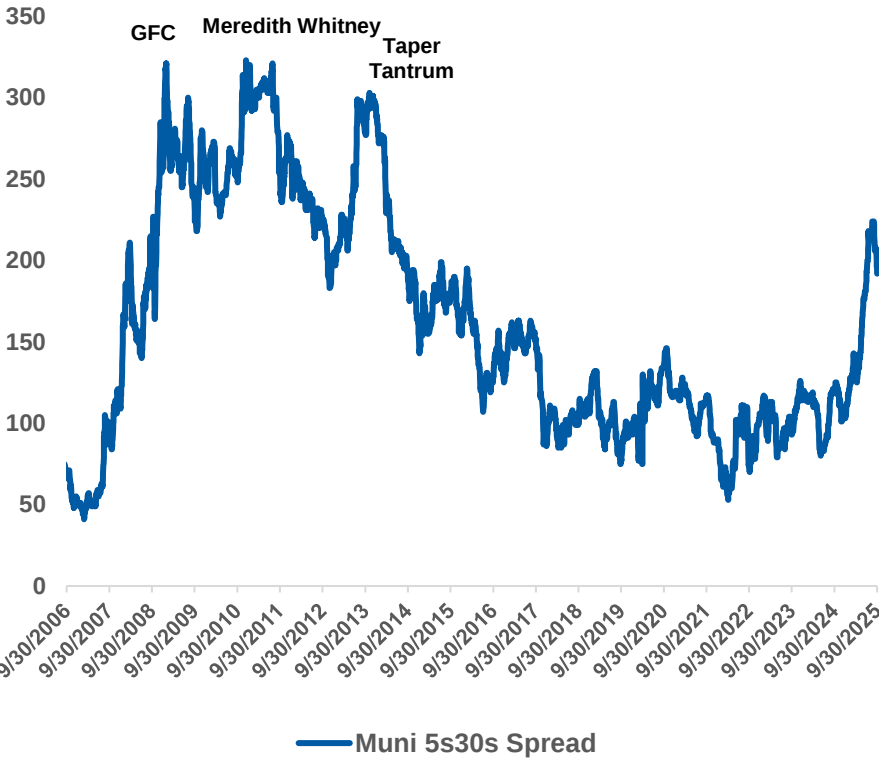

Municipal Bonds: Steep n Cheap

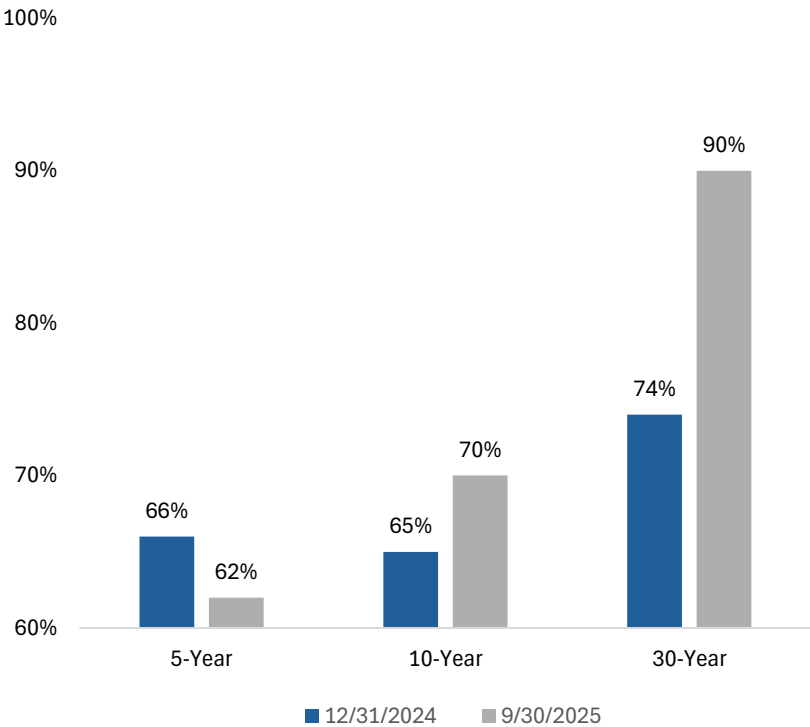
Even with the much-needed rally in September, the curve remains steep, and, in our view, longer-duration municipals are cheap as we enter the 4th quarter

Muni/Treasury Ratios as of 12/31/24 and 9/30/2025



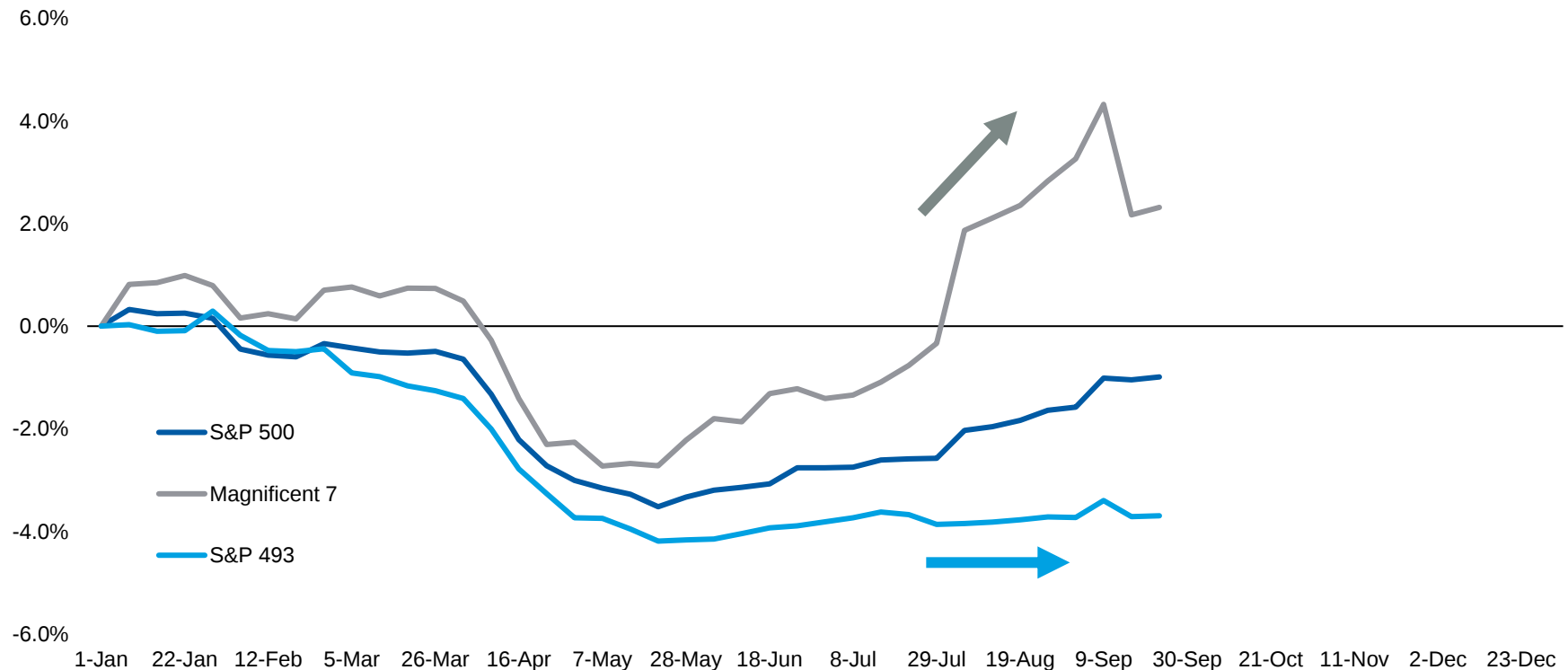

The Mag-7 Continues To Drive Positive Revisions in U.S.

Despite expectations for a broadening in U.S. equity market performance, the Mag-7* remains the primary driver of positive EPS revisions. Meanwhile, expectations for the S&P 493 (ex. Mag-7) have not yet recovered following April's downgrades.

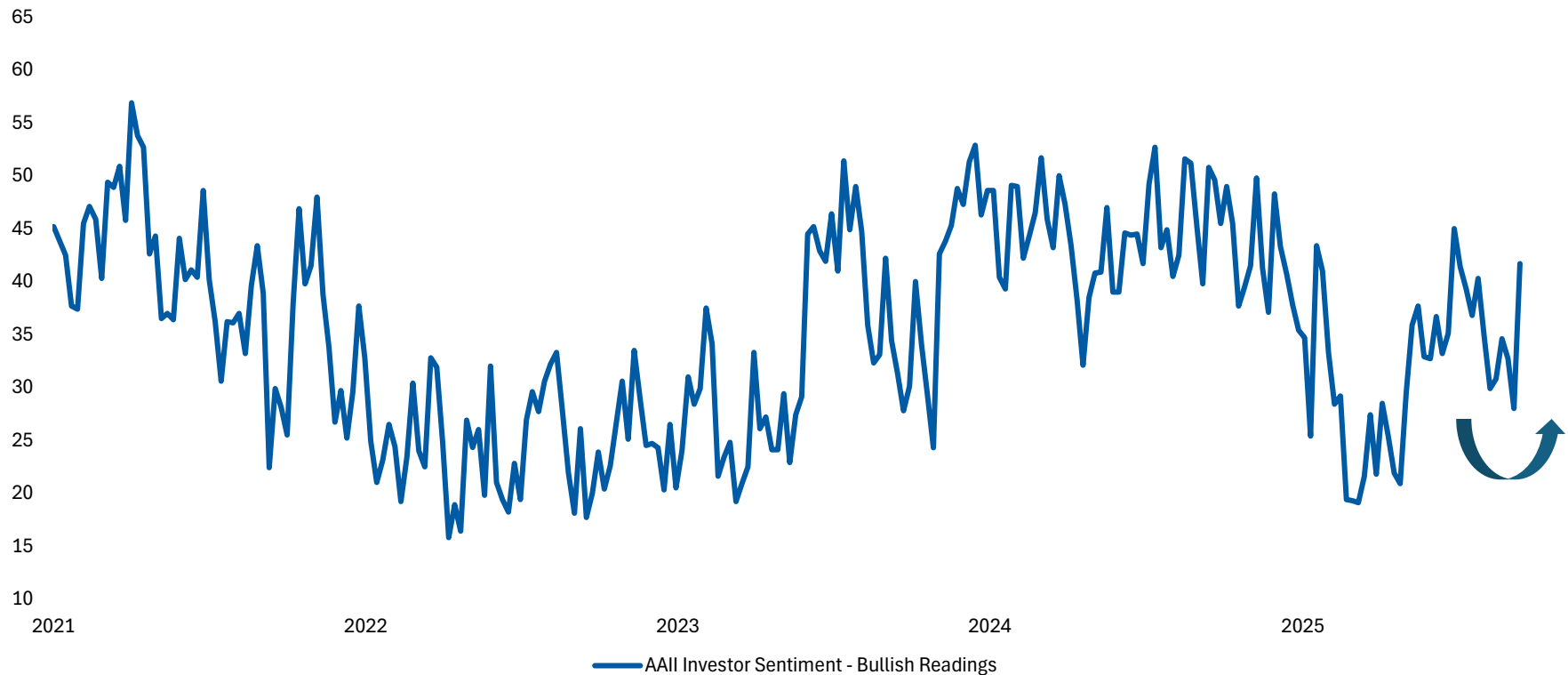

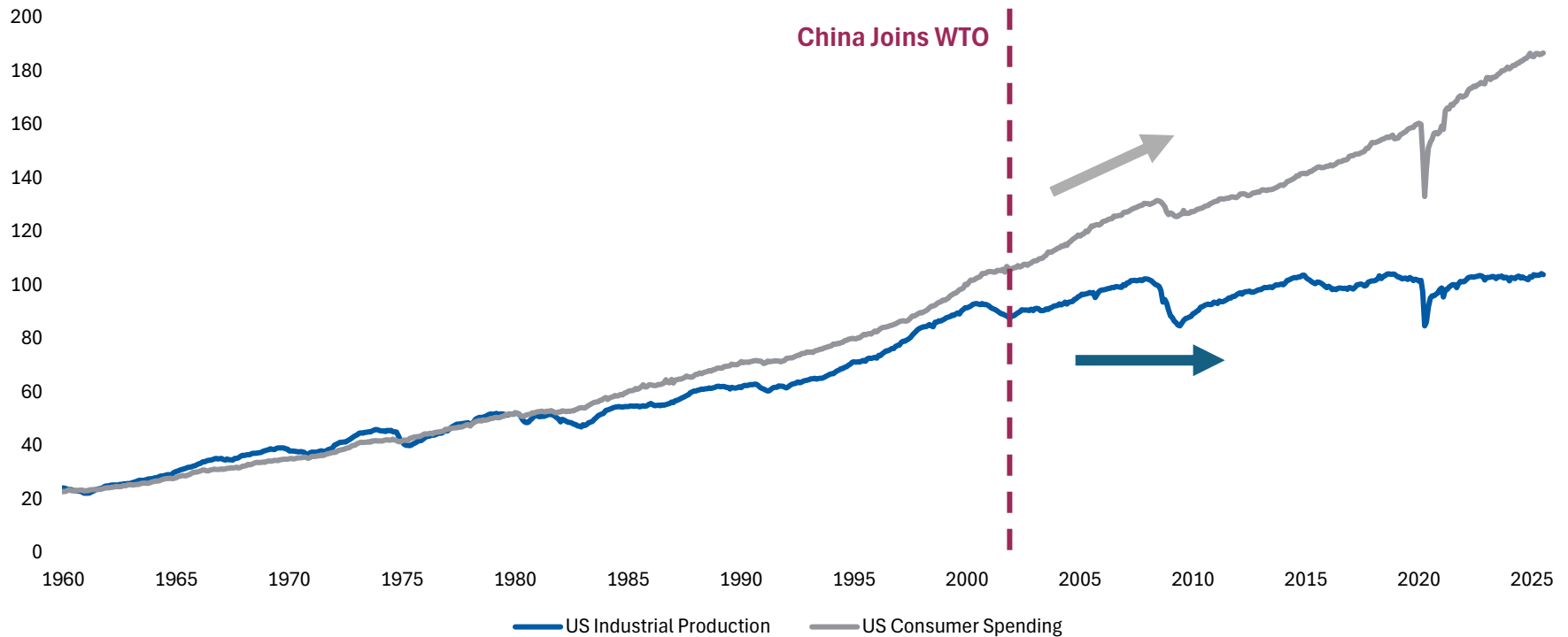

Overweight U.S. Industrial Policy Beneficiaries

Since China joined the World Trade Organization (WTO), U.S. industrial production growth has flatlined in favor of consumption. The administration's industrial policy push, namely the OBBBA, tariffs and deregulation, aims to reverse these dynamics.

U.S. industrial production vs. U.S. consumer spending (real, indexed)



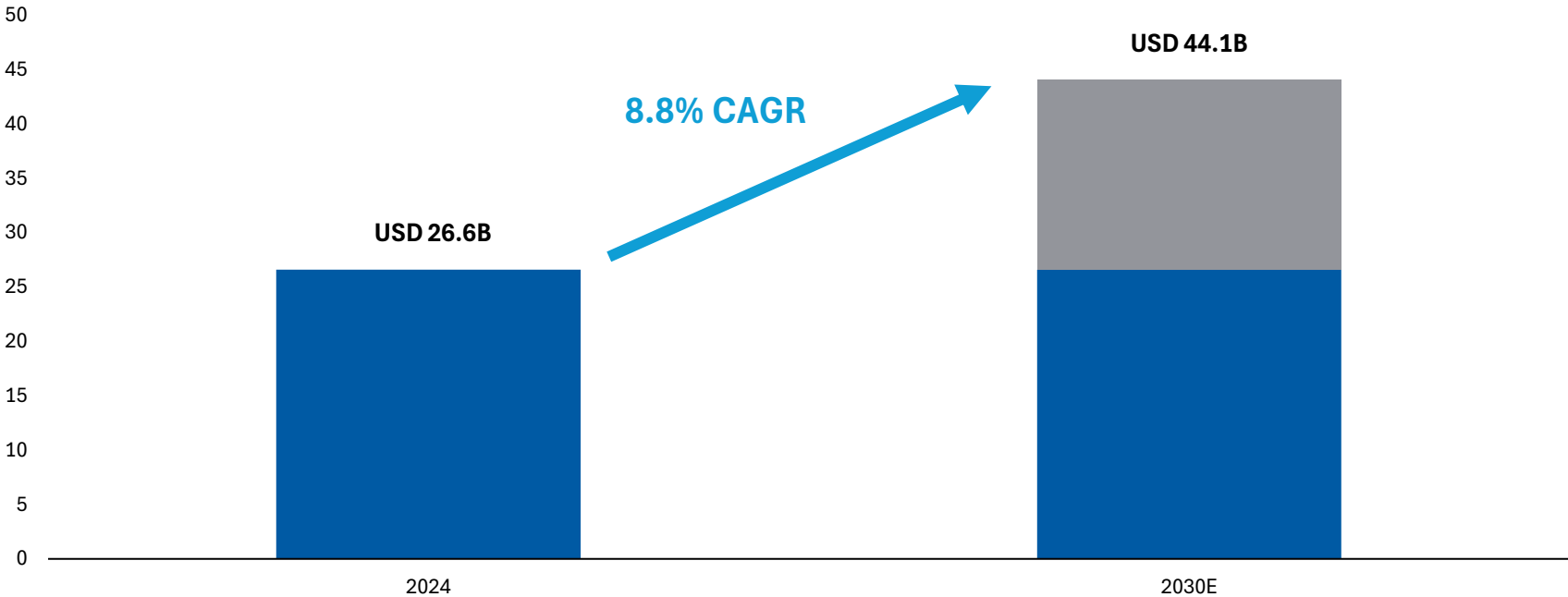

Overweight AI Adopters: Defense

The global defense industry appears well positioned to benefit from the adoption and usage of AI, with much of the increase in global defense spending projected to flow to these new technologies. According to several forecasts, the market size of AI in the defense industry is expected to nearly double by 2030.

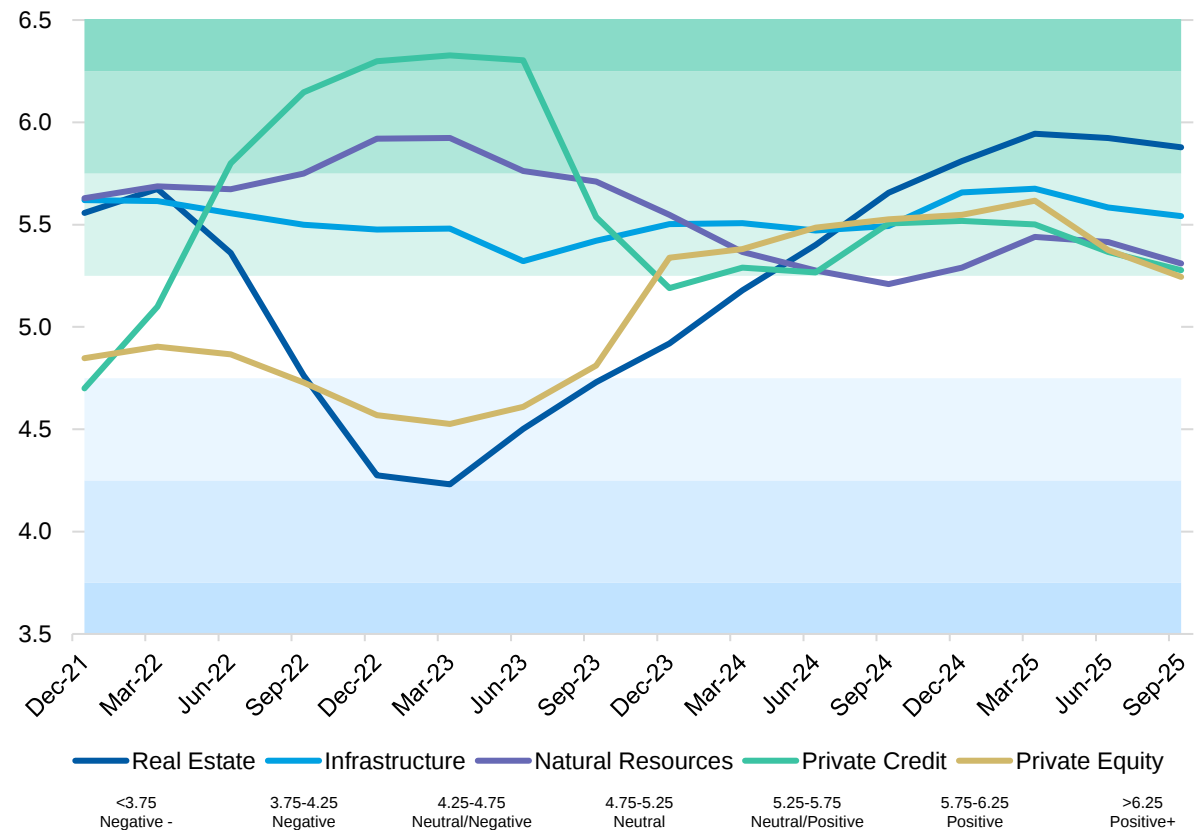
Private Markets: Quarterly Assessment of Segment Attractiveness

Private Markets Views:

- **Real Estate (Positive):**
New developments supply decreasing, coupled with attractive valuations, provide attractive entry.
- **Infrastructure (Neutral/Positive):**
Generational tailwinds in demand for energy and digital, but elevated valuations requires selectivity.
- **Natural Resources (Neutral/Positive):**
Population growth and decreasing arable land provide long-term tailwinds.
- **Private Credit (Neutral/Positive):**
Focused on pockets of value in specialist strategies as direct lending faces some challenges.
- **Private Equity (Neutral):**
Still constructive on buyouts, neutral on growth and venture capital.

Representative Allocations From the Portfolio Solutions Group

ASSET ALLOCATION	COMMENTARY

Duration	DURATION (U/W): We remain U/W duration. We continue to believe the market is too negative about the U.S. economic outlook, even as recent trends surprise to the upside. As such, we think it is unlikely that the UST 10-year yield falls materially below 4% and stays there for any length of time. We see two to three additional Fed cuts (vs. expectations of 4-5) but ultimately expect stronger growth and sticky inflation to limit cuts beyond that.
Credit	CREDIT (U/W): Corporate credit spreads remain near all-time tights, while defaults remain somewhat elevated by comparison. As such, we continue to view the risk/reward asymmetry within credit as unfavorable.
Equities	
Risk Level	EQUITIES (Neutral): We continue to hold a view of balanced risks for global equities. The back half of this year is likely to represent peak tariff headwinds, yet 3Q25 growth to date is surprising to the upside. Regionally, we remain overweight the U.S., where we see stable growth and continued scope for positive trends in earnings revisions.
Alternatives	
Commodities	COMMODITIES (Neutral): We remain neutral on energy commodity markets, as geopolitical upside risks are balanced by high spare capacity in markets such as crude, which limit upside absent physical disruptions. In the current environment we continue to see precious metals as a segment that could enjoy structural tailwinds.

EM Hard Currency Govt. Bonds	EM Hard Currency (O/W): We remain overweight EMD despite spreads being near all-time tights. Default prospects appear lower than in corporate credit while quality-adjusted spreads remain higher.
EM Local Currency Govt. Bonds	EM Local Currency (Neutral): EM Local continues to perform very well in USD, but has not been great in other currencies, such as EUR. This supports our view that EM Local rates and currencies are fairly valued, but a view on the base currency may be more impactful for near-term returns.

Municipal Bonds	Municipal Bonds (Neutral): Muni/UST ratios at the long-end of the curve have tightened significantly in September. We still like the asset class for taxable investors, but would opt for a neutral stance at current levels.
Investment Grade (IG)	Investment Grade (U/W): With spreads near all-time tights, IG has poor convexity in the current environment.
MBS/ABS	MBS/ABS (O/W): Asset-backed securities remain our highest conviction fixed income overweight. Yield per unit of credit quality remains attractive, and the asset class continues to benefit from structural tailwinds.
High Yield (HY)	High Yield (Neutral): We remain U/W HY in the U.S. and O/W in Europe. European HY continues to offer a more attractive spread relative to U.S. HY in both absolute terms and adjusted for ratings differentials. We expect higher yields (owing to FX carry) and lower defaults to drive outperformance of European HY.
Bank Loans	Bank Loans (O/W): With economic growth prospects for 2026 looking robust, we see value in owning bank loans given the high carry associated with the asset class. Additionally, we believe loans should benefit from a repricing in the front-end of the curve, which we feel is too aggressively pricing in rate cuts based on this outlook.

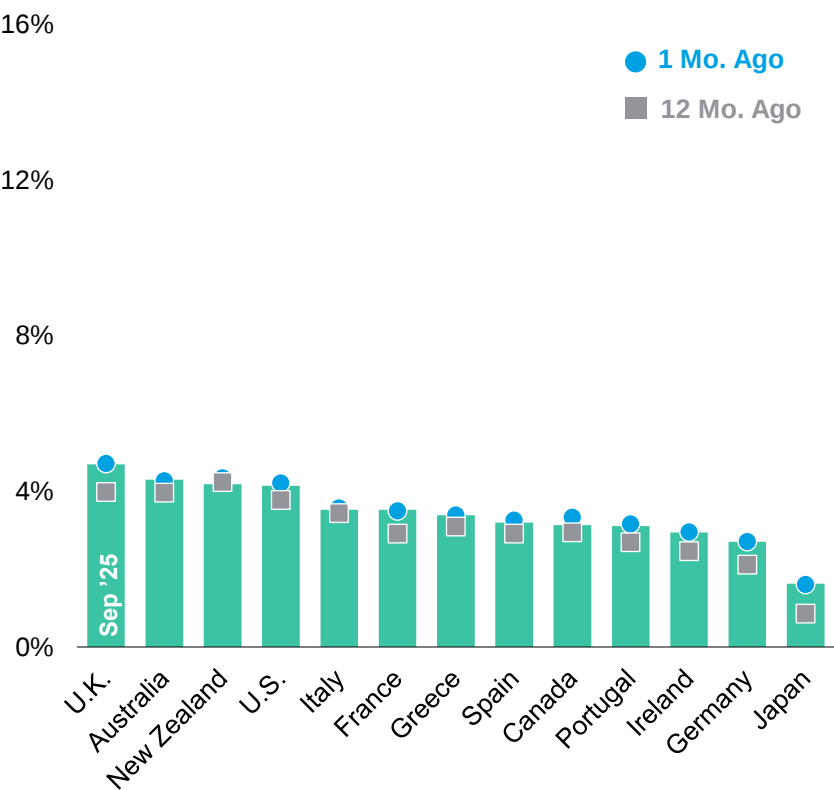

U.S.	United States (O/W): We remain O/W U.S. equities as economic growth continues to surprise to the upside amid broad expectations for tariff-induced weakness. In addition to our core U.S. exposure, we added targeted exposure to select industrial and construction companies given the coordinated efforts across trade, fiscal and deregulation policy to support U.S. industrial production.
Eurozone	Europe (Neutral): We continue to hold a positive view on structural trends in Europe, but earnings revisions at the broad index level continue to lag other regions. As such, we opt for a more targeted approach to compose our exposure and retain our O/W to European banks and German mid-caps.
Japan	Japan (Neutral): The near-term earnings outlook has improved, supported by the removal of U.S. tariff concerns, expectations of fiscal expansion under the next administration and gradual Bank of Japan policy normalization. We remain neutral here, favoring a selective approach to avoid structurally challenged sectors.
Emerging Markets	Emerging Markets (Neutral): EM is supported by resilient U.S. growth, a weaker USD and a more benign tariff outcome. In China, equity risk premiums remain compressed with the extended US-China trade truce, while Asia's tech supply chain continues to benefit from the global AI theme. By contrast, India has faced domestic growth setbacks, AI-related headwinds and strained U.S. relations.

Growth vs. Value	Growth vs. Value (Neutral): Since mid-2022 the Growth vs. Value trade has been dictated primarily by high-beta tech exposure with Growth-style indexes outperforming Value as markets rise and underperforming as they fall. In this context, a broadly neutral view on equities suggests a neutral view on Growth vs. Value.
Quality	Quality (O/W): We retain a preference for Quality as growth decelerates relative to the last three years.
Large Cap vs. Small Cap	Large Cap (O/W): We remain overweight Large Caps in the U.S., as the cohort continues to show stronger earnings revisions trends relative to Small and Mid caps (SMID). In Europe, we continue to hold mid-cap exposure in Germany given the structural tailwinds linked to the fiscal stimulus wave.
Cyclical vs. Defensive Sectors	Cyclicals (O/W): Our cyclical exposure in the U.S. and Europe rests on structural growth drivers from policy efforts.

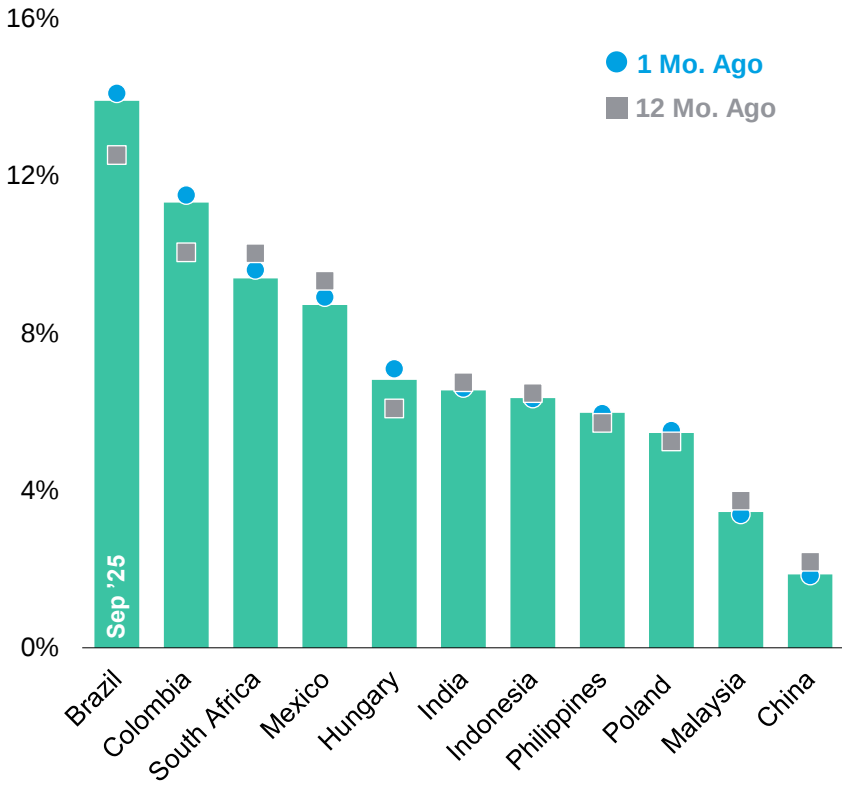

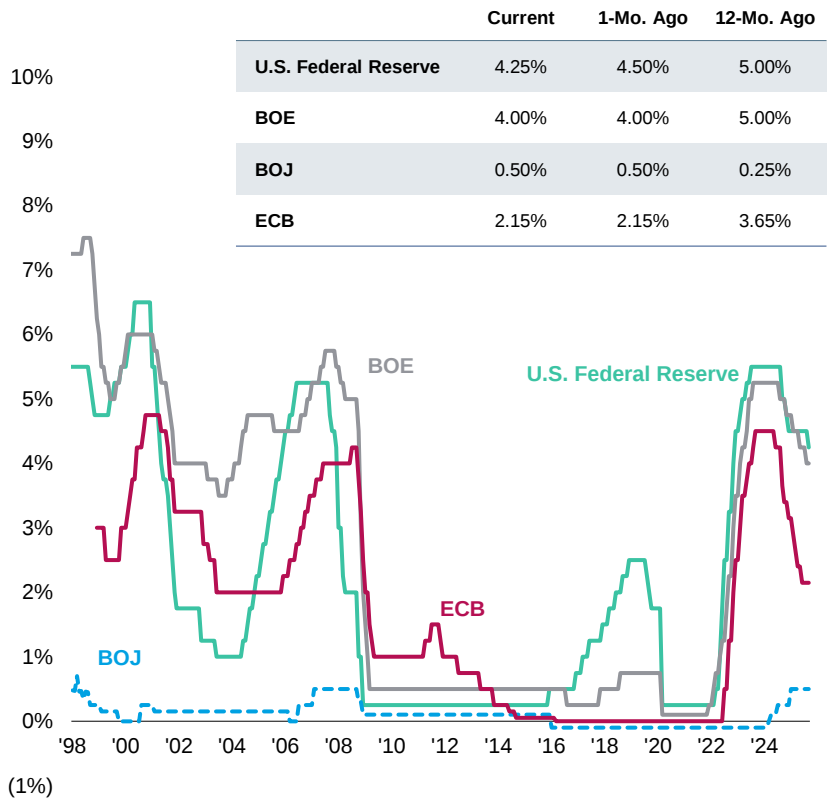

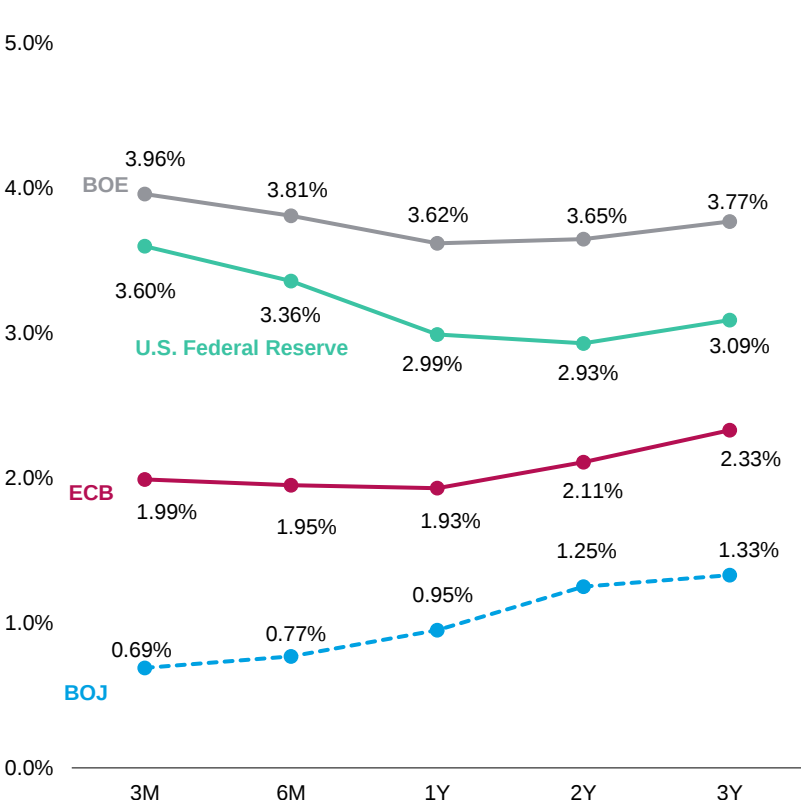

Market Expectations for Future Central Bank Rates

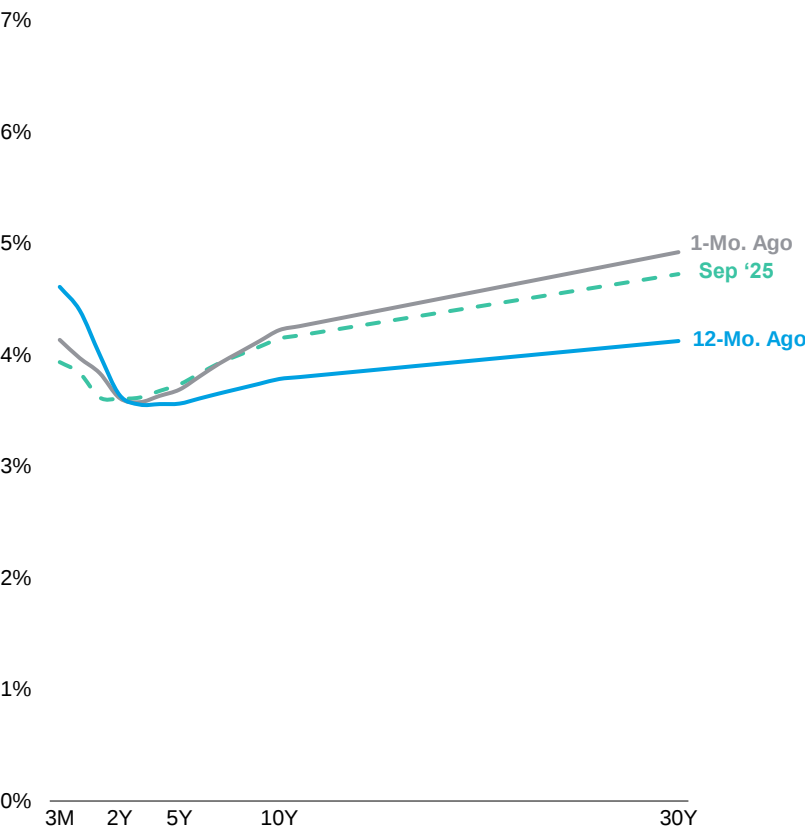

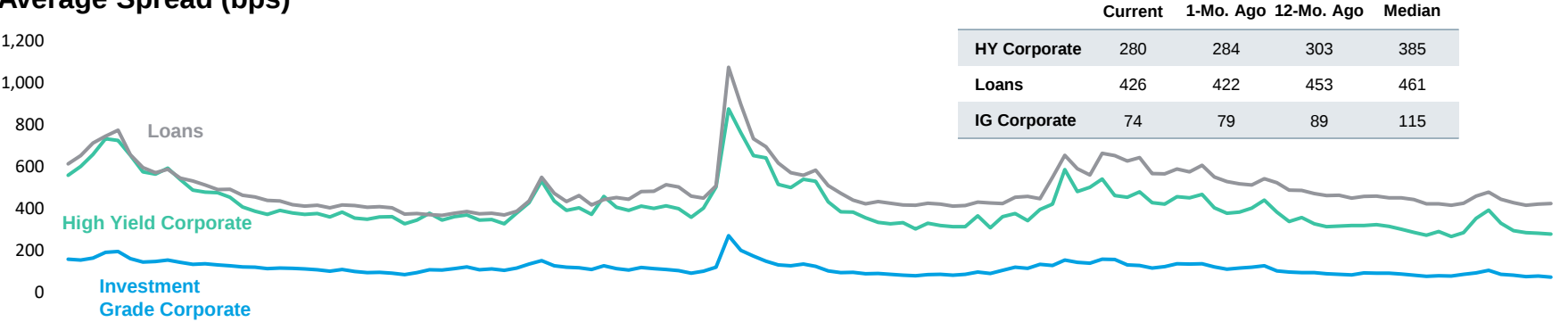

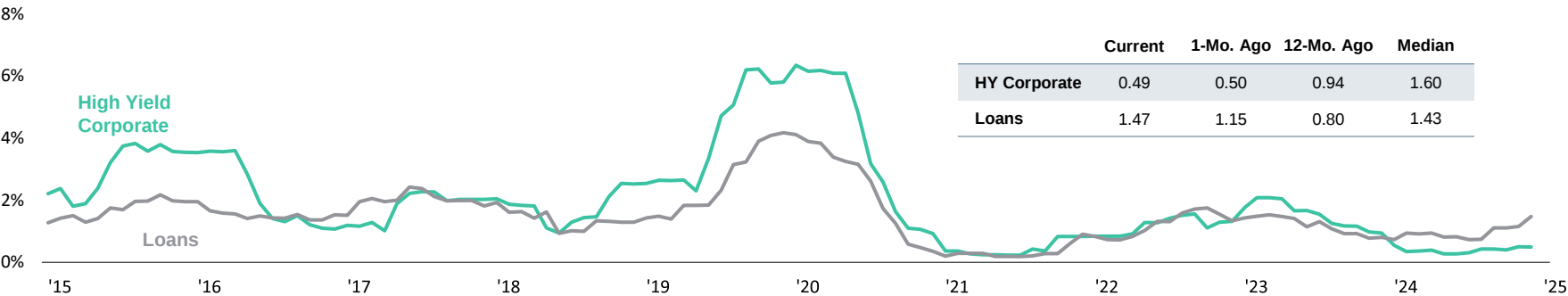

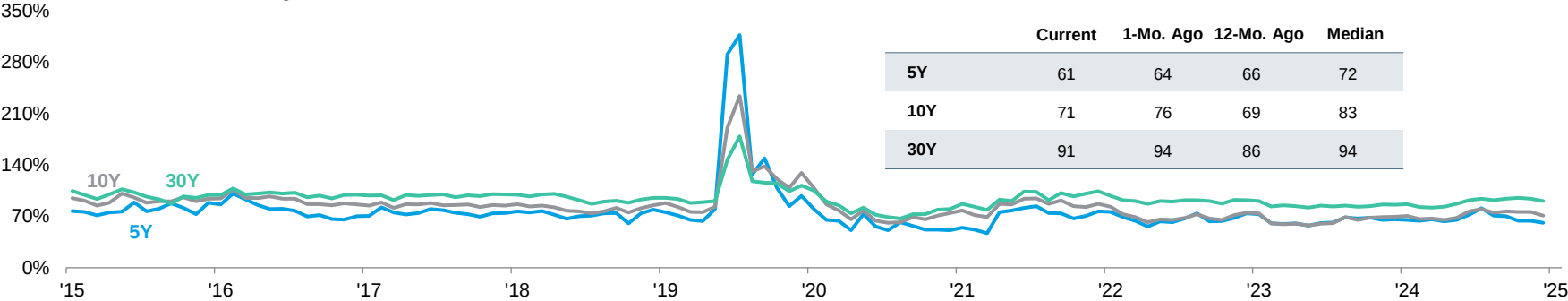

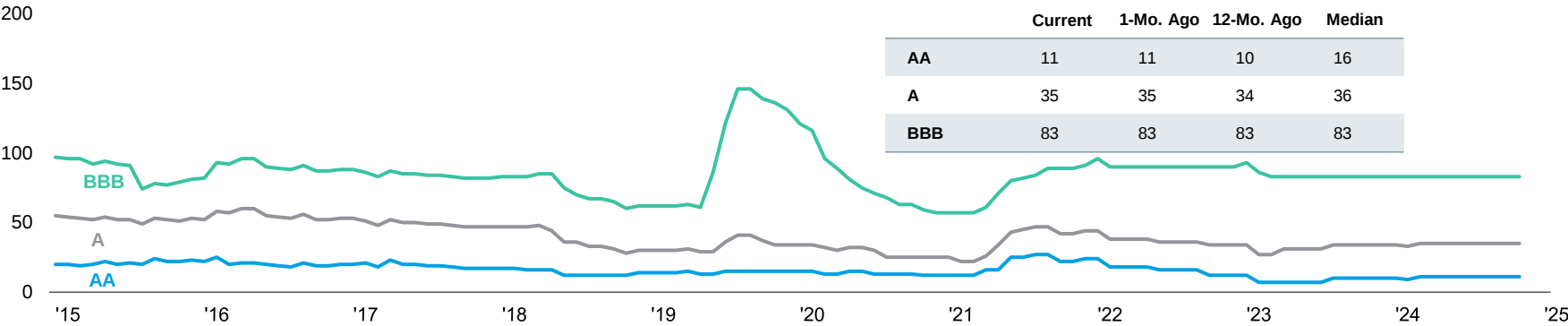

Credit Quality Spreads vs. AAA (bps)

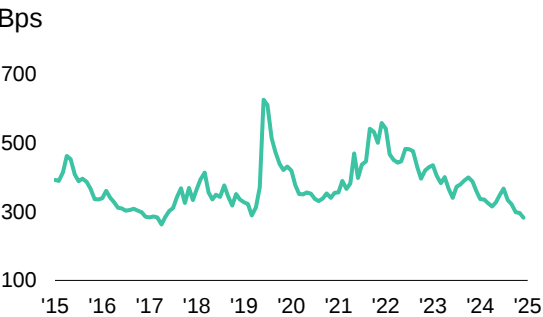

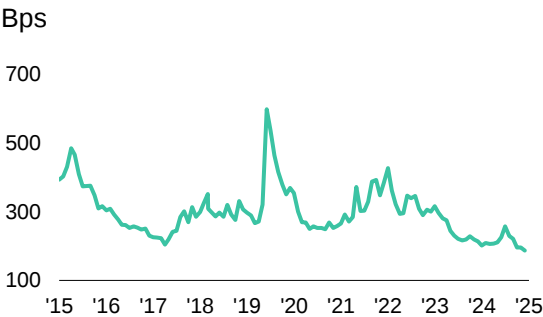

Sovereign EMD Spreads (USD)



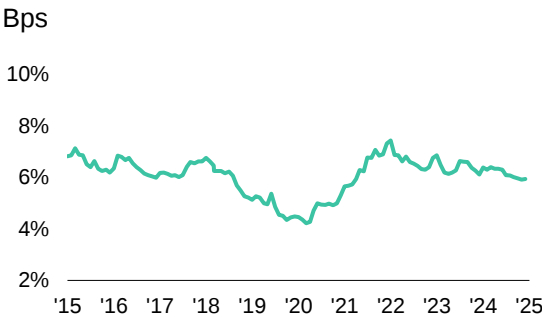

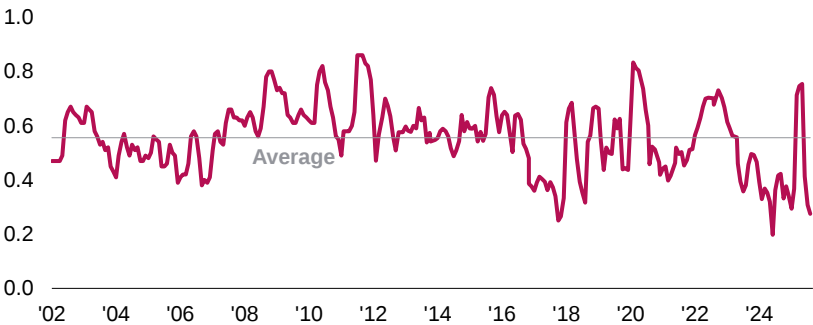

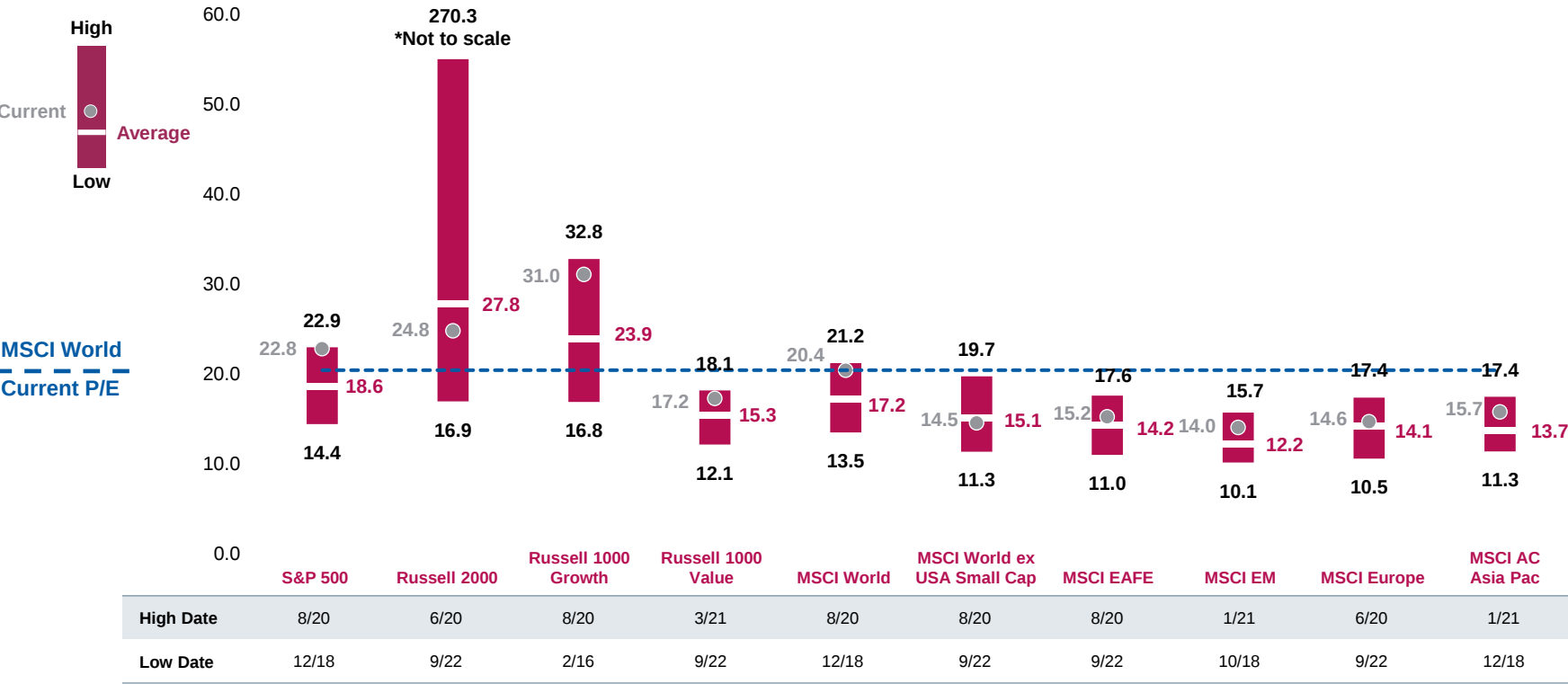

S&P 500 Sectors: Current NTM P/E vs. 10-Year High, Low, Average

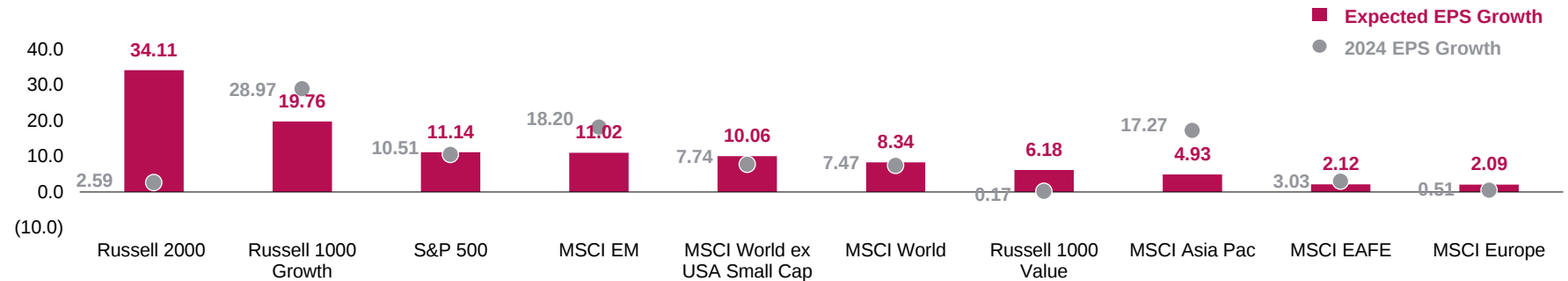

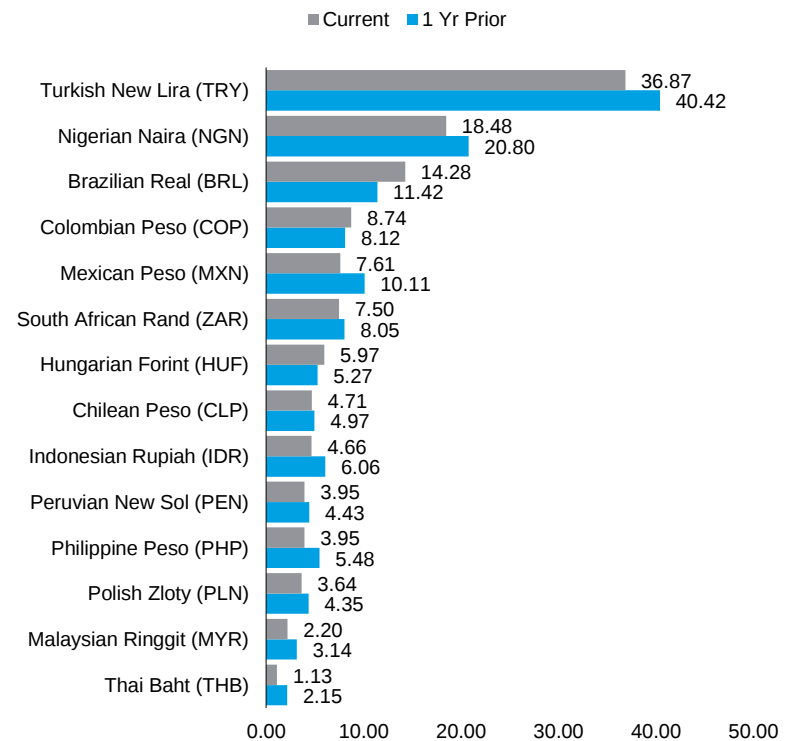
