## What is this product?

### Type

- This product is a class of share of the Sub-Fund and is denominated in USD. The Fund is an investment company with a variable capital and qualifies as an Undertaking for Collective Investment in Transferable Securities ("UCITS"), subject to the Luxembourg law of 17 December 2010 related to undertakings for collective investment (the "Investment Fund Law") transposing Directive 2009/65/EC as amended.
- As an investment fund, the return of the Sub-Fund depends on the performance of its underlying assets.

### Term

This product was incorporated for an undefined period. The manufacturer may not terminate it unilaterally. Only the board of directors of the Fund or a general meeting of shareholders may decide to terminate this product.

### Objectives

#### Investment objective:

- The investment objective of the Sub-Fund is to provide an attractive level of risk adjusted return, measured in USD, primarily through investing via a global portfolio of collective investment schemes, exchange traded funds, US government bonds, money market instruments, commodity-linked investments, and through financial derivative instruments. The Investment Manager will seek to manage risk using the total portfolio risk approach and within a target volatility range of 4% to 10%.
- The Sub-Fund invests in fixed income securities, equities and commodity-linked investments.

#### Investment policy:

- The Sub-Fund will invest in collective investment schemes and exchange traded funds across a spectrum of fixed income asset classes, including developed and emerging markets, emerging market sovereign debt, emerging market corporate debt, investment grade, non-investment grade, high yield, inflation-linked and unrated securities.
- Equity investment will be through collective investment schemes and exchange traded funds in developed and emerging markets worldwide which may include closed-end Real Estate Investment Trusts (REITs) and open-ended collective investment schemes. Investments can be made globally, including in emerging markets.
- The Sub-Fund may implement tactical views on commodities via exchange traded commodities (ETCs) which will not use embedded derivatives, and which qualify as 'transferable securities' and/or eligible commodity linked notes.
- The Sub-Fund may invest cash in high quality government bonds and/or invest in cash equivalents.
- The Sub-Fund may hold ancillary liquid assets (i.e., bank deposits at sight, such as cash held in current accounts with a bank accessible at any time) up to 20% of its net assets.

- The Sub-Fund may use derivative instruments for efficient portfolio management purposes, including hedging.
- The Sub-Fund may not invest in individual stocks or bonds, with exception of US government bonds.
- The Sub-Fund has an active investment strategy and is not managed in reference to a benchmark.
- Given the objectives and risk and reward profile of this product, the recommended holding period is five (5) years.

**Redemption and Dealing:** Investors may subscribe and redeem their shares on every full banking business day in Luxembourg.

**Distribution Policy:** Income generated by the Sub-Fund is reinvested and included in the value of shares.

### Intended Institutional Investor

This Sub-Fund may be appropriate for investors who:

- seek capital appreciation over the medium term;
- seek a balanced investment that focuses on those asset classes the Investment Manager finds tactically most attractive; and
- accept the risks associated with this type of investment, as set out in section "Risk Profile / Risk factors" of the prospectus and section "Risk Factors" in part A of the prospectus.

Investors should understand that they may not recover the amounts that they invest. Investors should read and understand the risk factors that are associated with an investment in the Sub-Fund, as explained in the "Risk Factors" section in the prospectus. Investors should consider their long-term investment goals and financial needs when making an investment decision about this Sub-Fund. The minimum investment is USD 1,000.

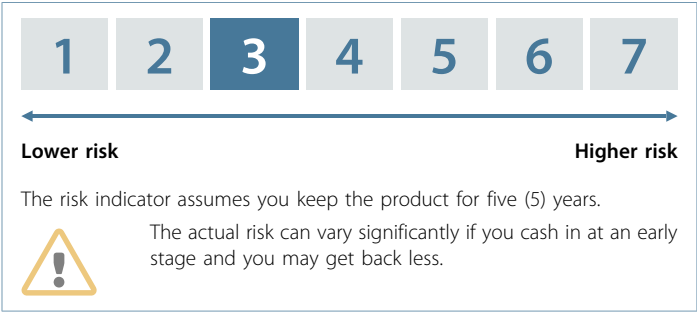

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate and favourable scenarios shown are illustrations using the worst, average and best performances of the product over the last ten (10) years, by identifying, depending on the performance scenarios and as defined in Regulation (EU) 2021/2268, all overlapping sub-intervals individually (i) equal in length to the recommended holding period which start or end in each month which are contained within that period of ten (10) years or (ii) equal or shorter in length to the recommended holding period, but equal to or longer than one (1) year, which end at the end of that period of ten (10) years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

**Unfavourable:** this type of scenario occurred for an investment between 31 October 2017 and 31 October 2022.

**Moderate:** this type of scenario occurred for an investment between 28 June 2019 and 28 June 2024.

**Favourable:** this type of scenario occurred for an investment between 29 January 2016 and 29 January 2021.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

**Be aware of currency risk.** You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

This rating does not take into account other risk factors which should be considered before investing, including credit, derivatives, emerging markets, liquidity and operational risks.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed

(i) in the first year you would get back the amount that you invested (0% annual return) and, for the other holding periods, the product performs as shown in the moderate scenario and (ii) \$ 10,000 is invested.

### How long should I hold it and can I take money out early?

#### Recommended holding period ("RHP"): 5 years

The RHP has been defined by taking into account the above investment objective and policy and the risk and the reward profile. You can redeem your investment without penalty incurred for disinvestment prior to the end of the recommended holding period, or hold the investment longer. Redemptions must be received by the registrar and transfer agent no later than 3pm CET to be dealt with on the basis of the net asset value per share applicable on that valuation date. Redemptions received by the registrar and transfer agent after that cut-off time will be dealt with on the next valuation date. Redemptions may be made in a number of shares. Redemption payments will be affected three (3) bank business days, which are also days when the relevant foreign exchange market is open, after the redemption of the shares. Any cashing-in before the end of the recommended holding period may have a negative consequence on your investment.
