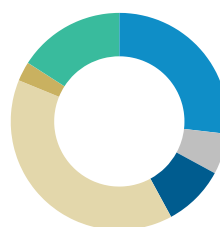

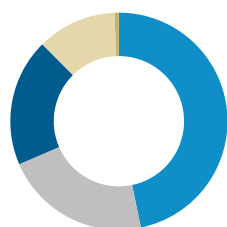

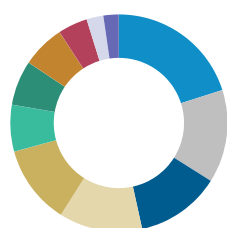

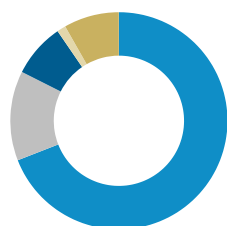

## Share Class C Risk and Reward Profile
