Dear shareholder,

We are writing to you as a holder of shares in Morgan Stanley Investment Funds Emerging Leaders Equity Fund, a fund of the Company (the "Fund").

The board of directors of the Company (the "Board") has decided to amend the investment policy of the Fund in order to align the exclusion policy of the Fund with the Screening Policy available on the Company's website which further excludes companies involved in the manufacturing or production of fossil fuels and gas.

In this context, the investment policy and the corresponding footnotes shall read as follows (new wording is in bold and the wording to be removed is struck through):

*"Investments shall not knowingly include any company involved in the manufacturing or production of:*

- *tobacco<sup>1</sup>;*
- *adult entertainment;*
- *civilian firearms;*
- *controversial weapons;*
- **fossil fuels<sup>2</sup>;**
- *coal<sup>3</sup>;*
- *oil sands<sup>4</sup>;*
- **Arctic oil and gas<sup>5</sup>; and**
- *gambling<sup>6</sup>. »*

These amendments will also be reflected in the SFDR disclosure annex dedicated to the Fund included in Appendix L of the Prospectus. This is a non-material change which will not affect the way in which the Fund is managed, its risk profile nor entail a rebalancing of its portfolio.

The above-mentioned change will be included in the version of the Prospectus dated November 2023. The full list of share classes impacted by this change is available in **Appendix 1**.
