Morgan Stanley to Close Global Opportunity Fund to New Investors With Limited Exceptions

The board of directors of the Company approved the closing of the Morgan Stanley Investment Funds (“MS INVF”) Global Opportunity Fund (the “Fund”) to new investors with limited exceptions as described below. The Fund will continue to offer shares to existing shareholders. On August 31, 2020, a notification was uploaded to www.morganstanleyinvestmentfunds.com announcing the soft closing of the Fund.

Effective December 31, 2020, the Fund will restrict new subscriptions into the Fund but allow additional subscriptions from the following:

- Investors purchasing shares through existing distributors and intermediaries (whether on a legal or beneficial basis);
- Clients who are significantly advanced in the due diligence process on this Fund as of the date of soft closure
- Clients of certain registered investment advisers who currently offer shares of the Fund in their asset allocation programs;
- Morgan Stanley affiliates and their employees; and
- Benefit plans sponsored by Morgan Stanley and its affiliates

The Effective Date of the suspension of new subscriptions for the Fund shall be December 31, 2020.

Except as described above, all your rights as an existing shareholder of the Fund are unaffected.

Please note that savings plan accounts (including new savings plan accounts) investing through platforms that trade omnibus by plan for shares as of December 31, 2020, fall under the exception for “existing distributors and intermediaries” set forth above.

Existing omnibus accounts (accounts offered on platforms that aggregate all underlying client-level transactions into one account) that are shareholders of record are considered one type of existing shareholder. Therefore, shares of the Fund will continue to be offered to underlying clients (including new clients) through such existing omnibus accounts.

After careful consideration, Morgan Stanley Investment Management believes that it is prudent to close the Fund to new investors to preserve the ability of the investment team to manage the Fund effectively for current shareholders. Closing the Fund to new investors will help ensure the investment team is well positioned to continue to deliver competitive performance to existing shareholders while staying true to its investment process, given the capacity-constrained nature of its concentrated portfolio.

Morgan Stanley Investment Management continues to evaluate its Fund offerings so the Fund may recommence offering shares to new investors in the future. Any such offerings of the Fund’s shares may be limited in amount and may commence and terminate without any prior notice.
