Asset backed commercial paper – Short-term debt that has a fixed maturity of up to 270 days and is backed by some financial asset, such as trade receivables, consumer debt receivables, or auto and equipment loans or leases. Floating Rate Note -  $\mbox{\sf A}$ debt instrument with a variable rate of interest that resets at specified intervals at a predetermined spread to an index or formula. Government Bonds - Bonds issued by the U.S. Government, typically regarded as the highest-grade securities issues with the least amount of default risk. ISIN is the international securities identification number (ISIN), a 12 digit code consisting of numbers and letters that distinctly identifies securities. Weighted average life (WAL) - measures the weighted average of the maturities of the portfolio's individual holdings. Weighted average maturity (WAM) – measures the weighted average of the maturities of the portfolio's individual holdings, taking into account reset dates for floating rate securities.
