You acknowledge and hereby consent that the Personal Data may also be stored on various systems hosted by entities appointed by Cachematrix Software Solutions LLC, under its own responsibility, to third party vendors such as Fortrust and Quality Technology Services which may be located in countries which are not deemed to offer an adequate level of protection such as the USA.

If you require trading rights, you will be asked to sign and return an Electronic Transactions Agreement (the "ETA"), which must be reviewed and agreed to by you prior to your being able to transact any business via the Liquidity Funds Website. Please retain a copy of the ETA for your records. The ETA is also available for your reference on the Treasury Investment Portal. Please note that the ETA is subject to amendment or termination in accordance with its provisions.
