# Global Endurance Portfolio

ACTIVE FUNDAMENTAL EQUITY | COUNTERPOINT GLOBAL | DECEMBER 31, 2019

Dear Clients:

Total returns for Global Endurance were +30.30% compared to +26.60% by the All Country World Index for the year.

Global Endurance seeks to invest in a select group of companies located throughout the world with durable competitive advantages, sustainable growth opportunities, valuable business models and strong management teams.

One such company was Carvana. Carvana is an e-commerce platform for buying and selling used cars online. The company provides a national inventory with over 21,000 cars and an in-house logistics network that facilitates the convenience of shopping online – open 24/7, home delivery, large selection and haggle-free pricing – while offering over \$1,000 savings per car over traditional dealers to its customers.

This strong consumer offering will, in my opinion, allow the company to continue to change the way people buy cars. Their simple and seamless car buying experience resonates with customers, as demonstrated by the extraordinary customer service rating of 4.7 (Carvana.com, September 30, 2019) out of 5 in an industry traditionally mistrusted and even dreaded by consumers. I believe we own a company which will continue to take share in a large market – estimated to be \$764 billion – while it maintains and builds upon its core competitive advantages of scale and network effects.

Our Carvana stake appreciated 181.41% in 2019. While Carvana was our top performer, Cardlytics, Constellation Software, Copart and HEICO Corporation were also important positive contributors to our results. Conversely, GTT Communications, Metro Bank, Blue Prism, Victoria and Wayfair were the biggest detractors to our performance this year.

It is worth noting that our companies' share prices can vary significantly in any short time period; but it is my belief that over time, they reflect the intrinsic value of their underlying businesses. And given that we own a select group of companies – 29 to be exact – a number which is a fraction of the over 3,000 companies held in the index we compete against, the fund's performance may vary in any given year.

I remain optimistic that a bottom-up approach to investing will allow us to find exceptional companies around the globe truly worthy of our capital in the years ahead. Furthermore, the companies we own today are perennially competing for space in the portfolio with ones we do not. I am committed to searching for exceptional companies, while also deepening my understanding of the fundamentals of our existing businesses.

At year-end, our top 10 companies accounted for 56.83% of the portfolio and top 20 companies accounted for 85.60% of the portfolio. From a geographic domicile weighting standpoint, our portfolio was 64.64% in United States, 10.77% in Canada, 9.35% in United Kingdom, 5.84% in New Zealand, 4.30% in Sweden, 2.96% in Germany and 1.06% in South Africa.

I am grateful for your trust in Global Endurance.
