### PRODUCT OVERVIEW

Since 1931, Capital Group's goal has been singularly focused on delivering superior, consistent results for long term investors using high conviction portfolios, rigorous research and individual accountability. The Capital Group Long Municipal SMA strategy seeks to provide current income exempt from regular federal income tax, consistent with maturity and quality standards, and to preserve capital. The Capital Group Long Municipal SMA strategy is managed in a separate account structure. The strategy invests in municipal bonds with quality ratings of BBB /Baa3 or better while maintaining a high level of liquidity. In the event of a downgrade by all rating organizations below the minimum rating requirement, the security will be sold as soon as practicable. Normally, the strategy has an overall duration range of +/- 1 year of the benchmark duration. The strategy will not investment in municipal securities that subject the investor to the alternative minimum tax (AMT). The strategy seeks to balance the assumed lower volatility of short term bonds with the higher potential income of long term municipal bonds. It offers a bridge between typically lower yielding, higher rated short term securities and higher yielding, lower rated longer term bonds.

## MANAGER'S INVESTMENT PROCESS

- Research and analysis: Fixed Income Research is produced and released internally daily. Sector and industry specific research (taxable and tax exempt).
- Equity and fixed income research collaboration: The Capital Group companies manage equity assets through three investment groups. These groups make investment and proxy voting decisions independently. Fixed income investment professionals provide fixed income research and investment management across the Capital organization; however, for securities with equity characteristics, they act solely on behalf of one of the three equity investment groups.
- Communication and idea generation: Ideas originate with analysts, traders or portfolio managers. Daily dialogue between portfolio managers and research analysts.
- Trading input: new and secondary supply, liquidity, relative valuation, execution. Daily research and weekly strategy meetings.
- Portfolio construction and risk management: Longer term themes for portfolio construction provided by Portfolio Strategy Group (PSG). Capital Group's Fixed Income Portfolio Strategy Group (PSG) is responsible for establishing and communicating broad, strategic parameters that guide fixed income portfolio construction. PSG's intention is to provide consistency and discipline in our fixed income portfolios, foster coordination and promote collaboration among our investment professionals in the pursuit of superior long-term investment results for our funds/strategies and investors while maintaining the creativity and flexibility of managers on the teams. PSG is a six-member team of seasoned investment professionals who both lead this effort and reach conclusions from the submitted research about optimal positioning for key portfolio parameters. Such parameters include duration, yield curve, sector allocation, volatility, inflation, and currency. Portfolio managers are given discretion (a range) around these parameters to accommodate tactical positioning.
- Portfolio managers size positions based on conviction, liquidity and portfolio objectives. Continuous assessment of relative value and daily opportunities.

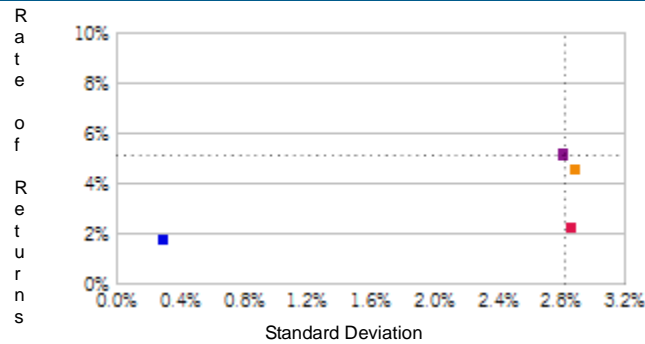

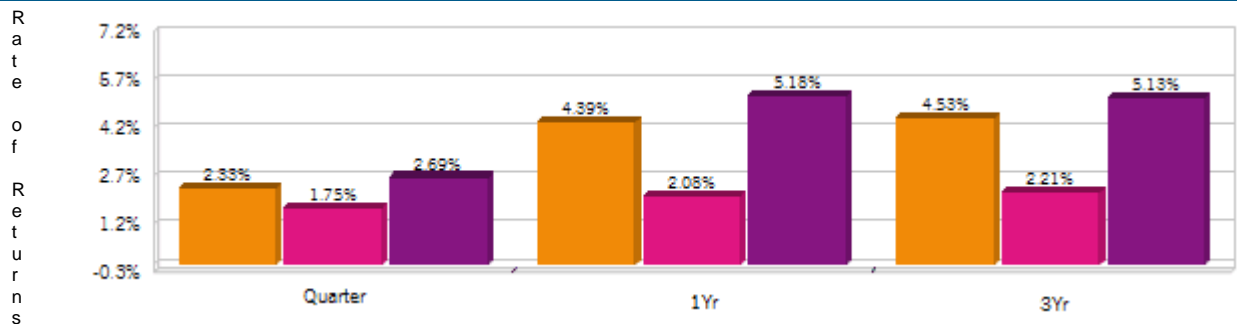

Analysts have primary responsibility for assessing company-specific and industry-specific investment risk, while portfolio managers have primary responsibility for considering systematic and macro risks to the overall portfolio. Our portfolio reporting and simulation systems allow for the active management of quantitative aspects of a portfolio strategy and simulation of risk-position changes. Our risk controls are designed to ensure that client guidelines and our internal risk limits are not breached and that appropriate processes are in place to help mitigate operational risk.

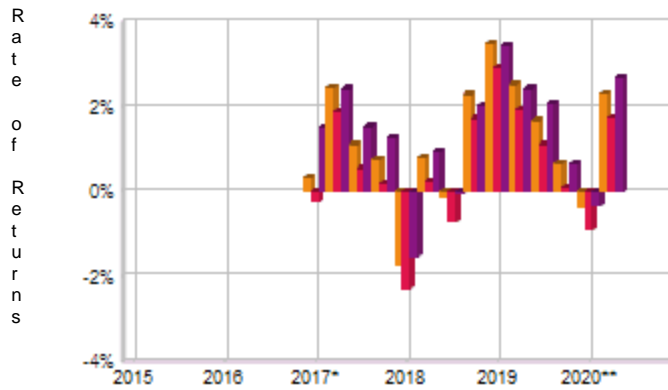
### AVERAGE ANNUAL TOTAL RETURN (%) - PERIODS ENDING 06/30/20

#### INDEX DESCRIPTIONS

##### 90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of discount is the interest earned. T-bills are issued in denominations of \$10,000 auction and \$1,000 increments thereafter.

##### BC Muni 15 Yr 12-17

The Barclays Municipal Bond Index is a rules-based, market-value-weighted index engineered for the long-term tax-exempt bond market. This index is the 15 Year (12-27) component of the Municipal Bond index.

##### S&P 500

The S&P 500 Total Return has been widely regarded as the best single gauge of the large cap U.S. equities market since the index was first published in 1957. The index has over \$5.58 trillion benchmarked, with index assets comprising approximately \$1.31 trillion of this total. ## GLOSSARY OF TERMS

**Alpha** is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

**American Depositary Receipts (ADRs)** are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

**Average Portfolio Beta** is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Beta** is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Bottom-Up Stock Selection** Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

**Capitalization** is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

**Distribution Rate** is defined as the most recent distribution paid, annualized, and then divided by the current market price. Distribution rate may consist of investment income, short-term capital gains, long-term capital gains, and /or returns of capital.

**Dividend** a portion of a company's profit paid to common and preferred shareholders.

**Dividend Yield** annual dividend per share divided by price per share. Dividend Yield for the portfolio is a weighted average of the results for the individual stocks in the portfolio.

**Downside Risk** is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

**Duration** is a measure of price sensitivity expressed in years.

**High Grade Corporate Bonds** corporate bonds from issuers with credit ratings of AA or AAA.

**Information Ratio** is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

**Investment Grade Bonds** are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

**Price/Book Ratio (P/B)** weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

**Price/Cash Flow Ratio** a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company' operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

**Price/Earnings Ratio (P/E Ratio)** shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

**Price/Sales Ratio** determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

**R2 (R-Squared)/Portfolio Diversification** indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

**Sharpe Ratio** measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

**Standard Deviation** is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

**Top-Down/Economic Analysis** Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

**Tracking Error** represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

**U.S. Treasury Bonds** a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

**Volatility** a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
