## PRODUCT OVERVIEW

The McDonnell core fixed income objective strives to provide total returns that compare to the Barclays Capital Government/Credit Index and seeks to achieve higher total returns than can be expected from a passive strategy (buying and holding). Portfolio holdings will primarily consist of representative securities from the U.S. Treasury, agency, and corporate sectors. McDonnell employs a conservative approach to actively managed fixed income portfolios. The investment team seeks to add value to the portfolios primarily through security and sector selection, followed by an attempt to exploit shift patterns in the yield curve. McDonnell does not attempt to "time" or "forecast" the direction of interest rate movements in order to add value. As a result, the portfolios' duration should not vary materially from the benchmark's duration.

## MANAGER'S INVESTMENT PROCESS

- In seeking these objectives, McDonnell employs a conservative approach to active municipal bond management.
- MIM claims a limited dependence on market timing. Duration is typically maintained at 90-105% of the benchmark duration.
- In order to add value, MIM attempts to identify what they believe are relative value opportunities among securities and sectors, as well as exploiting shift patterns of the yield curve.

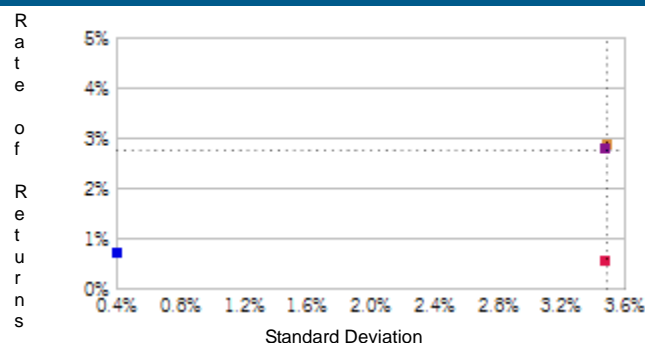

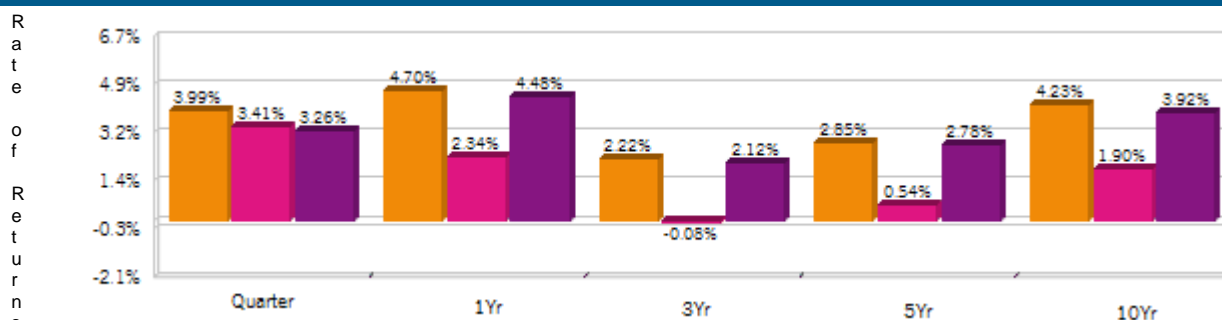

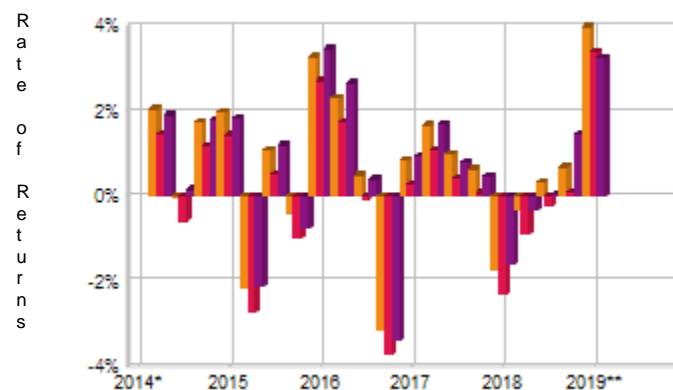
## AVERAGE ANNUAL TOTAL RETURN (%) - PERIODS ENDING 03/31/19

**Related Performance:**

The performance composite calculated by McDonnell Investment Management, LLC includes taxable and tax-exempt fixed income portfolios with target duration between 4 to 6 years and a minimum account size of \$5 million. For periods prior to November 1, 2001, accounts were included in the composite following the first full quarter of management. For subsequent periods, accounts are included following the first two full months of management. Client portfolios are not tax sensitive (i.e. do not invest in municipal bonds as a tax advantaged investment). These portfolios generally invest in U.S. domestic investment grade taxable fixed income securities. The composite performance results contained herein for periods prior to October 31, 2001 reflect performance achieved by our investment team while employed by the fixed income separate account business of Van Kampen Management Inc. (VKMI), which was acquired by McDonnell Investment Management, LLC on October 31, 2001. As a result of the acquisition, the investment team responsible for the performance of the accounts in the composite prior to October 31, 2001 became employees of McDonnell effective November 1, 2001 and currently is responsible for the management of all bond strategies for the same accounts at McDonnell. The investment team has used the identical investment discipline during the entire period of the performance results portrayed. Results were calculated in U.S. dollars on a monthly basis using a time-weighted methodology. Composites are asset weighted using beginning-of-month market values. Annual returns are derived from the geometric linking of monthly returns. Investment transactions are recorded on trade date. Investment income is included on an accrual basis. Cash and cash equivalents are included in account assets. Effective July 1, 2002, accounts with external cash flows greater than 20% are removed from the composite and returned in accordance with the new account inclusion guidelines. Bond Composite results do not reflect the actual performance for accounts in managed account programs; performance with respect to accounts in managed account programs may differ materially from the composite performance set forth herein. As noted, McDonnell's results reflect the performance of portfolios included in McDonnell's Gov't/Credit Bond Composite, which includes those client portfolios with minimum assets of \$5 million. McDonnell's composite performance is presented before the deduction of investment advisory fees and after the deduction of transaction costs.

**Morgan Stanley Performance:**

The composite consists of **65** account(s) with a market value of **\$62.6 million** as of **03/31/2019**. In this profile, the performance from January 1, 1999 through June 30, 2012 consists of accounts managed by the investment manager in this strategy in either the Morgan Stanley or the Smith Barney form of the Fiduciary Services program. From July 1, 2012 through December 31, 2015, performance consists of all Fiduciary Services (FS) accounts managed by the investment manager in this strategy, subject to any other limitations stated in this profile. From January 1, 2016, performance consists of the performance of all FS accounts (as described in the previous sentence) as well as the performance of all single style Select UMA accounts managed by the investment manager in this strategy, subject to any other limitations stated in this profile. #### INDEX DESCRIPTIONS

##### 90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of discount is the interest earned. T-bills are issued in denominations of \$10,000 auction and \$1,000 increments thereafter.

##### BC Gov/Cr

The Barclays Government/Credit Bond Index contains bonds that are investment grade and that have at least one year to maturity.



**S&P 500**

The S&P 500 Total Return has been widely regarded as the best single gauge of the large cap U.S. equities market since the index was first published in 1957. The index has over \$5.58 trillion benchmarked, with index assets comprising approximately \$1.31 trillion of this total. **GLOSSARY OF TERMS**

**Alpha** is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

**American Depositary Receipts (ADRs)** are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

**Average Portfolio Beta** is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Beta** is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Bottom-Up Stock Selection** Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

**Capitalization** is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

**Distribution Rate** is defined as the most recent distribution paid, annualized, and then divided by the current market price. Distribution rate may consist of investment income, short-term capital gains, long-term capital gains, and /or returns of capital.

**Dividend** a portion of a company's profit paid to common and preferred shareholders.

**Dividend Yield** annual dividend per share divided by price per share. Dividend Yield for the portfolio is a weighted average of the results for the individual stocks in the portfolio.

**Downside Risk** is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

**Duration** is a measure of price sensitivity expressed in years.

**High Grade Corporate Bonds** corporate bonds from issuers with credit ratings of AA or AAA.

**Information Ratio** is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

**Investment Grade Bonds** are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

**Price/Book Ratio (P/B)** weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

**Price/Cash Flow Ratio** a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company's operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

**Price/Earnings Ratio (P/E Ratio)** shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

**Price/Sales Ratio** determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

**R2 (R-Squared)/Portfolio Diversification** indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

**Sharpe Ratio** measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

**Standard Deviation** is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

**Top-Down/Economic Analysis** Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

**Tracking Error** represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

**U.S. Treasury Bonds** a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

**Volatility** a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
