### PRODUCT OVERVIEW

PIMCO focuses on generating tax-efficient income and capital preservation by investing in high quality municipal bonds that are exempt from federal, and in some cases state, taxes. Each of our Municipal Ladder Strategies uses our extensive credit research capabilities to identify investment-grade municipal bonds with various laddered maturities (1-12 years for the proposed product). Portfolio credit quality is managed to achieve an average credit rating of A+ or better (A- or better if the client elects a BBB allocation). Portfolios are not invested in municipal bonds subject to alternative minimum tax (AMT) at time of purchase. The strategy focuses on diversified investment selection across sectors and issuers, monitoring of credit quality, and institutional execution. In a normal market environment, the strategy seeks to buy and hold issues until maturity, but PIMCO has investment discretion in deciding whether to replace a bond prior to maturity. Factors under consideration will include, but not be limited to: an analysis as to whether, in PIMCO's opinion, the credit will continue to weaken resulting in downgrades, consideration of whether the present market value of the security or the liquidity of the market for the security has decreased to a level where selling the bond would unduly hurt the overall portfolio, and consideration of whether satisfactory steps have been taken to stabilize the credit.

**MANAGER'S INVESTMENT PROCESS**

- PIMCO Municipal Ladder Strategies are guided by our top-down global macroeconomic outlook. Rigorous bottom-up analysis drives the municipal bond selection process and facilitates the identification of undervalued securities.
- The firm aims to select bonds with high credit quality in the laddered portfolios and optimally structure maturities to enhance portfolios' return potential. PIMCO seeks to purchase municipal bonds that provide appropriate compensation for risks relating to structure, callability, credit quality, liquidity, tax liabilities and market supply-demand conditions.
- The portfolio is constructed with municipal bonds whose maturities are staggered over a specific period of time chosen specifically in an effort to add value. For example, the 1-12 year Ladders have the potential to benefit from reduced investor demand for maturities beyond 10 years.
- As a bond comes due, it is replaced with a new bond at the longest rung of the ladder. This approach seeks to generate a predictable income stream and may also provide an advantage in a rising rate environment since proceeds are reinvested at potentially higher rates.
- Credit research is an important component of the strategy's investment philosophy, as the Municipal Ladders emphasize high quality municipal securities. Although the laddered strategies are designed as buy and hold investments, PIMCO employs active credit selection and continues to monitor credits in the portfolios. PIMCO's credit research emphasizes a forward-looking view of the market and credit environment. Credit views are primarily the result of bottom-up analysis but are also influenced by the firm's macroeconomic outlook.

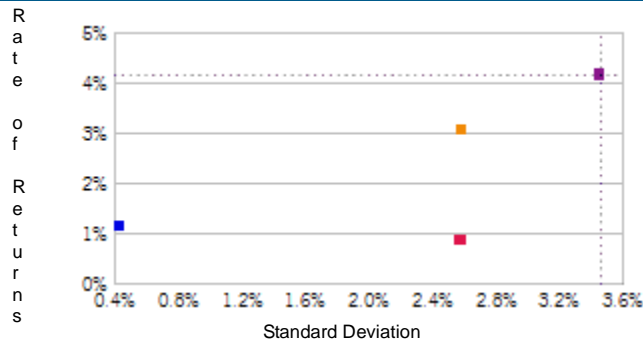

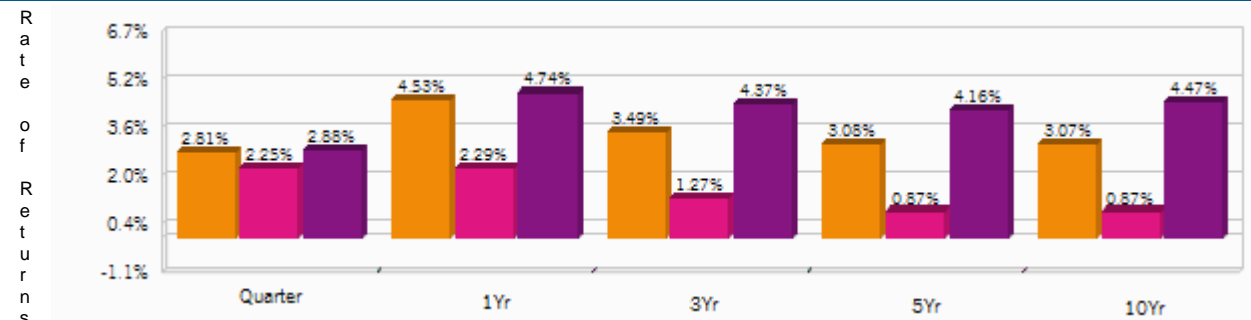

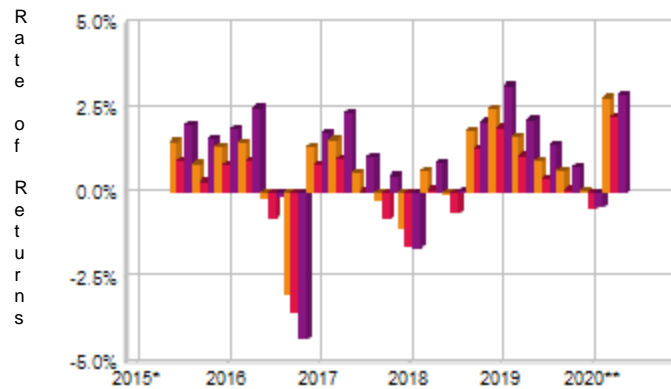
## AVERAGE ANNUAL TOTAL RETURN (%) - PERIODS ENDING 06/30/20

The PIMCO 1-12 Year National Municipal Bond Ladder Composite includes all discretionary, USD-based, 1-12 Year National Municipal Bond Ladder accounts without material state specific constraints that are managed through a wrap-fee program. The PIMCO Municipal Bond Ladder Strategy for Managed Accounts is a professionally managed by and hold strategy with a focus on investment selection and monitoring of credit ratings. Portfolios consist of municipal bonds exempt from Federal income taxes. The maximum maturity of any security at time of purchase is normally 12 years. The strategy will not invest in municipal bonds subject to the Alternative Minimum Tax. The composite creation date is April 2010. Valuations are computed and performance is reported in U.S. dollars. #### INDEX DESCRIPTIONS

##### 90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. T-bills are purchased at a discount to the full face value, and the investor receives the full value when they mature. The difference of discount is the interest earned. T-bills are issued in denominations of \$10,000 auction and \$1,000 increments thereafter.

##### BC Muni 10 Yr

The Barclays Municipal Bond Index is a rules-based, market-value-weighted index engineered for the long-term tax-exempt bond market. This index is the 10 Year (8-12) component of the Municipal Bond index.

##### S&P 500

The S&P 500 Total Return has been widely regarded as the best single gauge of the large cap U.S. equities market since the index was first published in 1957. The index has over \$5.58 trillion benchmarked, with index assets comprising approximately \$1.31 trillion of this total. The index includes 500 leading companies in leading industries of the U.S. economy, capturing 75% coverage of U.S. equities. This index includes dividend reinvestment.

## GLOSSARY OF TERMS

**Alpha** is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

**American Depositary Receipts (ADRs)** are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

**Average Portfolio Beta** is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Beta** is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Bottom-Up Stock Selection** Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

**Capitalization** is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

**Distribution Rate** is defined as the most recent distribution paid, annualized, and then divided by the current market price. Distribution rate may consist of investment income, short-term capital gains, long-term capital gains, and /or returns of capital.

**Dividend** a portion of a company's profit paid to common and preferred shareholders.

**Dividend Yield** annual dividend per share divided by price per share. Dividend Yield for the portfolio is a weighted average of the results for the individual stocks in the portfolio.

**Downside Risk** is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

**Duration** is a measure of price sensitivity expressed in years.

**High Grade Corporate Bonds** corporate bonds from issuers with credit ratings of AA or AAA.

**Information Ratio** is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

**Investment Grade Bonds** are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

**Price/Book Ratio (P/B)** weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

**Price/Cash Flow Ratio** a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company's operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

**Price/Earnings Ratio (P/E Ratio)** shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

**Price/Sales Ratio** determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

**R2 (R-Squared)/Portfolio Diversification** indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

**Sharpe Ratio** measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

**Standard Deviation** is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

**Top-Down/Economic Analysis** Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

**Tracking Error** represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

**U.S. Treasury Bonds** a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

**Volatility** a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
