### PRODUCT OVERVIEW

Todd Asset Management believes Price/ Intrinsic Value (P/IV) is the most effective fundamental calculation to determine the true valuation of a stock. P/IV is used with a proprietary multi-factor ranking model to combine Valuation, Fundamental and Market Recognition factors into a composite score which allows stock prospects to be compared, regardless of sector or geography. TAM's portfolio managers believe this comprehensive, disciplined process, combined with risk controls, should result in a portfolio that consistently outperforms the ACWI ex-US over full market cycles. The International Intrinsic Value strategy is unique in that it is based on a 30 year old philosophy and managed by a team of portfolio managers averaging more than 30 years of industry experience. An effective review and sell discipline based on valuation and fundamentals is in place to limit risks inherent in stock selection, and diversification requirements are also maintained. Emerging Markets and Canada can represent +/- 10% of the ACWI ex-US weightings and the portfolio is limited to +/- 10% of the MSCI ACWI ex-US sector and region weightings. There are no derivative strategies used. The strategy is bottom-up and holds 65-85 positions primarily large cap stocks, balanced across regions and industry sectors.

## MANAGER'S INVESTMENT PROCESS

- Screening starts with a universe of 3,200 international stocks which is narrowed to about 800 that are traded in the US, have a market cap >\$1 billion and a TAM minimum quality rating of B-
- A universe of attractively priced stocks is identified using a P/IV calculation—generally the least expensive third— and then scored according to our proprietary multi-factor ranking model. The model combines Valuation, Fundamentals, and Market Recognition into a single composite score allowing the stocks' prospects to be compared, regardless of sector or geography.
- The portfolio managers validate all inputs to ensure scores are accurate. They examine normal earnings against a company's cyclicality, and long-term growth rates against competitors and sustainable IRR growth rates. They confirm internal quality ratings illustrate the risk/reward premium needed for our valuation calculation, and evaluate the company's outlook to assure a rationale for inclusion. Lastly, they confirm whether the stock is being accumulated or distributed.
- The portfolio is compiled using the most attractive stocks offering the largest potential upside, quality, and diversification, according to our process. Risk is managed by the rules and processes used to develop the portfolio. About 65% of portfolio risk is controlled through diversification and sector decision rules; 35% is controlled by P/IV.
- Sell discipline: When a stock trades at 1.3x its intrinsic value, the fundamentals of a company/industry are perceived to have weakened or our multi-factor ranking falls below the midpoint, we do further fundamental research to see if the stock needs to be reduced or eliminated. A stock is a mandatory sale when its price trades at 1.5x, or if a structural negative or accounting integrity issue develops.

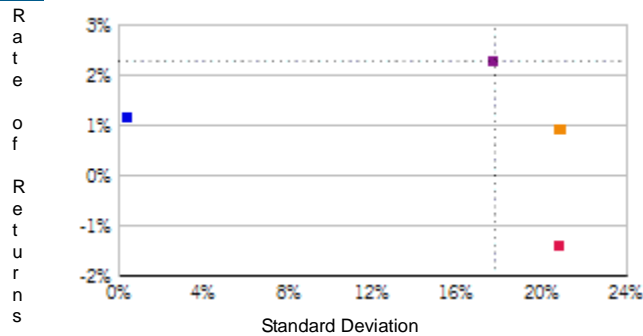

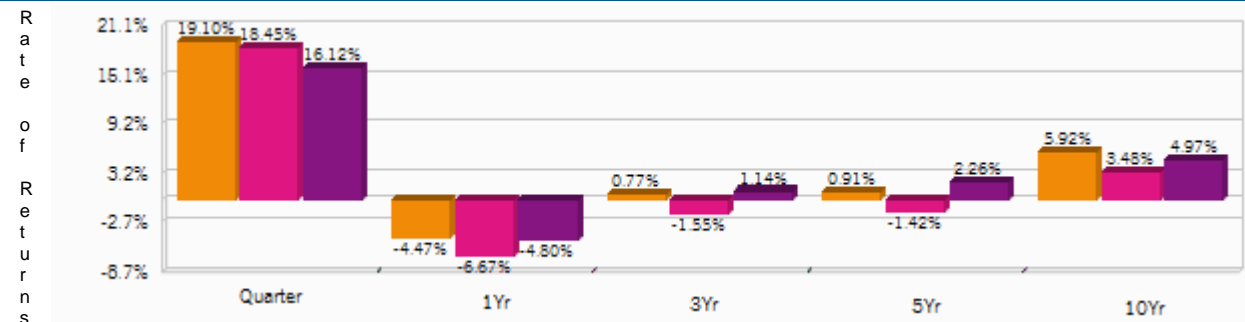

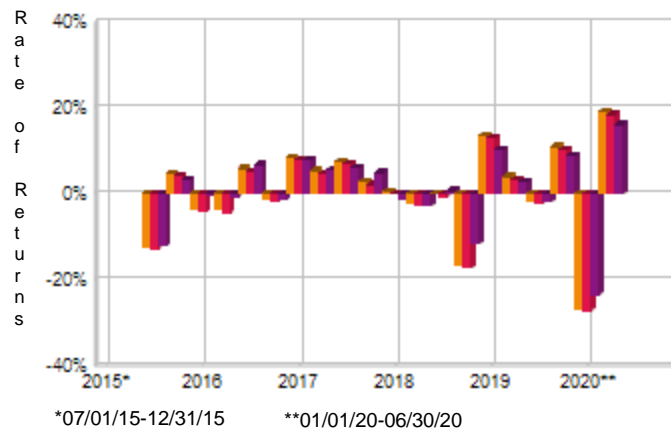
## AVERAGE ANNUAL TOTAL RETURN (%) - PERIODS ENDING 06/30/20

#### INDEX DESCRIPTIONS

##### 90-Day T-Bills

The 90-Day Treasury Bill is a short-term obligation issued by the United States government. **GLOSSARY OF TERMS**

**Alpha** is a mathematical estimate of risk-adjusted return expected from a portfolio above and beyond the benchmark return at any point in time.

**American Depositary Receipts (ADRs)** are receipts for shares of a foreign-based corporation held in the vault of a U.S. bank.

**Average Portfolio Beta** is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Beta** is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

**Bottom-Up Stock Selection** Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

**Capitalization** is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

**Distribution Rate** is defined as the most recent distribution paid, annualized, and then divided by the current market price. Distribution rate may consist of investment income, short-term capital gains, long-term capital gains, and /or returns of capital.

**Dividend** a portion of a company's profit paid to common and preferred shareholders.

**Dividend Yield** annual dividend per share divided by price per share. Dividend Yield for the portfolio is a weighted average of the results for the individual stocks in the portfolio.

**Downside Risk** is a measure of the risk associated with achieving a specific target return. This statistic separates portfolio volatility into downside risk and upside uncertainty. The downside considers all returns below the target return, while the upside considers all returns equal to or above the target return.

**Duration** is a measure of price sensitivity expressed in years.

**High Grade Corporate Bonds** corporate bonds from issuers with credit ratings of AA or AAA.

**Information Ratio** is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

**Investment Grade Bonds** are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

**Price/Book Ratio (P/B)** weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

**Price/Cash Flow Ratio** a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company' operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

**Price/Earnings Ratio (P/E Ratio)** shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

**Price/Sales Ratio** determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

**R2 (R-Squared)/Portfolio Diversification** indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

**Sharpe Ratio** measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

**Standard Deviation** is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

**Top-Down/Economic Analysis** Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

**Tracking Error** represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

**U.S. Treasury Bonds** a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

**Volatility** a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
