PRODUCT OVERVIEW

The cornerstone of WestEnd Advisors investment philosophy is that the macroeconomic environment is a key driver of financial market returns. WestEnd Advisors conducts in-depth analysis of the global macroeconomic environment and allocates client portfolios to areas of the U.S. equity markets, international equity markets, and U.S. fixed income markets that we believe will benefit from economic tailwinds. Out-of-favor areas facing economic headwinds are underweighted or avoided. WestEnd invests in diversified, major-market Exchange Traded Funds (ETFs) in the Global Balanced strategy to express our outlook. We believe that these ETFs are the optimal investment vehicles to capitalize on market views because their performance is driven by broad macroeconomic trends. WestEnd's Investment Team has actively managed ETF-only portfolios since 2005. WestEnd collects and rigorously analyzes over 200 domestic and international data points using a time-tested, qualitative process. Our years of experience studying economic trends gives us the ability to determine which data is most important in the current economic environment. Performing in-depth macroeconomic research, however, is not enough. Many economists and investors analyze economic data, but what differentiates WestEnd is our ability to translate economic research into actionable investment decisions for clients. The Global Balanced strategy is invested in areas of the markets that we believe will perform well based upon our economic outlook.

MANAGER'S INVESTMENT PROCESS

- Overweights or underweights equity vs. fixed income based on the Investment Team's economic and market outlook.
- Overweights or underweights U.S. vs. international equity markets, as well as developed vs. emerging markets for the strategy's international equity allocation.
- Overweights or underweights S&P 500 sectors for the large-cap U.S. portion of the equity allocation, and also overweights or underweights broad U.S. small/mid-cap exposure for the U.S. equity allocation.
- Assesses the attractiveness of different types of fixed income based on WestEnd's interest rate outlook and an evaluation of monetary policy, demand for money and inflation trends to determine the appropriate duration and credit quality of the fixed income portion of the Global Balanced portfolio.
- Selects ETFs from leading U.S. providers to invest in favored segments of U.S. fixed income and global equity markets. WestEnd typically invests in eight to fifteen ETFs at any one time in the Global Balanced portfolio, including four to five sector ETFs, but may be invested in more or fewer sectors as conditions warrant. The result is a low-turnover portfolio of eight to fifteen ETFs that WestEnd believes will deliver superior returns given the firm's macroeconomic outlook

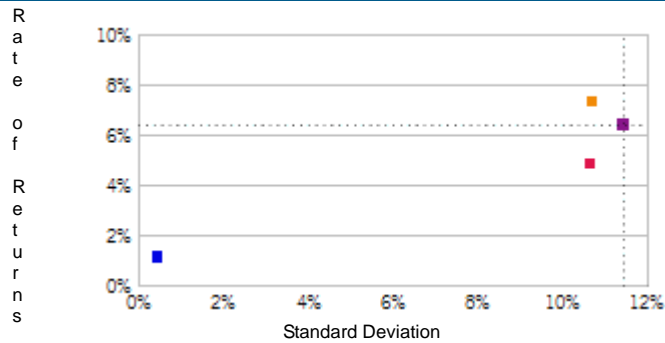

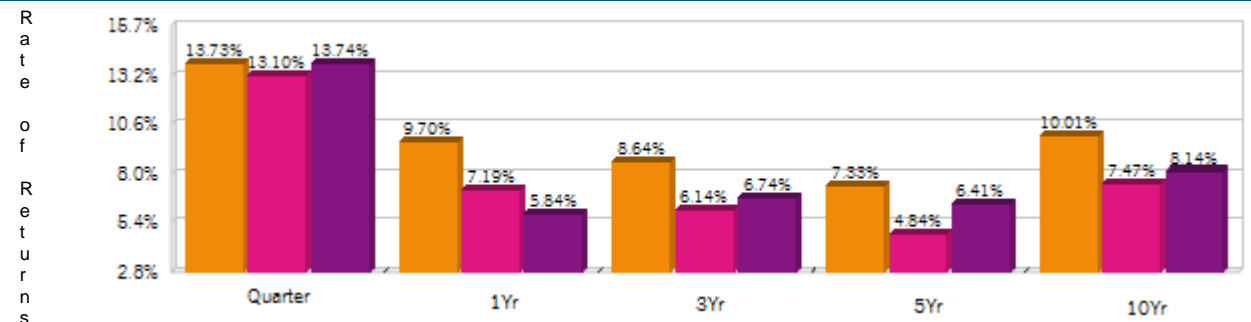

RISK/RETURN ANALYSIS - 5 YEARS ENDING 06/30/20



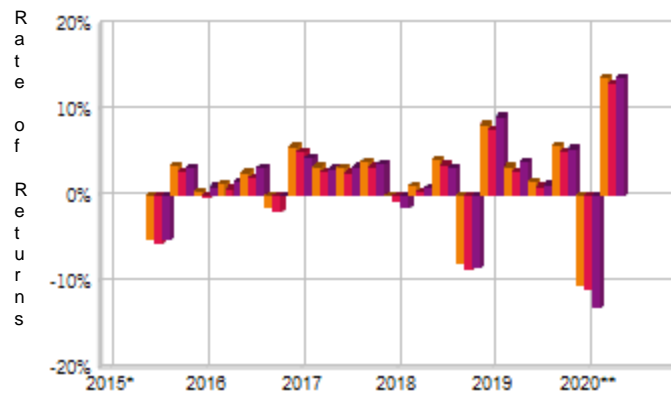

WestEnd Advisors' Global Balanced Composite includes all discretionary accounts invested in the Global Balanced model except for portfolios managed by WestEnd Advisors in a wrap-fee program. The Global Balanced Composite creation date is December 31, 2004, and the investment strategy for the Global Balanced Composite has been consistent since creation. WestEnd Advisors' Global Balanced Composite is invested in large-, mid-, and small-cap U.S. equities, international equities, U.S. fixed-income, and other assets, all through the use of exchange-traded funds, and/or high-grade money market instruments. Returns are achieved without the use of options, derivatives, or leverage of any kind. Results are calculated daily using the aggregate method, use trade date valuations, and include cash as well as the reinvestment of dividends, interest income and other earnings if applicable. Portfolio returns are weighted using beginning of period values plus weighted cash flows. Portfolios and composites are valued daily and are denominated in U.S. dollars only.

GLOSSARY OF TERMS

Average Portfolio Beta is a measure of the sensitivity of a benchmark or portfolio's rates of return to changes against a market return. The market return is the S&P 500 Index. It is the coefficient measuring a stock or a portfolio's relative volatility.

Beta is a measure of the sensitivity of a portfolio's rates of return to changes in the market return. It is the coefficient measuring a stock or a portfolio's relative volatility.

Bottom-Up Stock Selection Emphasis primarily on individual stock selection. Considerations of economic and industry factors are of secondary importance in the investment decision-making process.

Capitalization is defined as the following: Mega (Above \$100 billion), Large (\$12 to \$100 billion), Medium (\$2.5 - \$12 billion), Small (\$.50 - \$2.5 billion) and Micro (below \$.50 billion).

Distribution Rate is defined as the most recent distribution paid, annualized, and then divided by the current market price. Distribution rate may consist of investment income, short-term capital gains, long-term capital gains, and /or returns of capital.

Information Ratio is a measure of the investment manager's skill to add active value against a given benchmark relative to how stable that active return has been. Essentially, the information ratio explains how significant a manager's alpha is. Therefore, the higher the information ratio, the more significant the alpha.

Investment Grade Bonds are those rated by Standard & Poor's AAA (highest rated), AA, A or BBB (or equivalent rating by other rating agencies or, in the case of securities not rated, by the investment manager).

Price/Book Ratio (P/B) weighted average of the stocks' price divided by book value per share. Book value per share is defined as common equity, including intangibles, divided by shares outstanding times the adjustment factor.

Price/Cash Flow Ratio a ratio used to compare a company's market value to its cash flow. It is calculated by dividing the company's market cap by the company's operating cash flow in the most recent fiscal year (or the most recent four fiscal quarters); or, equivalently, divide the per-share stock price by the per-share operating cash flow.

Price/Earnings Ratio (P/E Ratio) shows the multiple of earnings at which a stock sells. Determined by dividing current stock price by current earnings per share (adjusted for stock splits). Earnings per share for the P/E ratio are determined by dividing earnings for past 12 months by the number of common shares outstanding. The P/E ratio shown here is calculated by the harmonic mean.

Price/Sales Ratio determined by dividing current stock price by revenue per share (adjusted for stock splits). Revenue per share for the P/S ratio is determined by dividing revenue for past 12 months by number of shares outstanding.

R2 (R-Squared)/Portfolio Diversification indicates the proportion of a security's total variance that is benchmark-related or is explained by variations in the benchmark.

Sharpe Ratio measures the efficiency, or excess return per unit of volatility, of a manager's returns. It evaluates managers' performance on a volatility-adjusted basis.

Standard Deviation is a statistical measure of historical variability or spread of returns around a mathematical average return that was produced by the investment manager over a given measurement period. The higher the standard deviation, the greater the variability in the investment manager's returns relative to its average return.

Top-Down/Economic Analysis Emphasis primarily on macroeconomic trends as opposed to bottom-up stock selection.

Tracking Error represents the standard deviation of the difference between the performance of the investment strategy and the benchmark. This provides a historical measure of the variability of the investment strategy's returns relative to its benchmark.

U.S. Treasury Bonds a marketable, fixed interest U.S. government debt security with a maturity of more than 10 years. Treasury bonds make interest payments semi-annually and the income that holders receive is only taxed at the federal level.

Volatility a measure of risk based on the standard deviation of the asset return. Volatility is a variable that appears in option pricing formulas, where it denotes the volatility of the underlying asset return from now to the expiration of the option. There are volatility indexes. Such as a scale of 1-9; a higher rating means higher risk.
